
Q1 Switching Time Test Circuit

(a) Test Circuit








Q2 Switching Time Test Circuit

Then, for normal switching operation, $V_{GS(on)}$ must be higher than V_{th} , and $V_{GS(off)}$ must be lower than V_{th.} This relationship can be expressed as: V_{GS(off)} < V_{th} < V_{GS(on)}.
