Typical Impedance Characteristics:

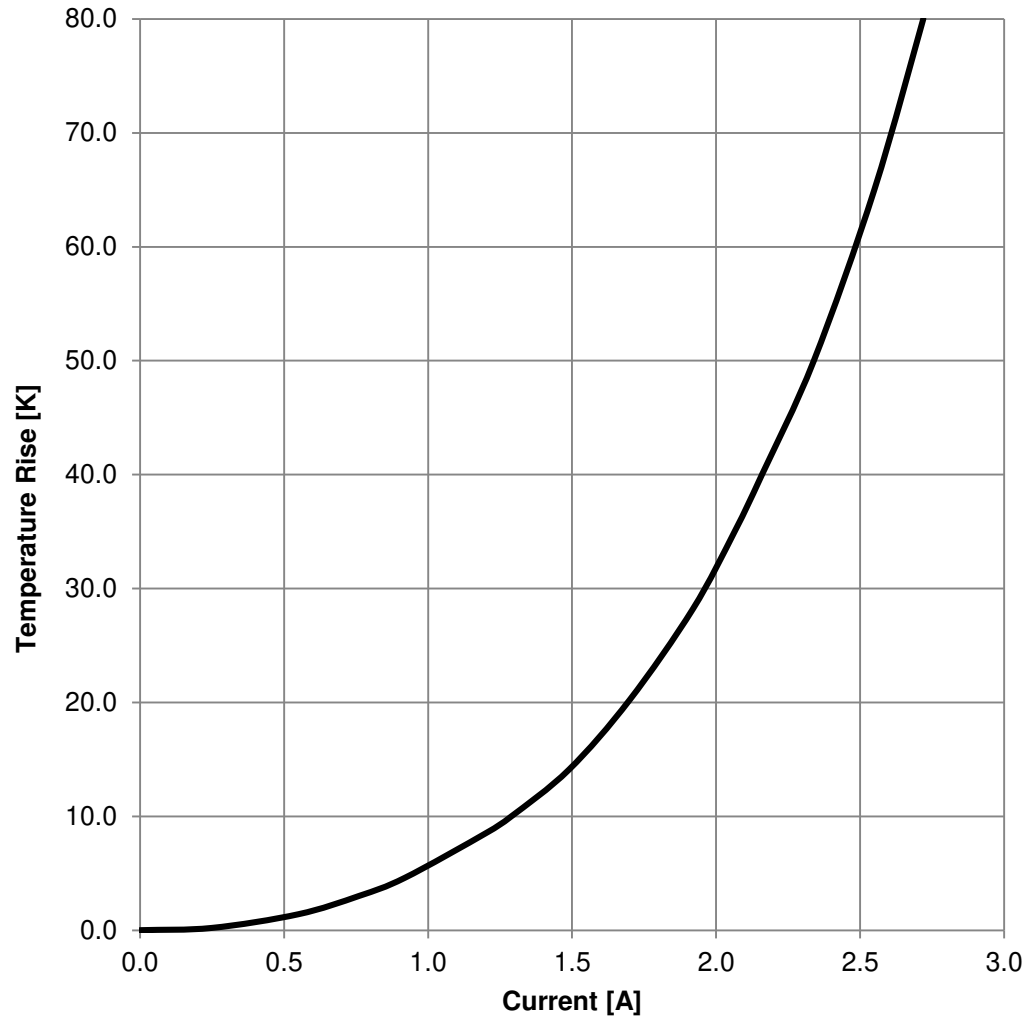








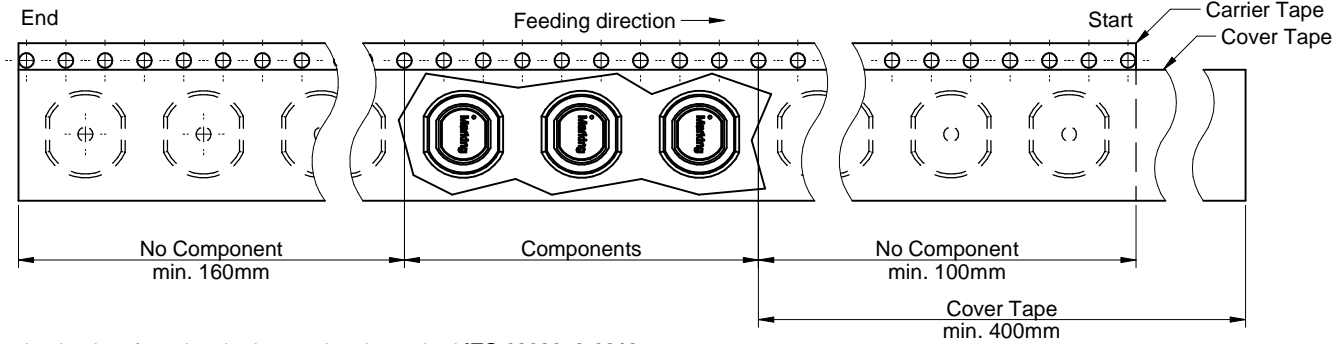
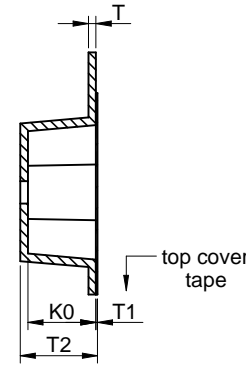
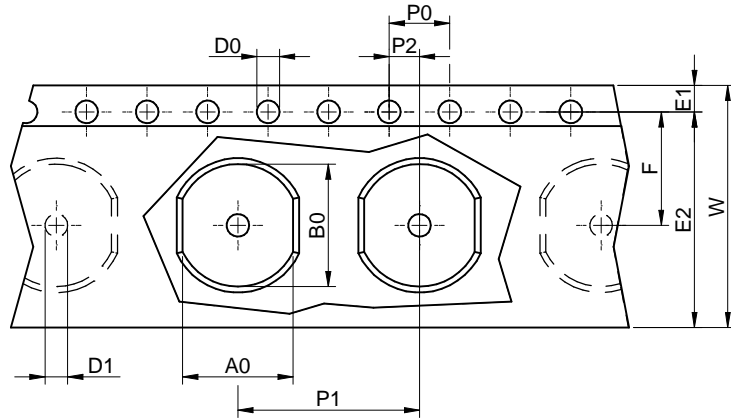
Typical Temperature Rise vs. Current Characteristics:

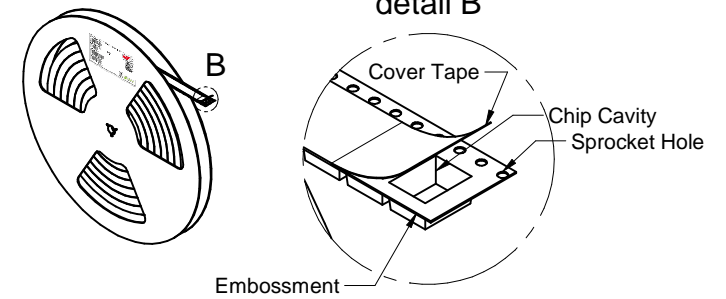
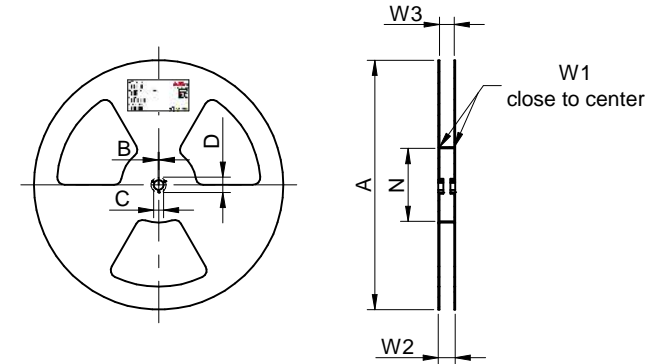

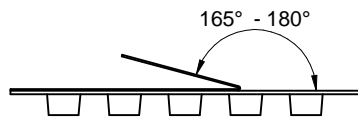

Soldering



Packaging:


