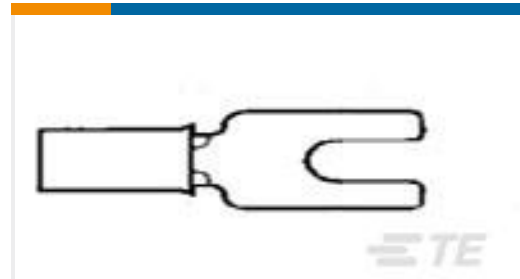
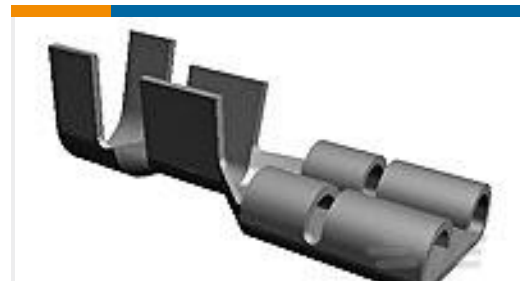
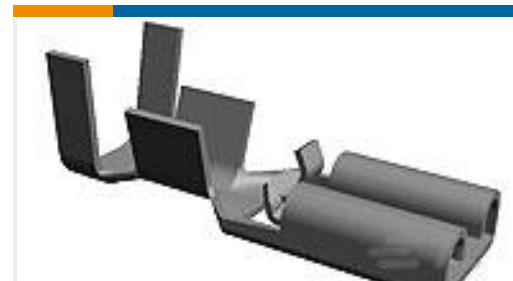


Rectangular Connector Locking(2)
