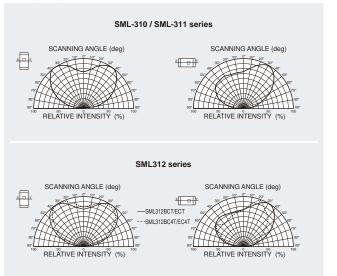

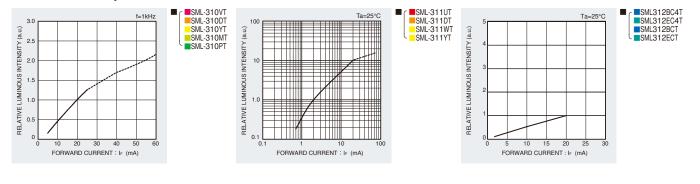
#### **Electrical Characteristics Curves**



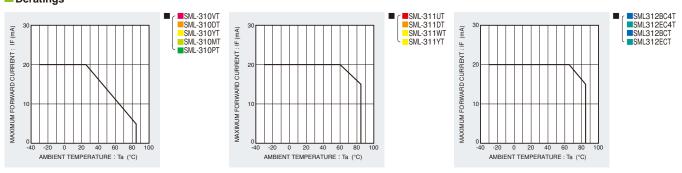
Luminous Intensity-Atmosphere Temperature

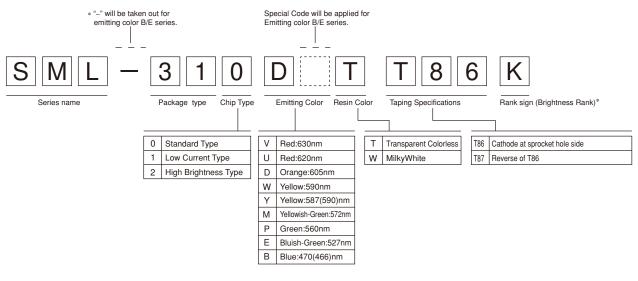
