




FIG.1 FORWARD CURRENT DERATING CURVE




FIG.2 TYPICAL FORWARD CHARACTERISTICS




FIG.3 TYPICAL JUNCTION CAPACITANCE




FIG.4 MAX OVERLADE SURGE CURRENT




Fig.5-TYPICAL REVERSE CHARACTERISTIC
