









Figure 8. Normalized On-State Resistance vs Temperature








Figure 10. Maximum Safe Operating Area






Figure 12. Maximum Drain Current vs Temperature






7.2 Q3A Recommended PCB Pattern




1. Laser cutting apertures with trapezoidal walls and rounded corners may offer better paste release. IPC-7525 may have alternate design recommendations.
