





Characteristic Curves













NORMALIZED TRANSIENT THERMAL IMPEDANCE FROM JUNCTION TO CASE (PER DEVICE)





oscilloscope

- 1 Set up ESD Tester at IEC61000-4-2 condition. (IEC61000-4-2 : C=150pF, R=330 Ω)
- 2 Mount a sample on the high frequency test board with the SMA connector.
- 3 Connect the SMA connector to the oscilloscope by 50Ω cable.


Then, add the 10X-attenuator between test board and the cable to protect the oscilloscope.



⁴ Discharge ESD in contact discharge mode at any voltage. (normally 8kV Max.)


