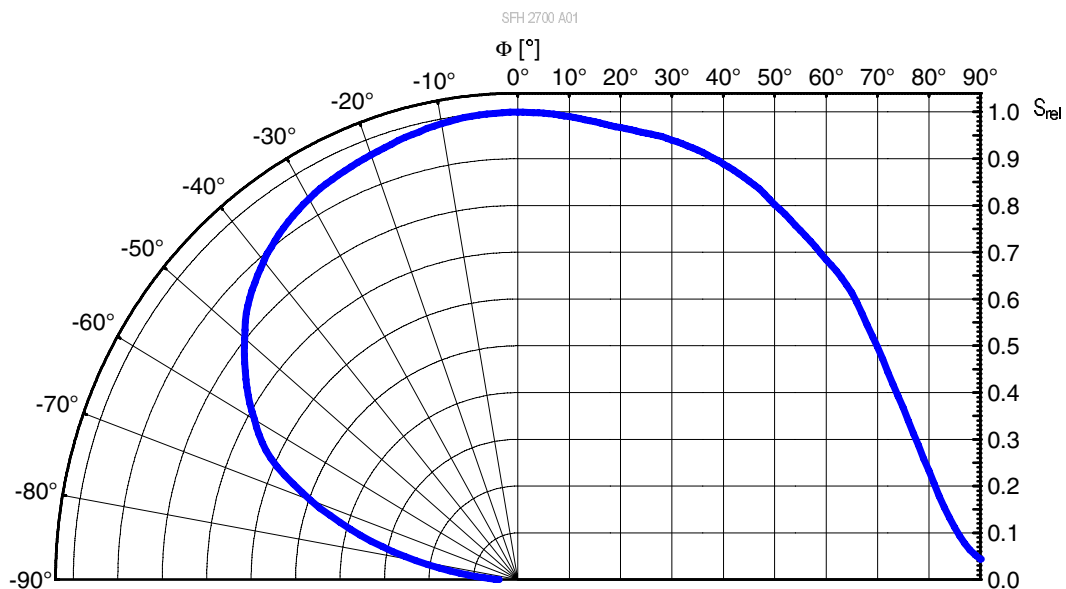

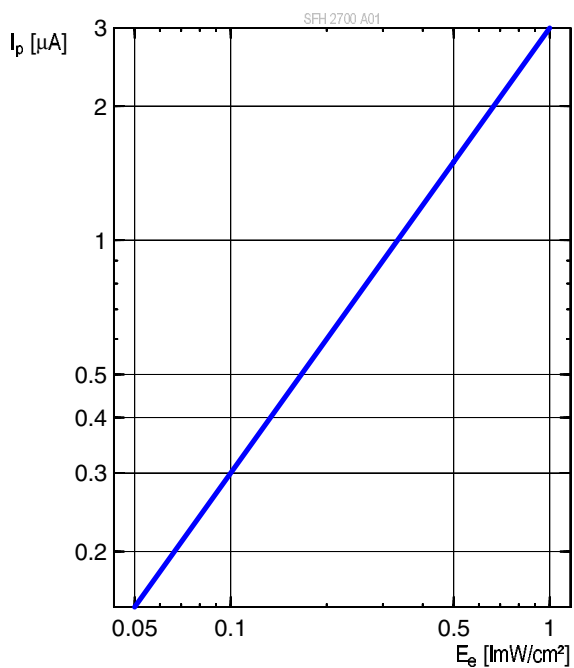

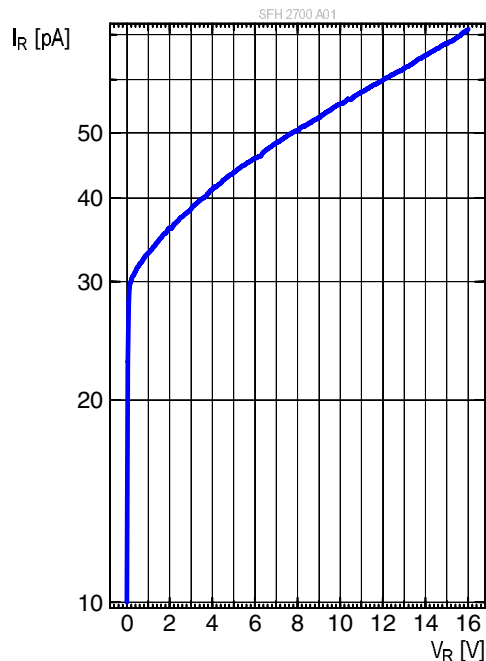

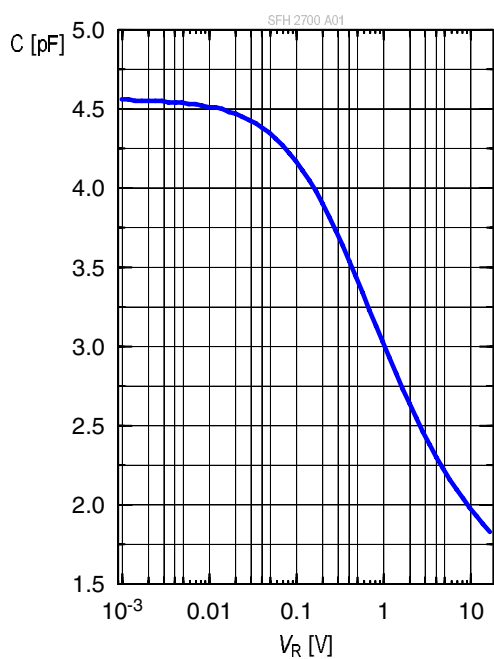

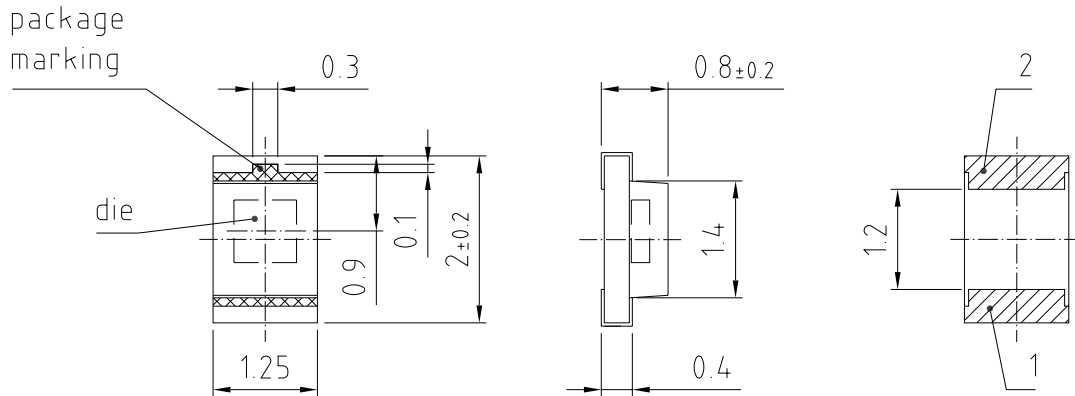

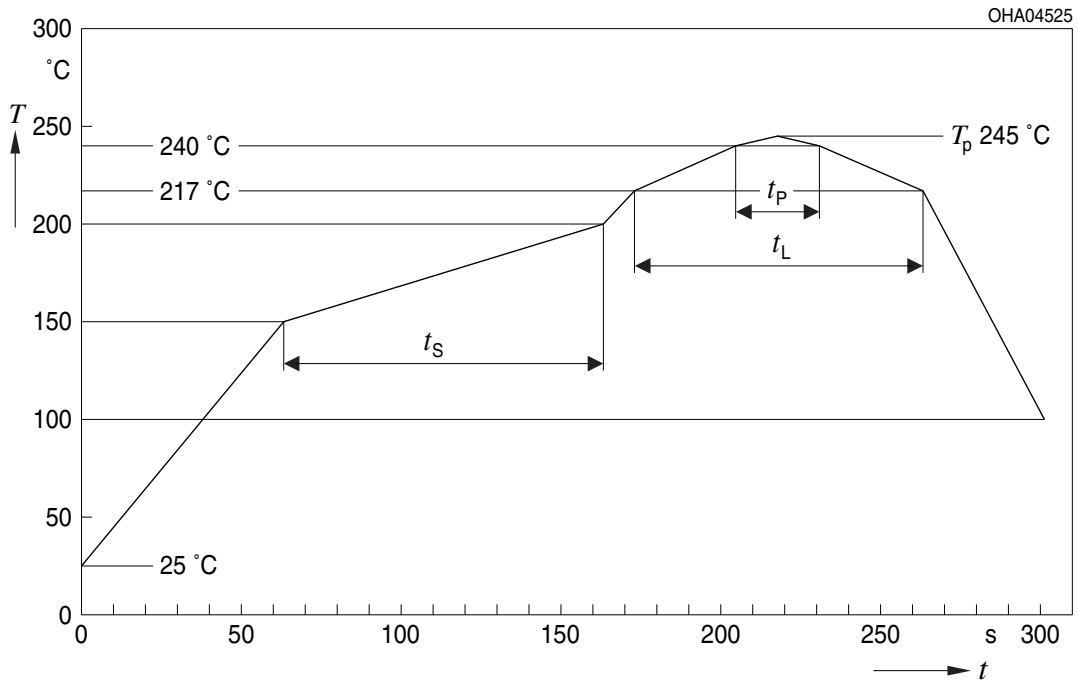

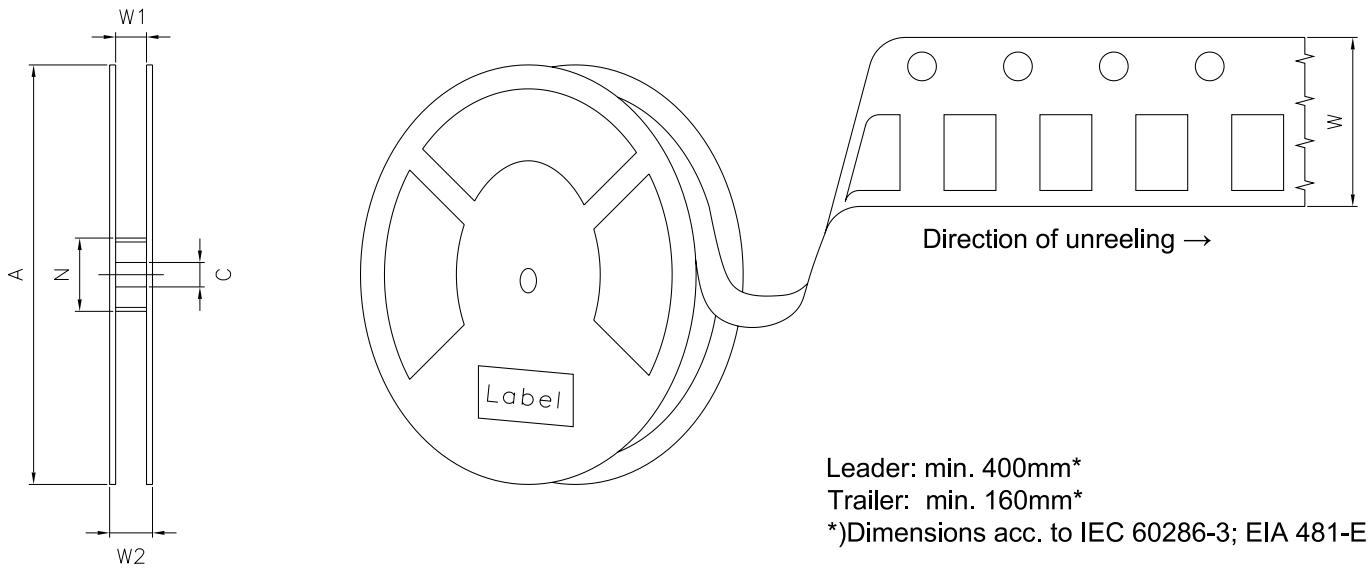



Notes
