Typical Impedance Characteristics:

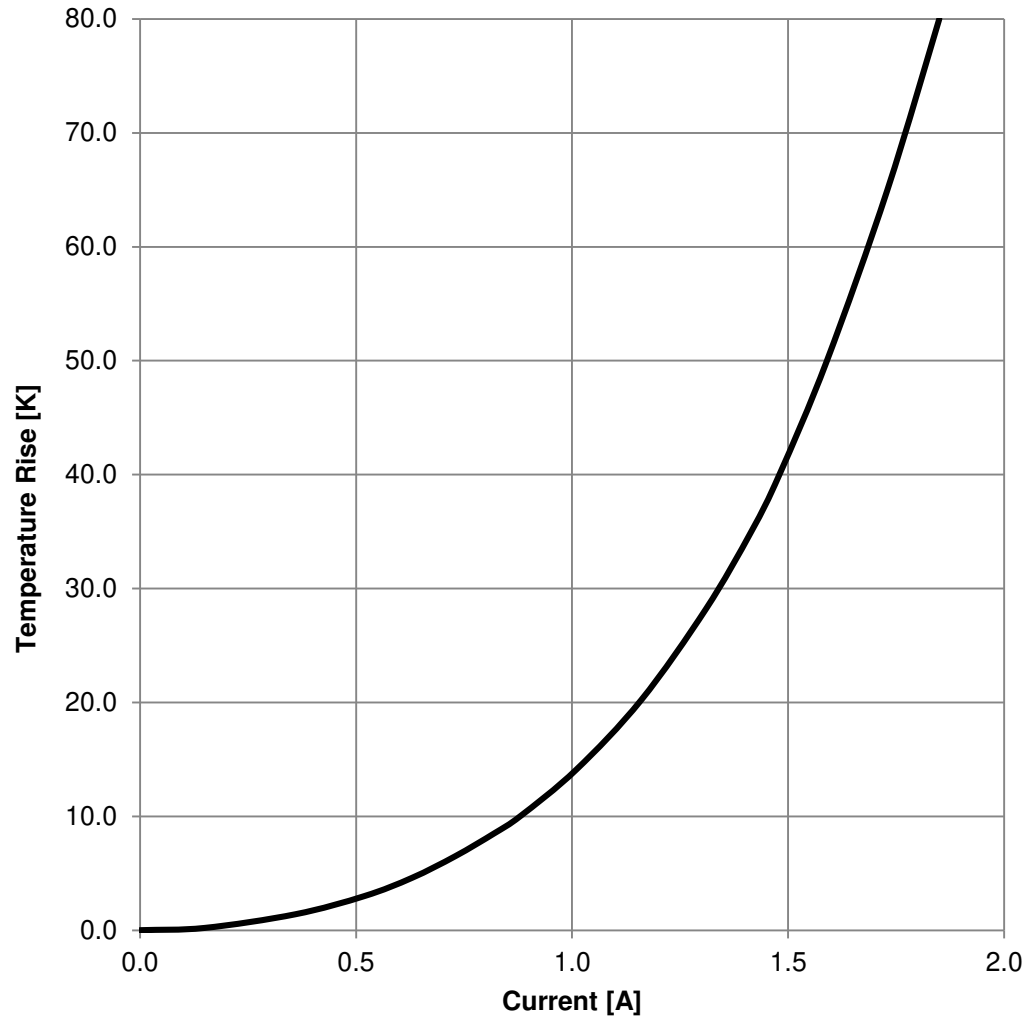








Soldering



Packaging:


