
## **Total Power Dissipation vs. Ambient Temperature:**






### **Relative CTR vs. Ambient Temperature:**





#### **Collector-Emitter Saturation Voltage vs. Ambient Temperature:**







## Absolute CTR vs. Forward Current ( at $V_{CE}=5 V$ )




## Relative CTR vs. Forward Current ( at $V_{CF}=5 V$ )





## Absolute CTR vs. Forward Current ( at $V_{CE}=0.4 V$ )




## Relative CTR vs. Forward Current ( at V<sub>CF</sub>=0,4 V )




