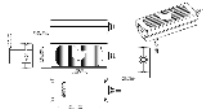

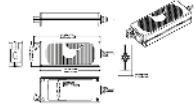

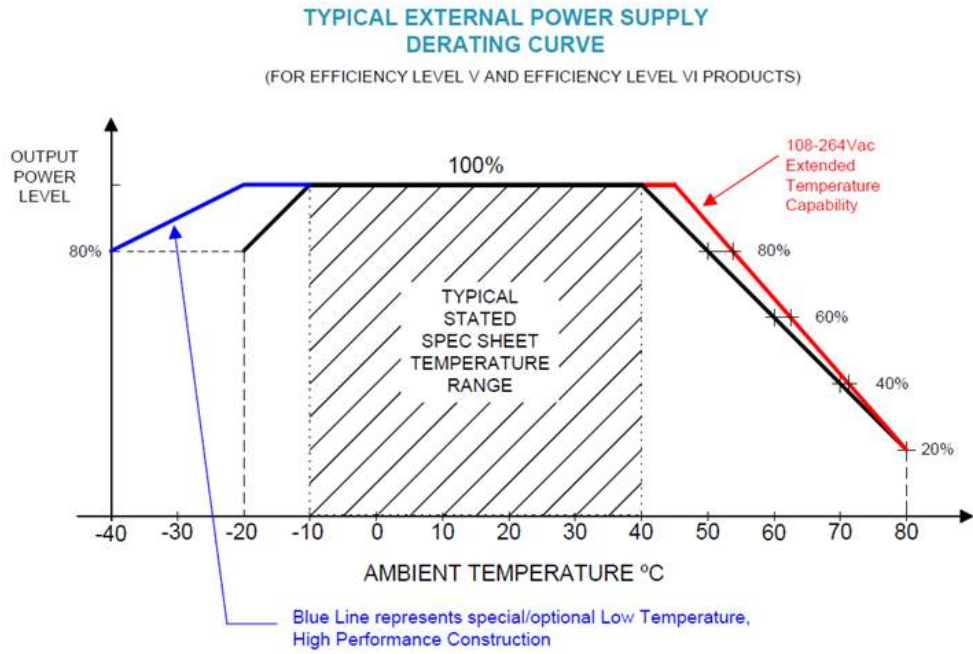


Alternative housing with input cord clamp to prevent accidental removal of the power cord. Product PN# ends with suffix "CL"
