

The 25TTS...FP High Voltage Series of silicon controlled rectifiers are specifically designed for medium power switching and phase control applications. The glass passivation technology used has reliable operation up to 125 °C junction temperature.

Typical applications are in input rectification (soft start) and these products are designed to be used with Vishay HPP input diodes, switches and output rectifiers which are available in identical package outlines.

The fully isolated package ($V_{INS} = 2500 \ V_{RMS}$) is UL E78996 approved. Plastic material $94V_{Ro}$.




Fig. 1 - Current Rating Characteristics




Fig. 2 - Current Rating Characteristics




Fig. 3 - On-State Power Loss Characteristics





Fig. 4 - On-State Power Loss Characteristics

Fig. 5 - Maximum Non-Repetitive Surge Current




Fig. 6 - Maximum Non-Repetitive Surge Current




Fig. 7 - On-State Voltage Drop Characteristics




Fig. 8 - Thermal Impedance Z_{thJC} Characteristics




Fig. 9 - Gate Characteristics


