Forward Current vs. Forward Voltage:



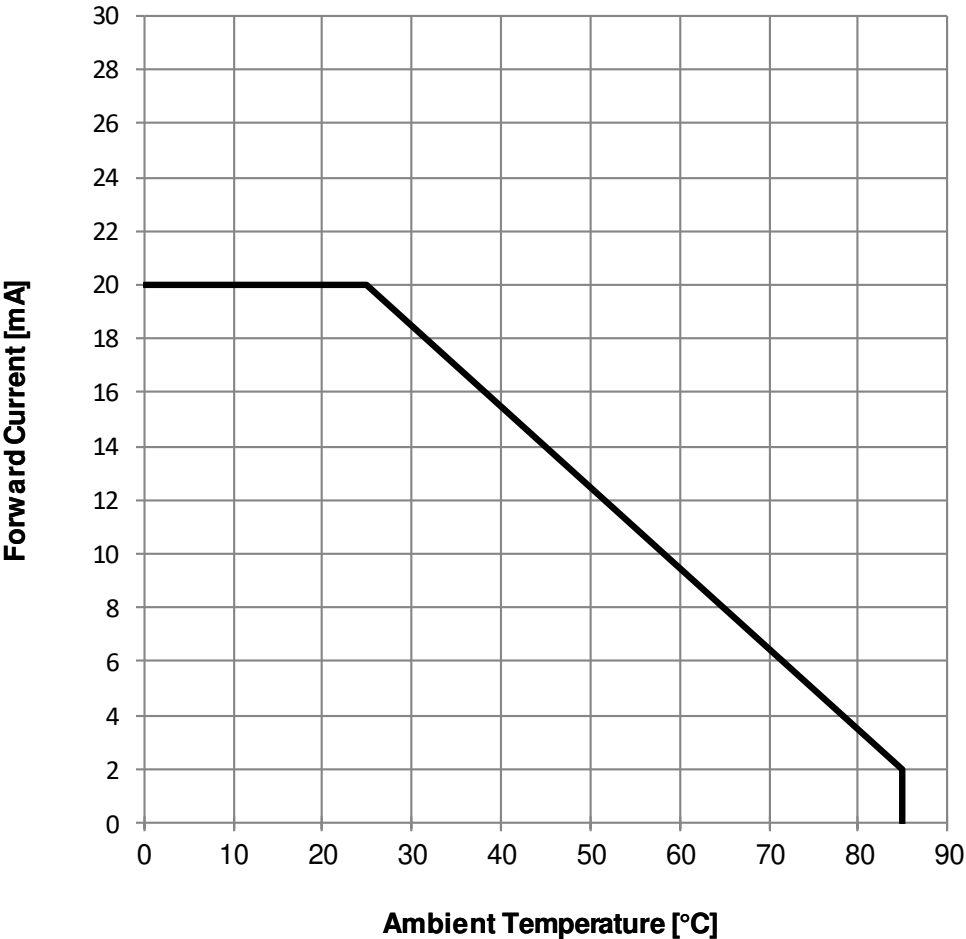
Luminous Intensity vs. Forward Current:

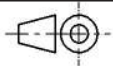

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.

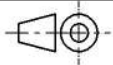

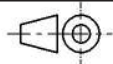

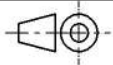
