




Figure 1. Turn-On Time

Figure 2. Turn-Off Time




Figure 3. DC Current Gain




Figure 4. Collector Saturation Region




Figure 5. Turn – On Time




Figure 6. Turn-Off Time




Figure 7. Frequency Effects




Figure 8. Source Resistance Effects




Figure 9. Capacitances




Figure 10. Current-Gain Bandwidth Product




Figure 11. Collector Emitter Saturation Voltage vs. Collector Current






Figure 13. Base Emitter Voltage vs. Collector Current




Figure 15. Safe Operating Area




