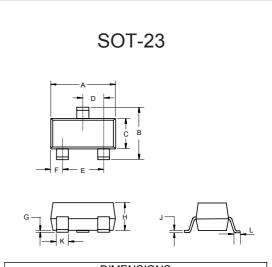
#### **Internal Structure**





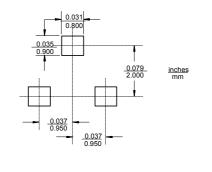


# 350mW Small Signal Diode



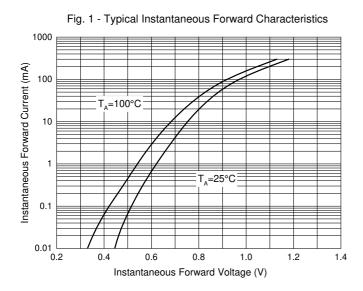

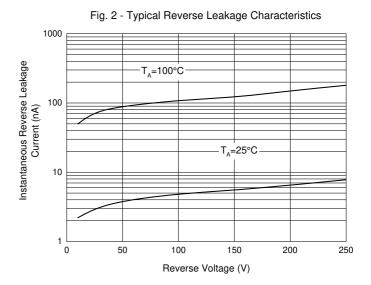
## **Suggested Solder Pad Layout**

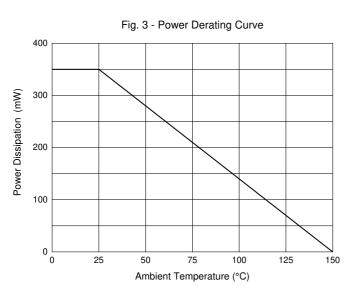
