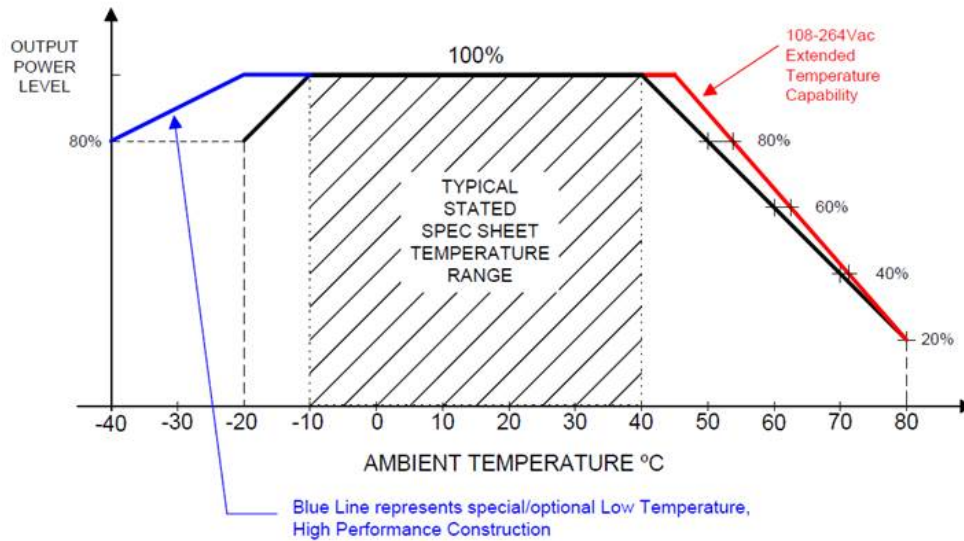

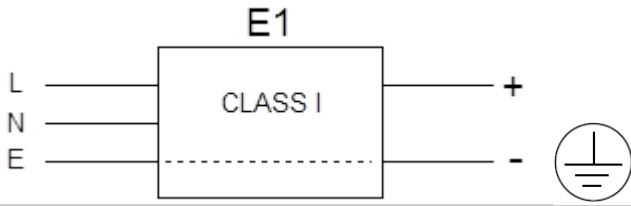
**TYPICAL EXTERNAL POWER SUPPLY
