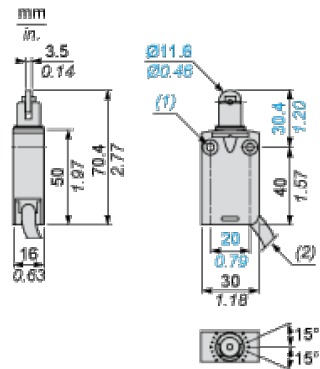

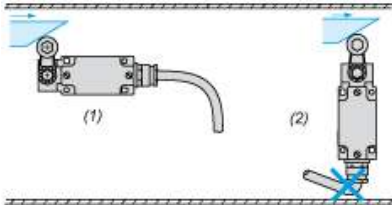

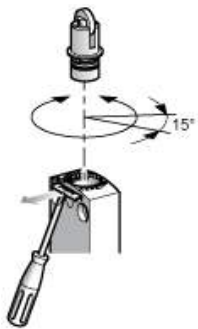
Sweep of Connecting Cable

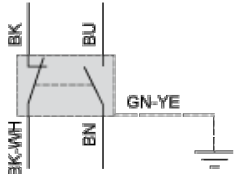

Wiring Diagram

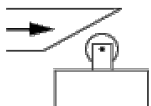
2-pole NC + NO Snap Action



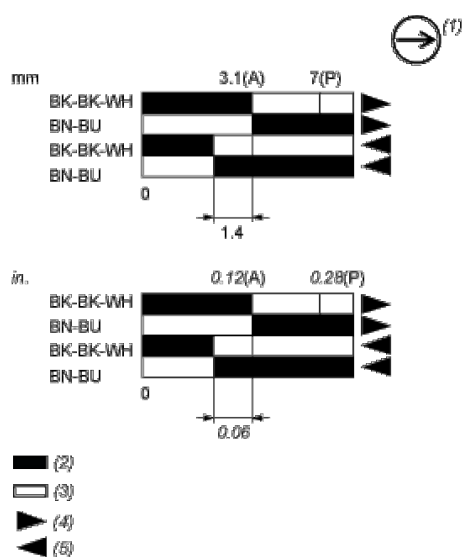
