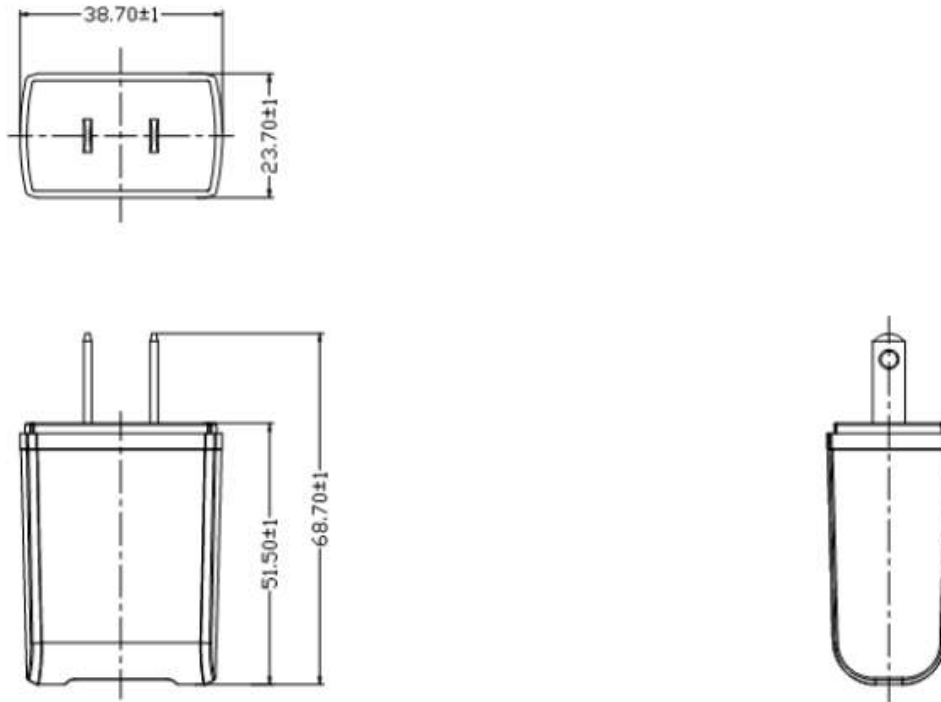

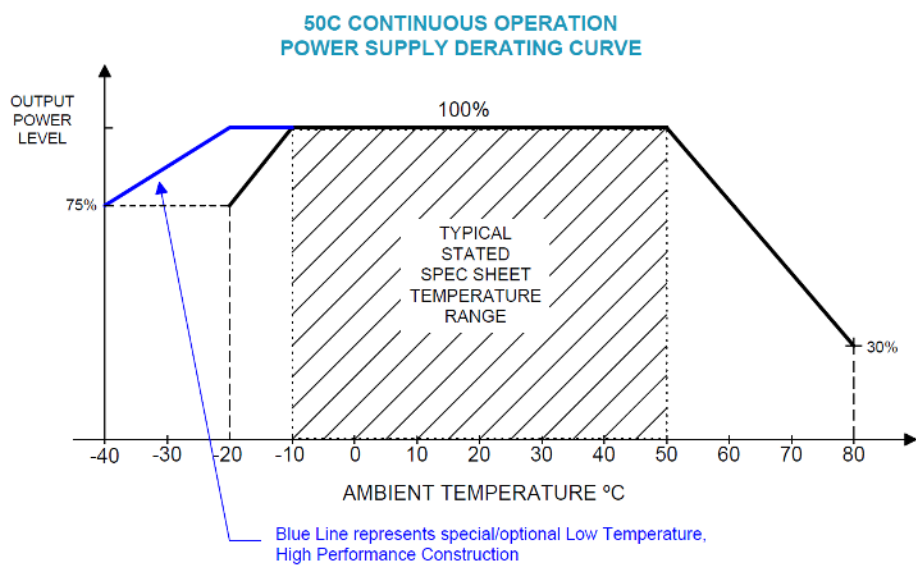

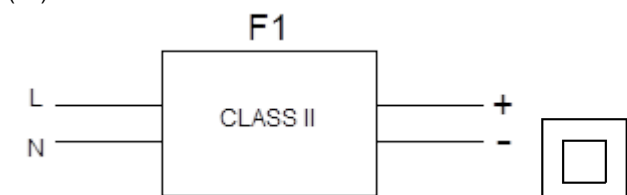
DERATING CURVE

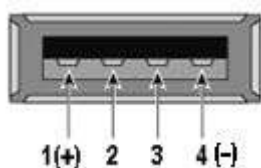

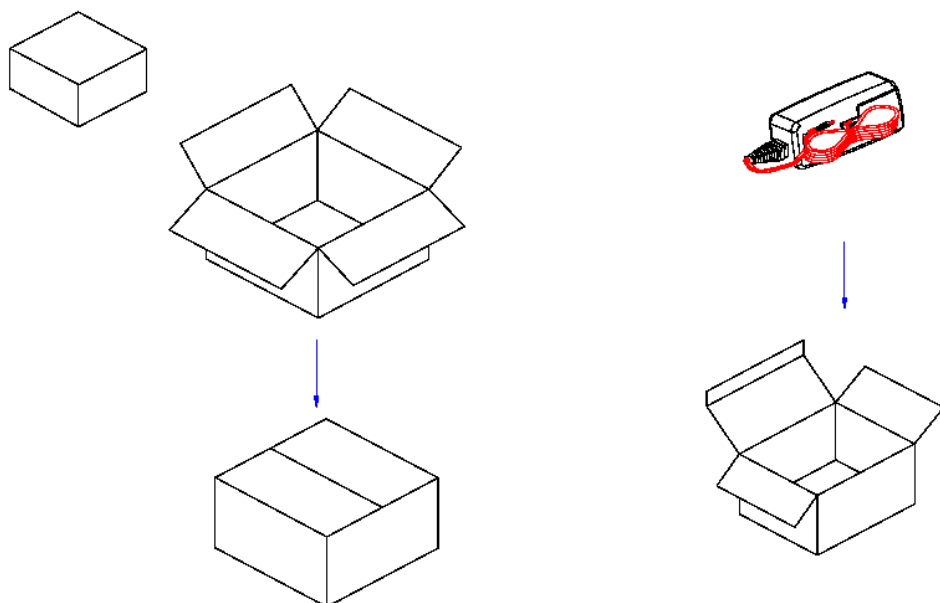
