




PACKAGE DIMENSIONS








REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS


 Don't cause stress to the LEDs while it is exposed to high temperature.

 Reflow soldering is recommended. Other soldering methods are not recommended as they might cause damage to the product.


PACKING & LABEL SPECIFICATIONS
