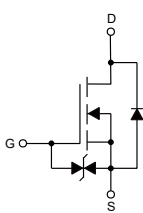

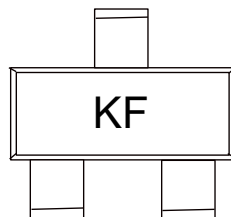
Note:

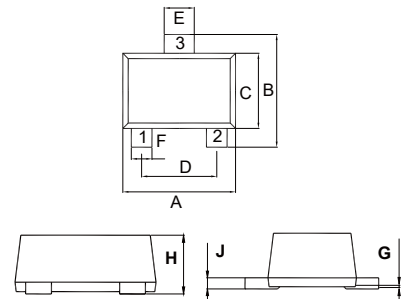


1. GATE

3. DRAIN



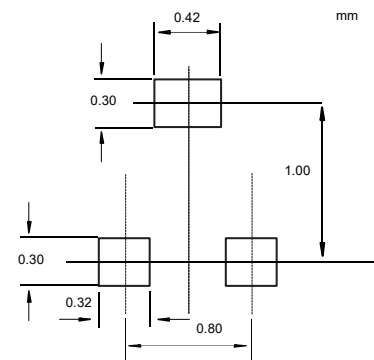

Fig. 1 - Typical Output Characteristics

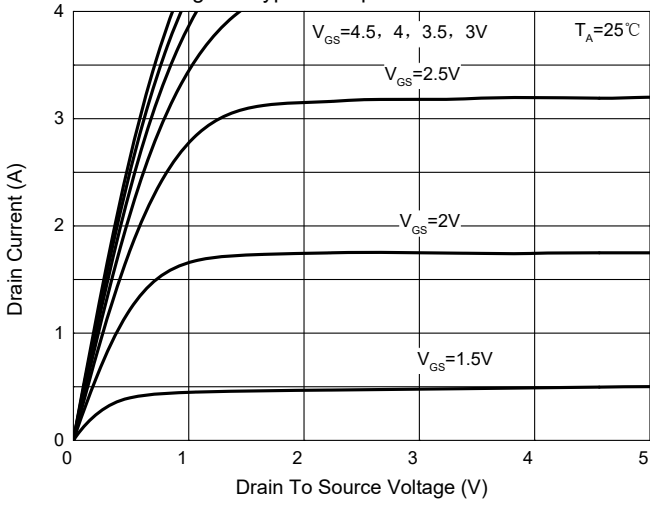


Fig. 2 - Transfer Characteristics

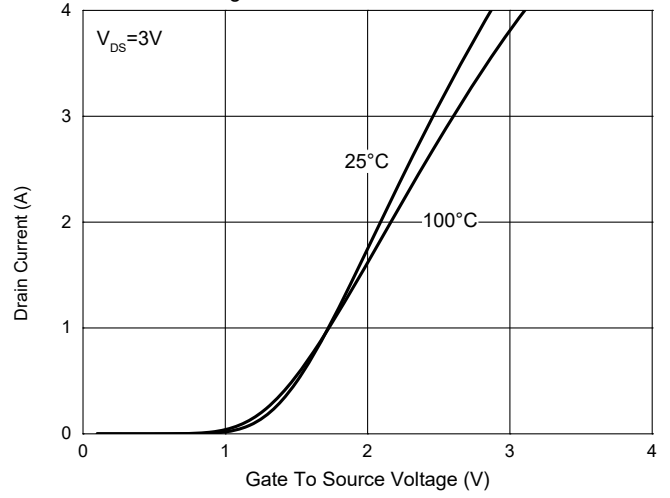


Fig. 3 - $R_{DS(ON)} - I_D$

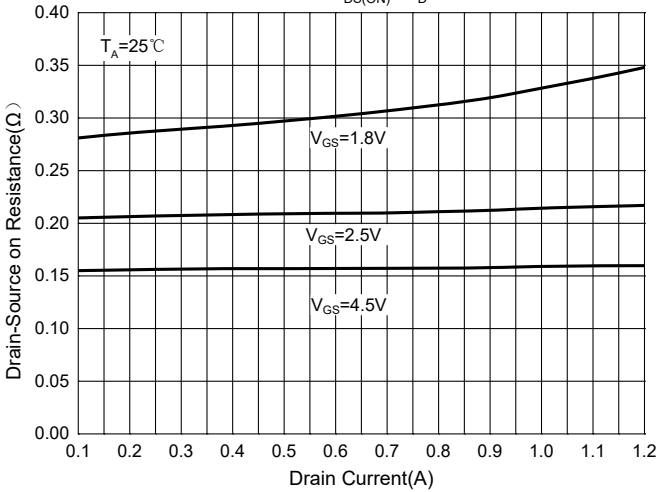


Fig. 4 - $R_{DS(ON)} - V_{GS}$

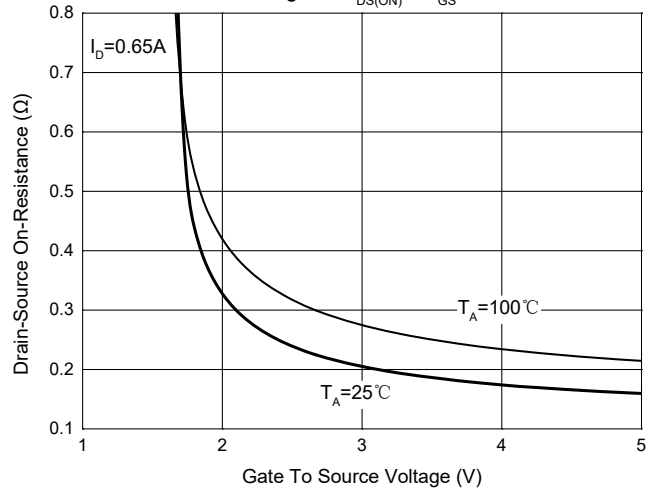


Fig. 5 - $I_S - V_{SD}$

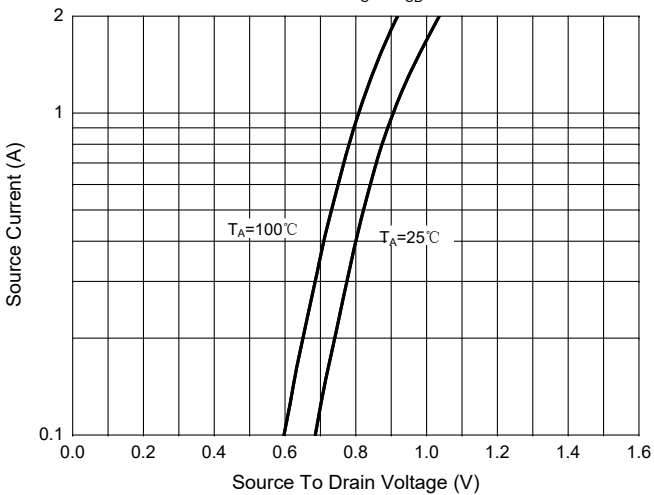
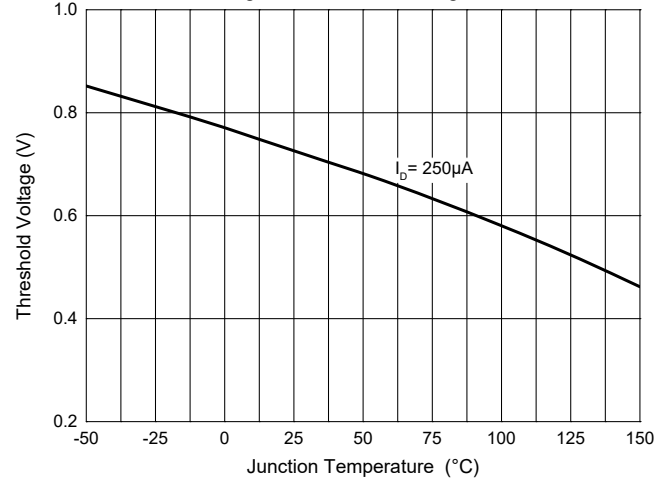


Fig. 6 - Threshold Voltage

Fig. 7 - GateCharge

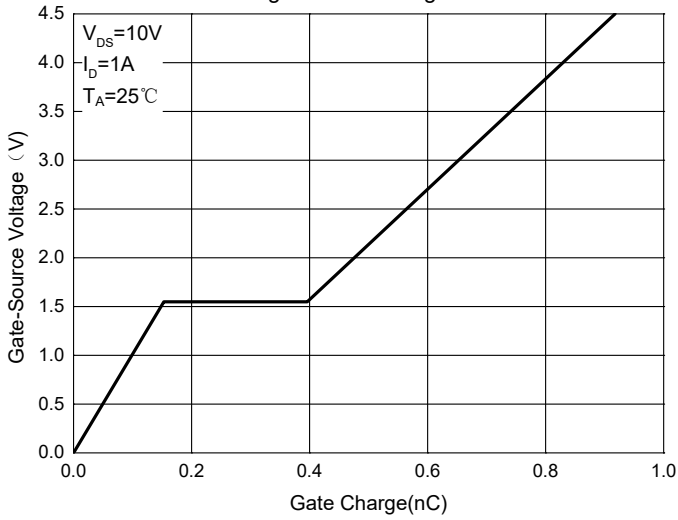


Fig. 8 - Capacitance Characteristics

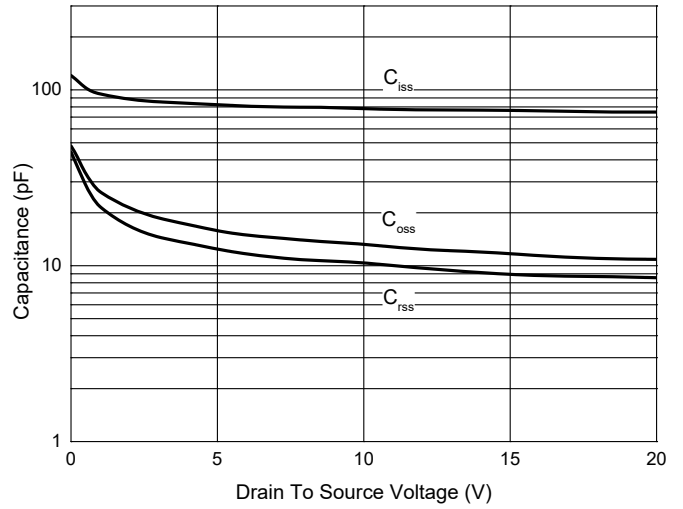


Fig.9-NormalizedOnResistanceCharacteristics

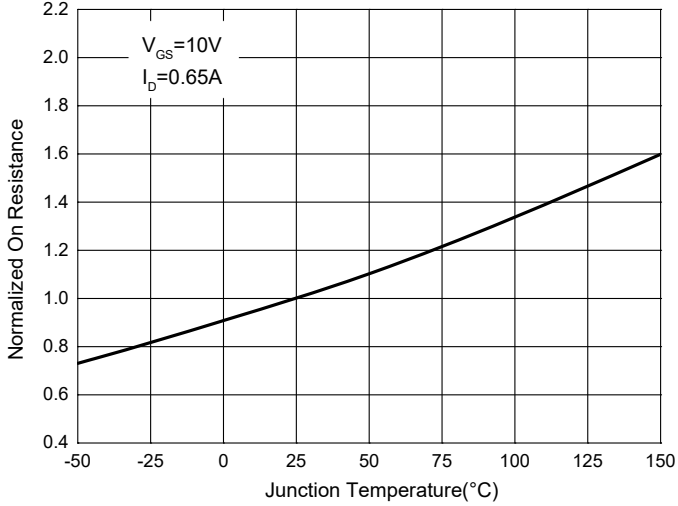


Fig. 10 - Current dissipation

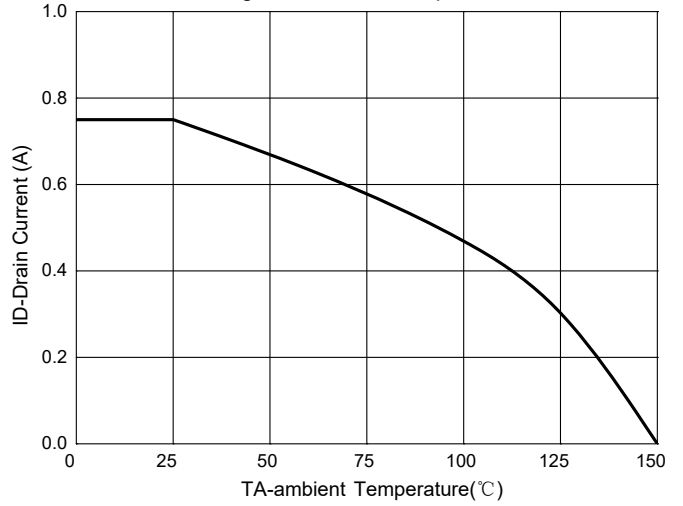
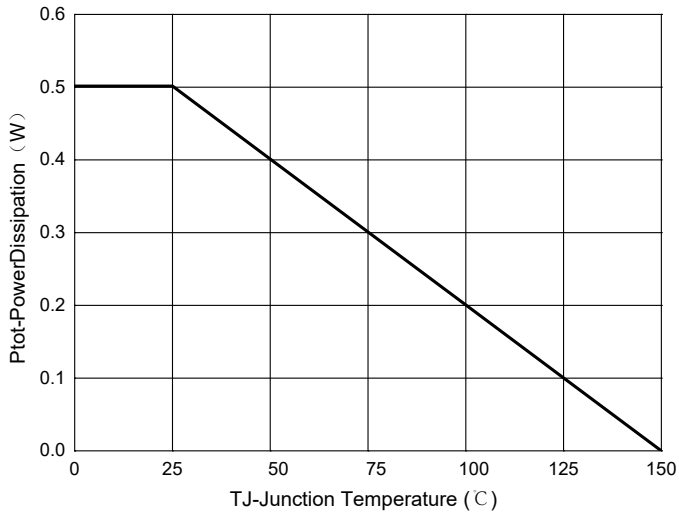


Fig.11-PowerDissipation

Fig. 12 - Safe Operation Area

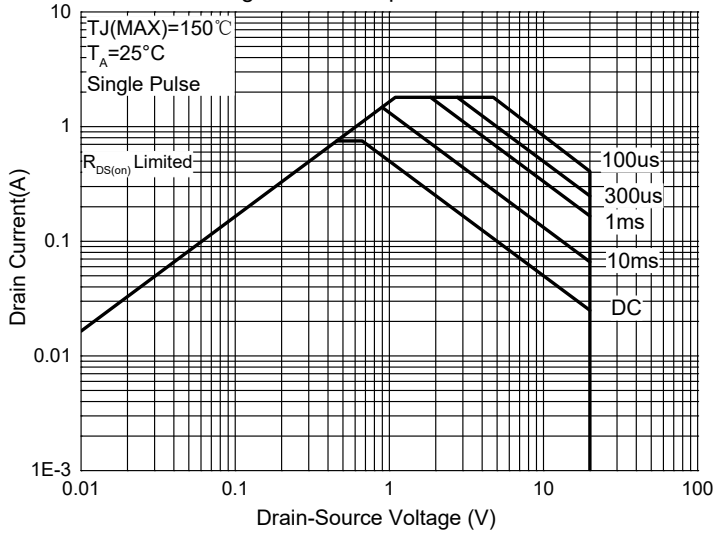
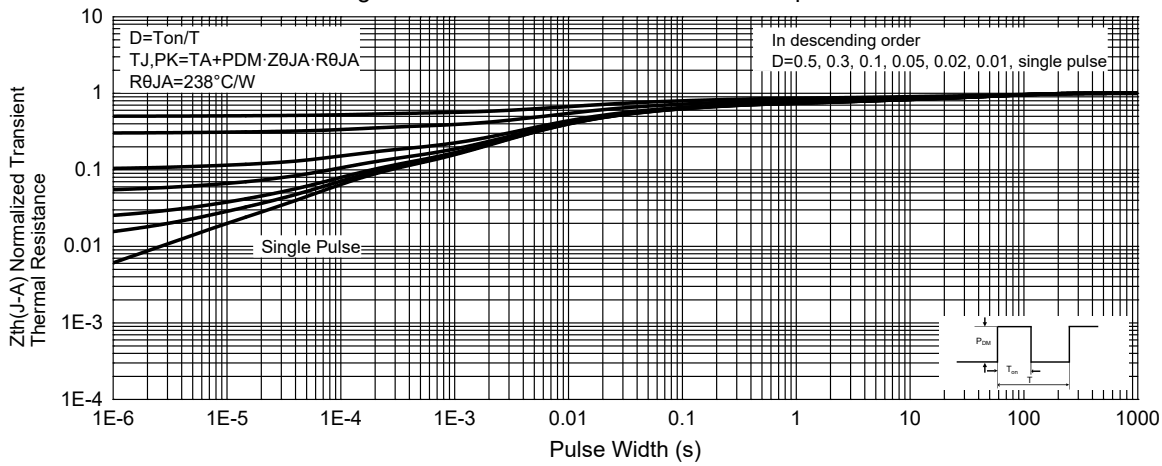


Fig. 13 - Normalized Transient Thermal Impedance
