




Fig. 5 DC Current Gain vs. Collector Current









Fig. 6 Gain Bandwidth Product vs. Collector Current









Fig. 11 On-Resistance vs. Gate-Source Voltage (2N7002)

I_D, DRAIN CURRENT (A)


