





● Electrical characteristic curves(T<sub>a</sub> = 25°C)









# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





## Fig.8 Gain Bandwidth Product vs. Emitter Current





## • Electrical characteristic curves ( $T_a = 25^{\circ}C$ )







### Fig.10 Safe Operating Area




