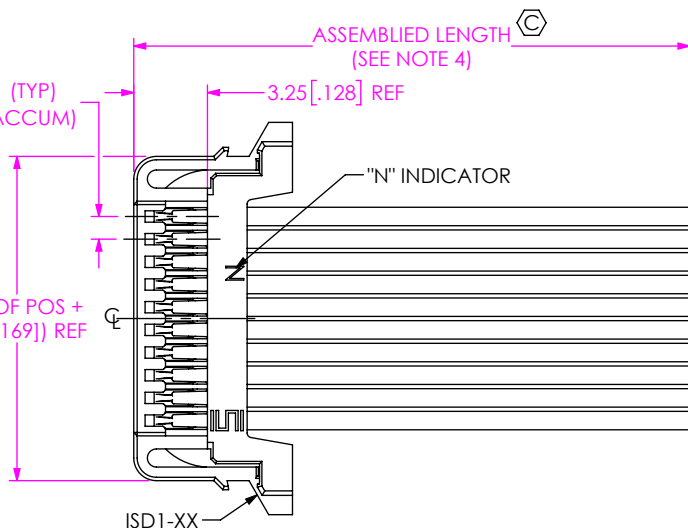
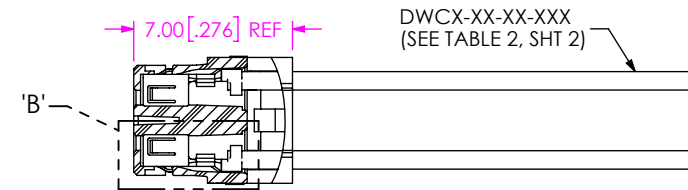
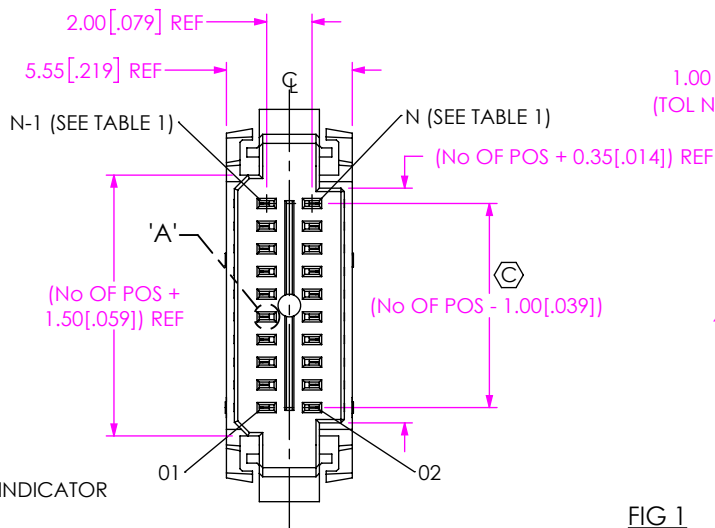
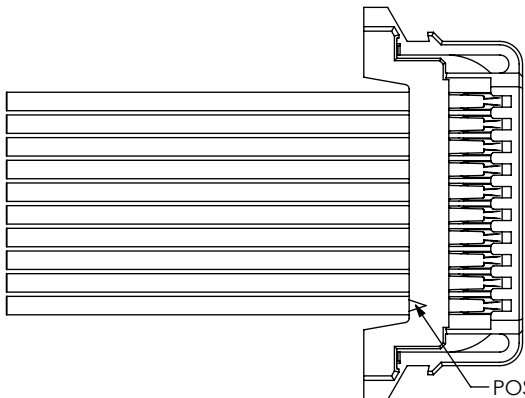


DETAIL 'A'

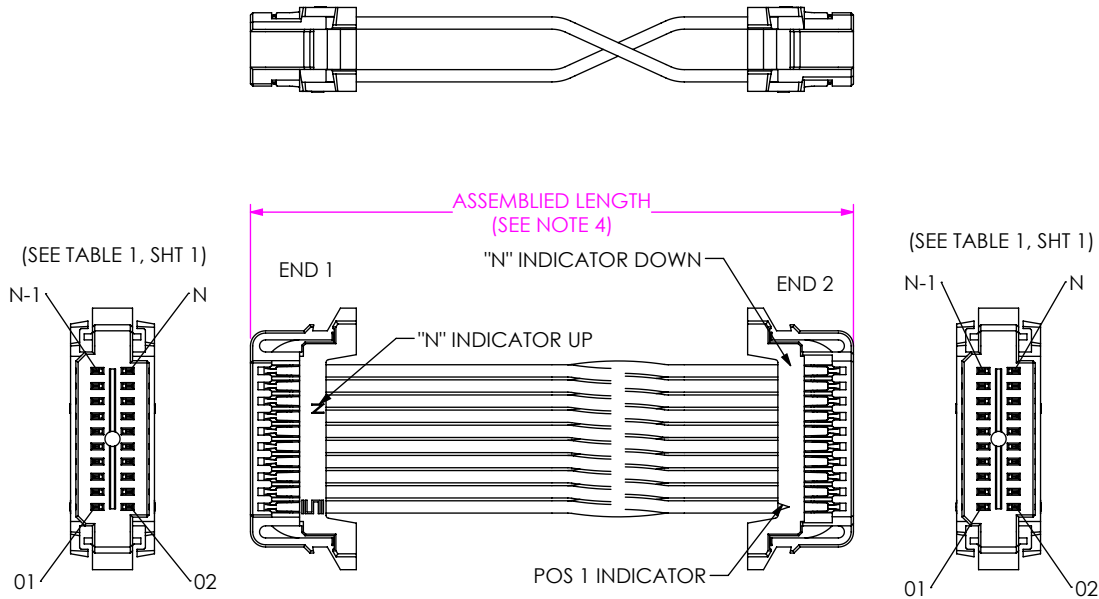

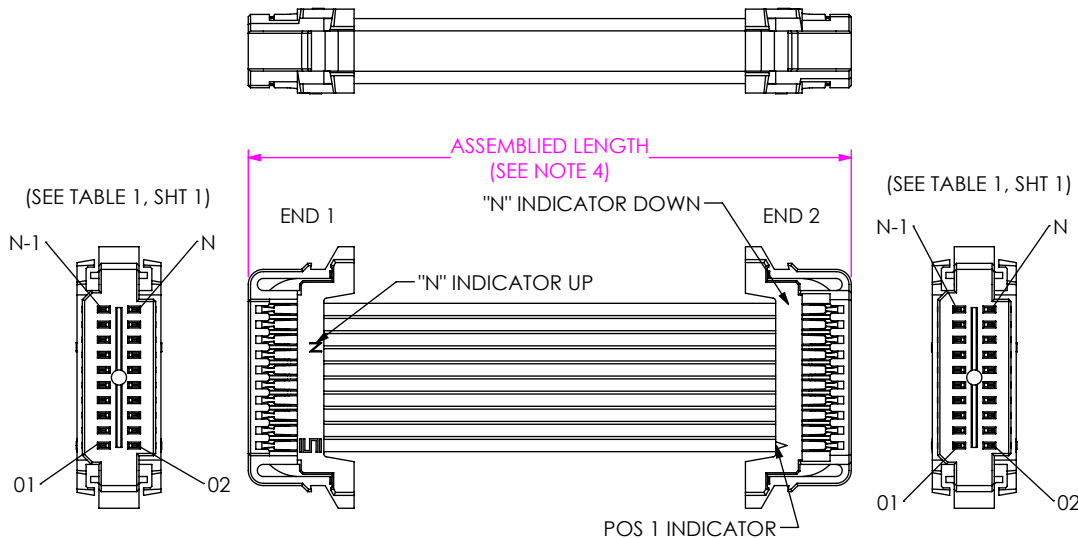

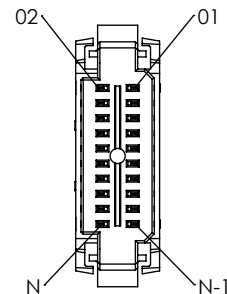
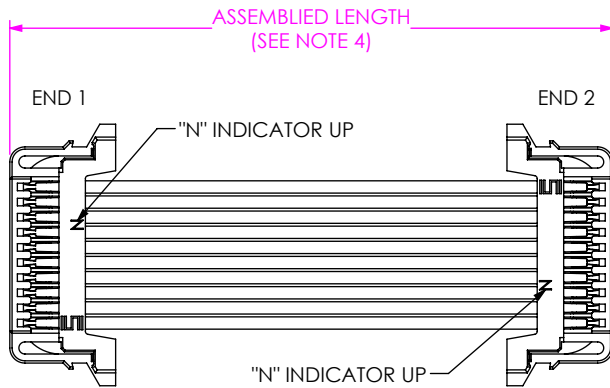
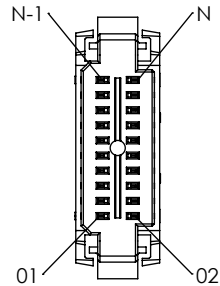
CABLE CUT IN-PROCESS
