### Typical Insertion Loss:



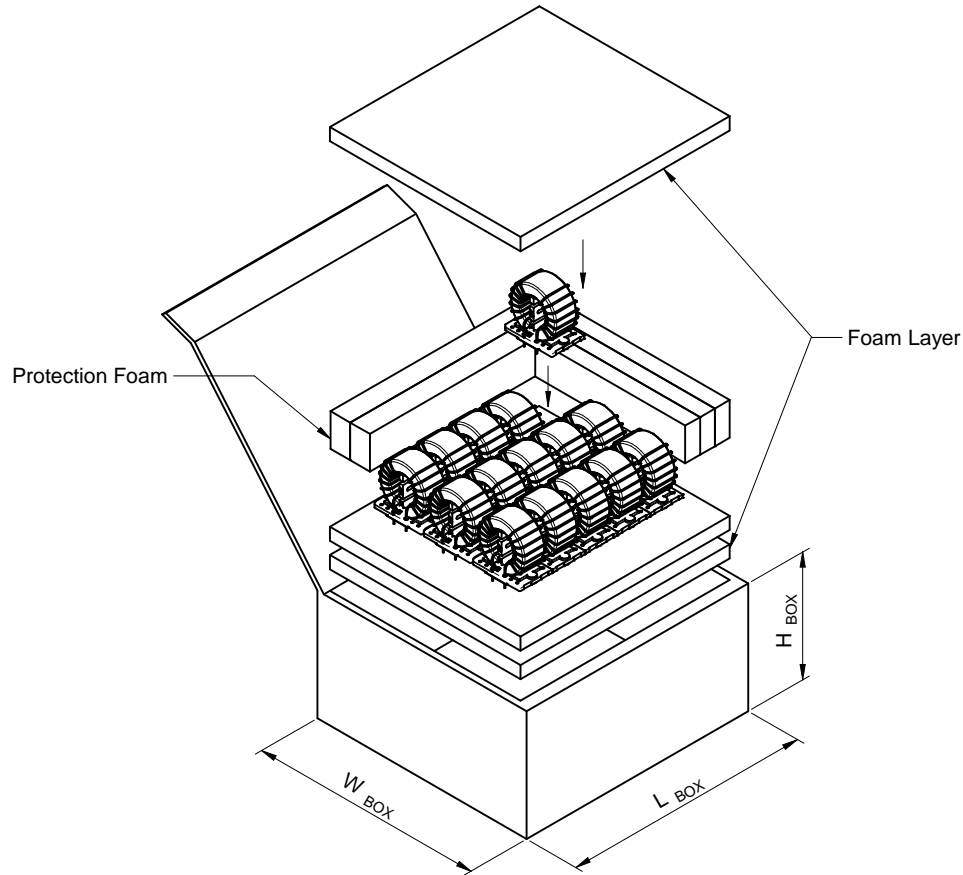

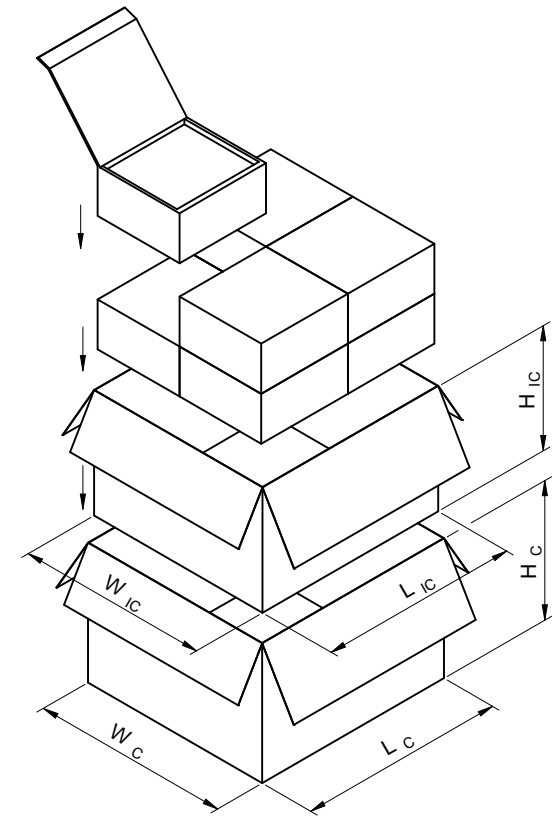



#### Soldering



#### Packaging:


