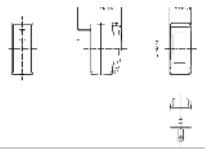

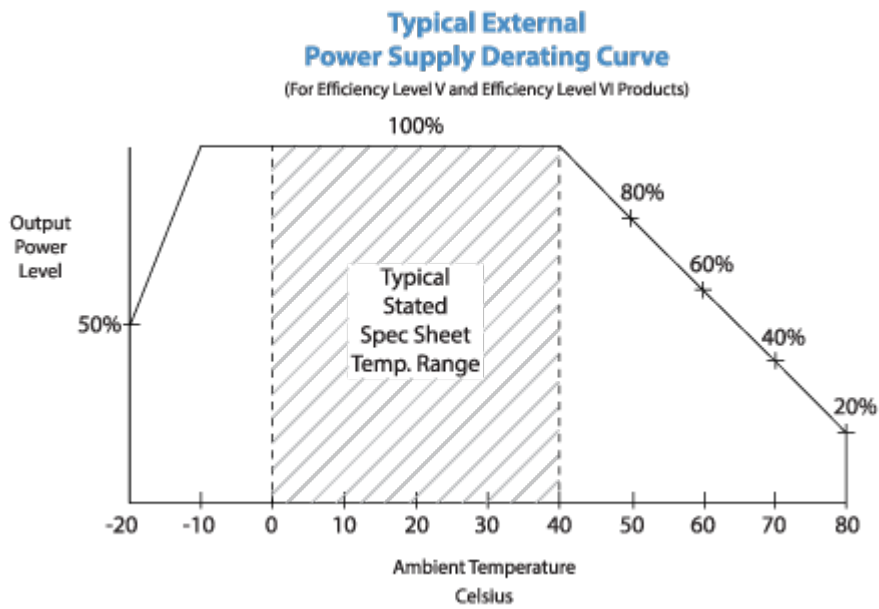

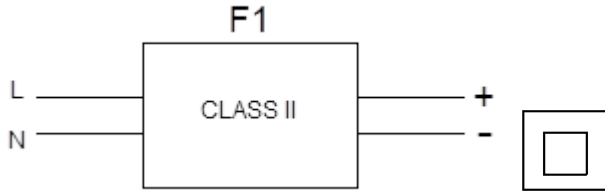
DERATING CURVE
