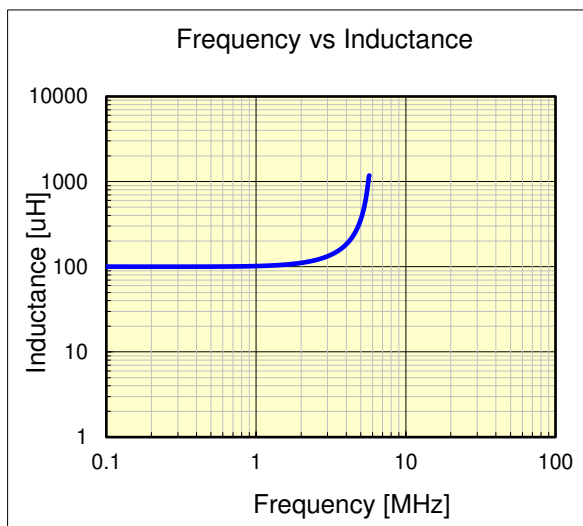
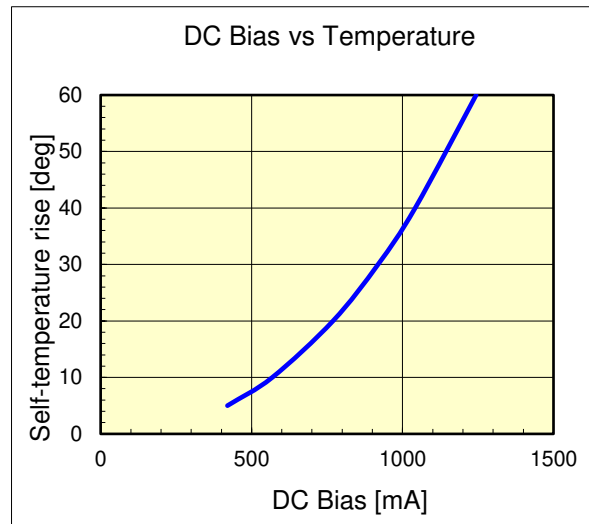
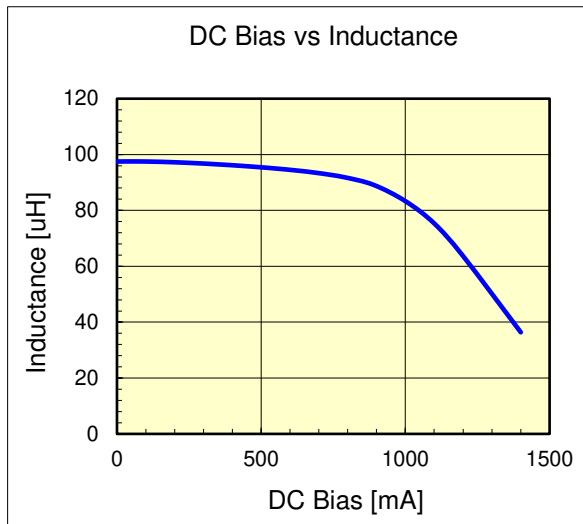
【Reflow Mounting Pattern】
