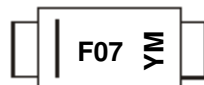

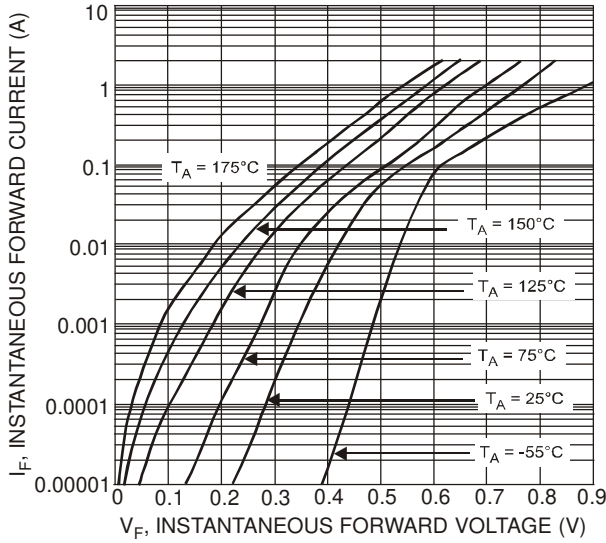


Fig. 1 Typical Forward Characteristics

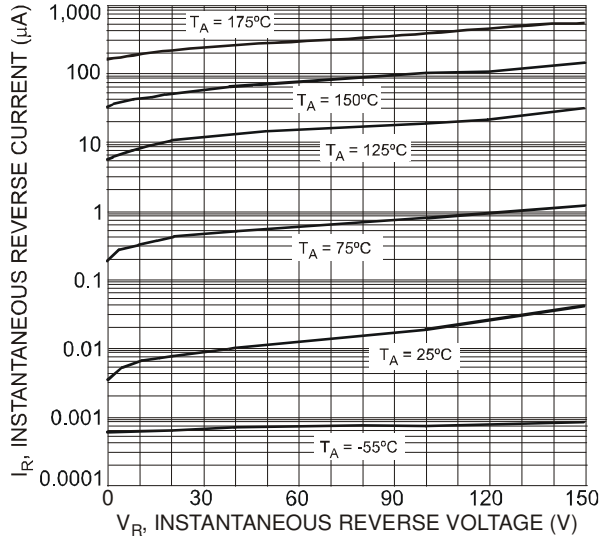


Fig. 2 Typical Reverse Characteristics

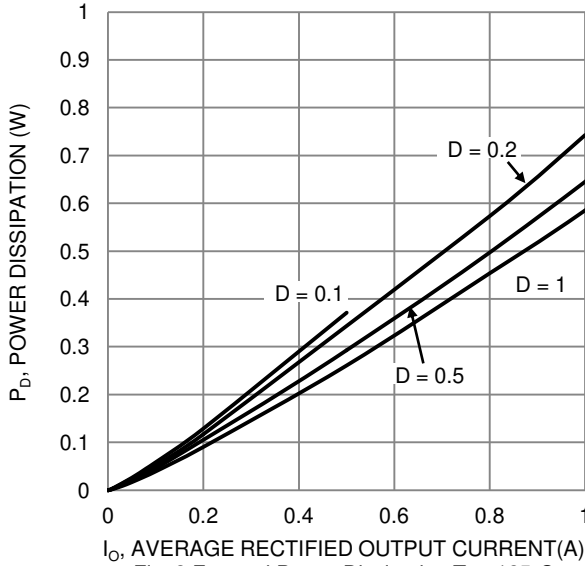


Fig. 3 Forward Power Dissipation $T_J = 125^\circ\text{C}$

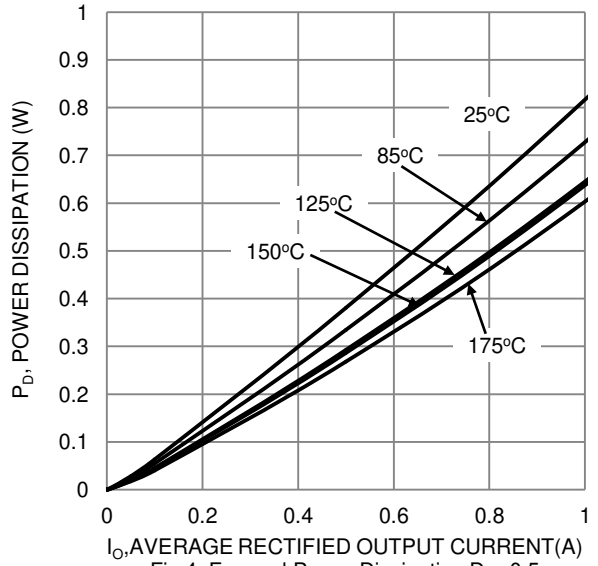


Fig. 4 Forward Power Dissipation $D = 0.5$

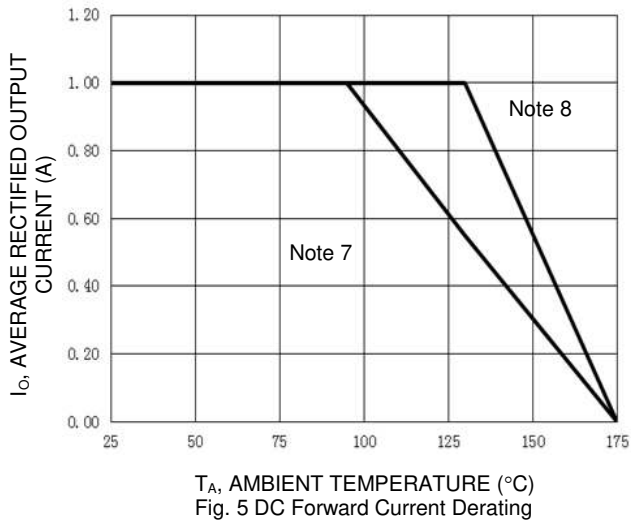


Fig. 5 DC Forward Current Derating

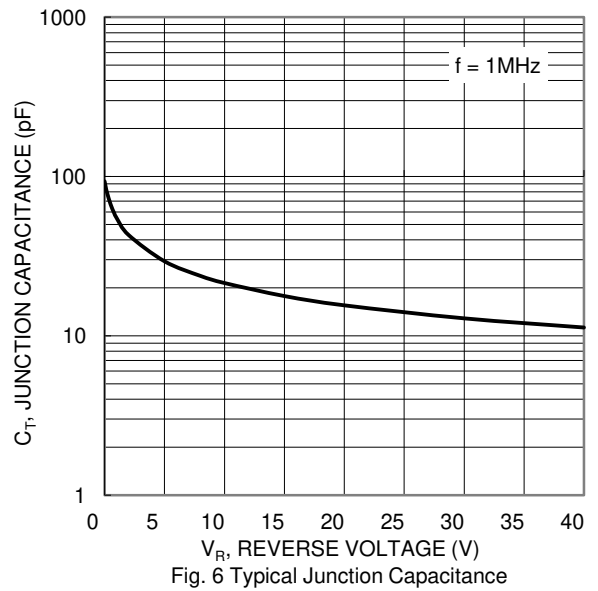


Fig. 6 Typical Junction Capacitance

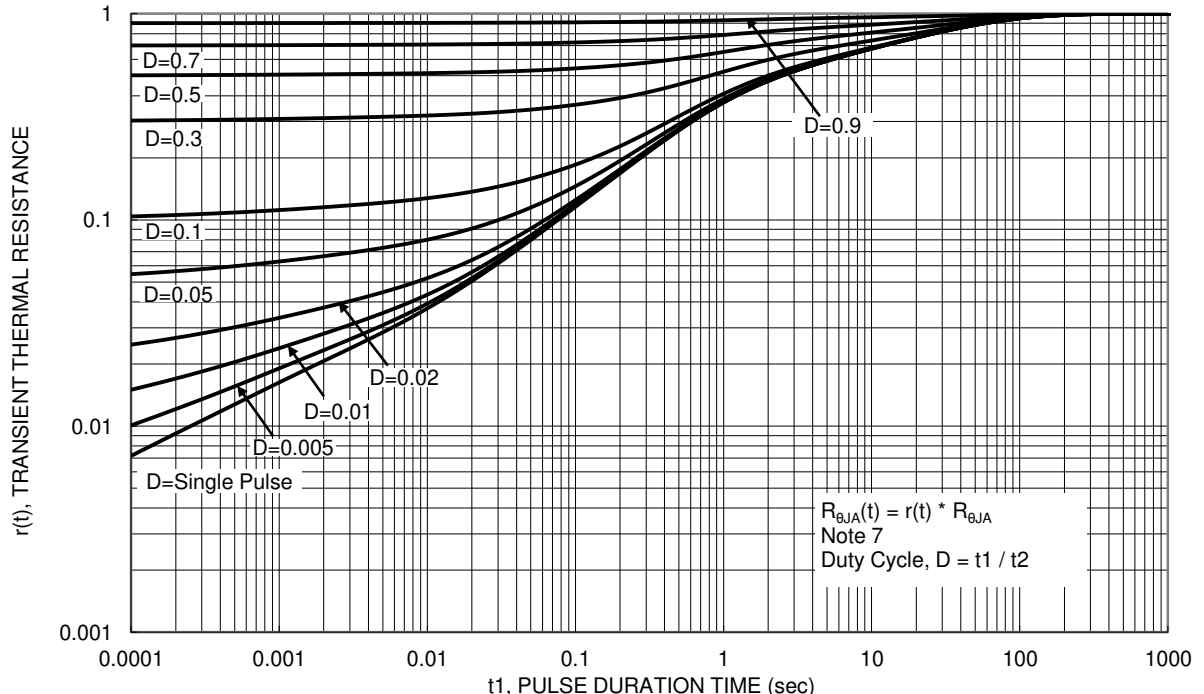
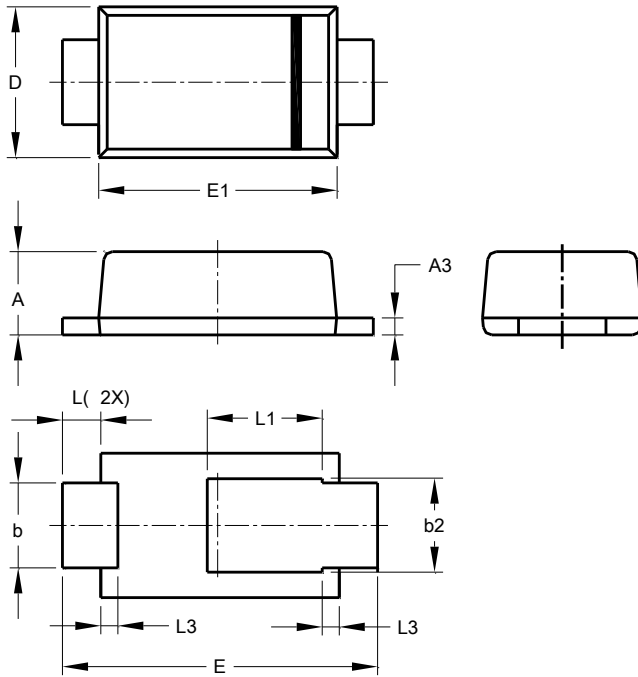


Fig. 7 Transient Thermal Resistance

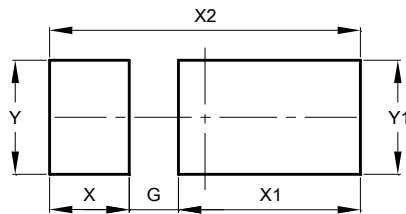
