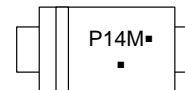

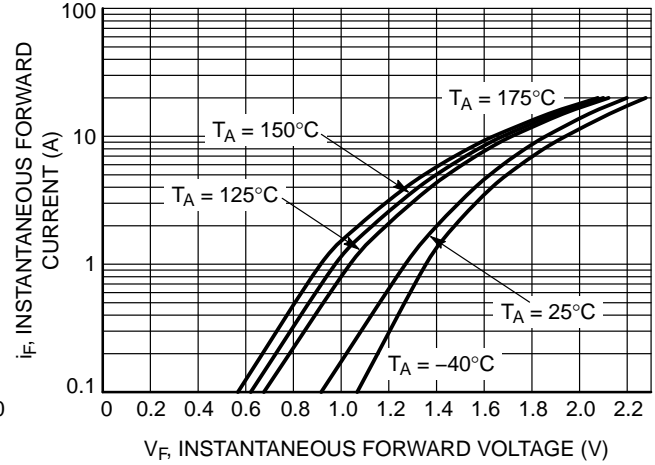

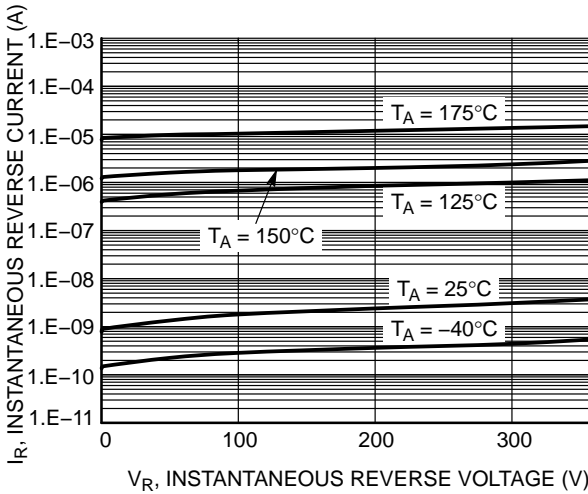

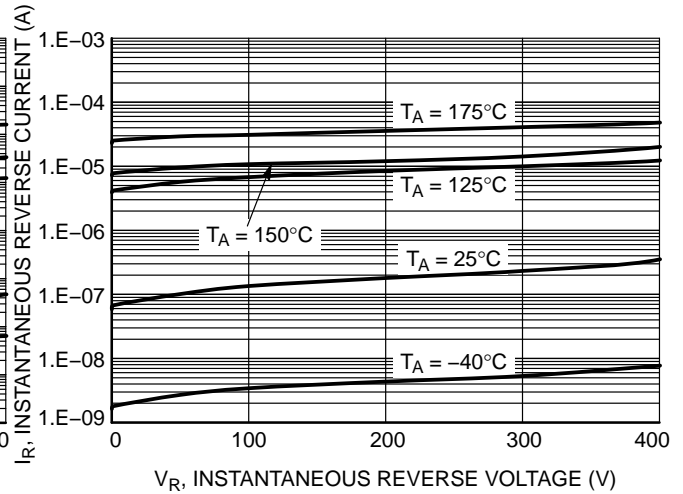
**Figure 1. Typical Instantaneous Forward Characteristics**



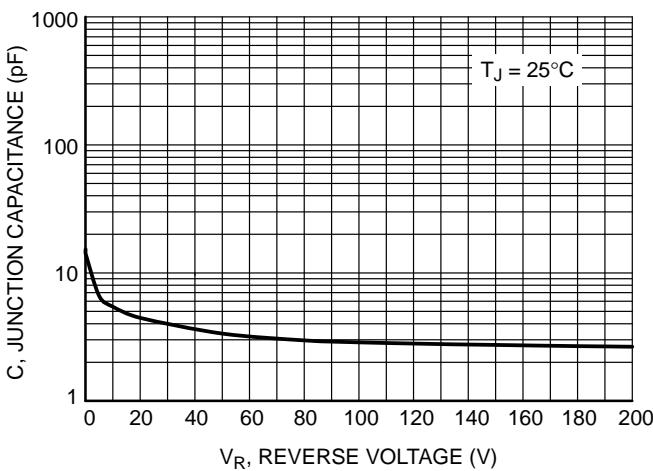
**Figure 2. Maximum Instantaneous Forward Characteristics**



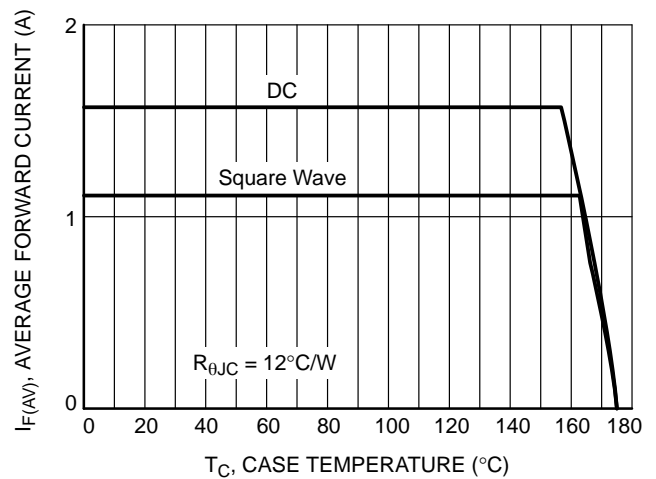
**Figure 3. Typical Reverse Characteristics**

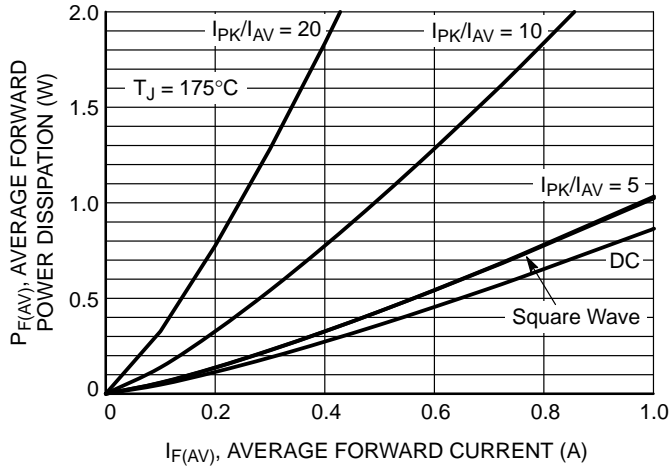


Figure 7. Forward Power Dissipation

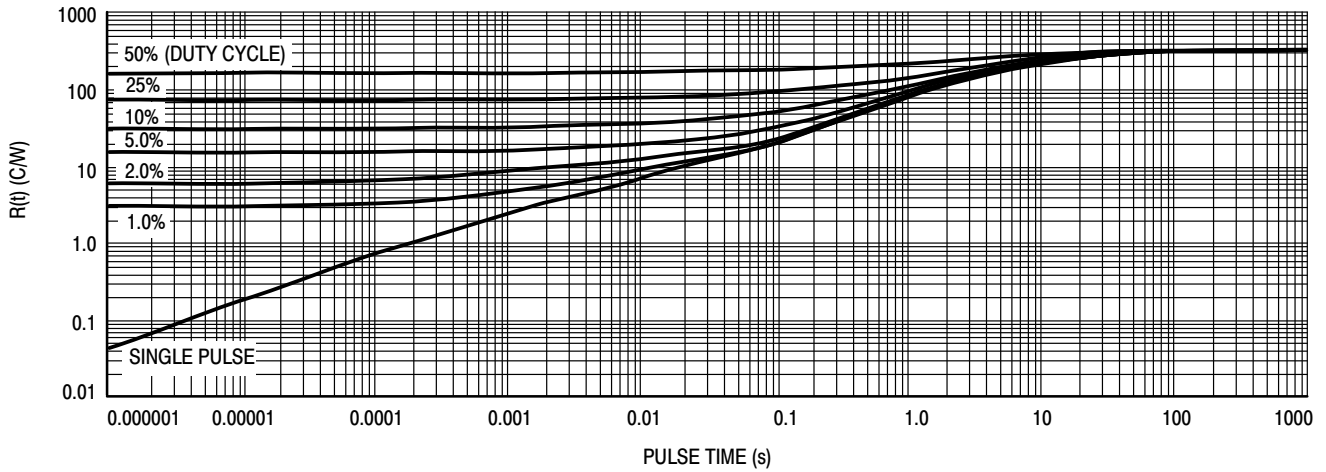


Figure 8. Thermal Response, Junction-to-Ambient ( $20\text{ mm}^2$  pad)

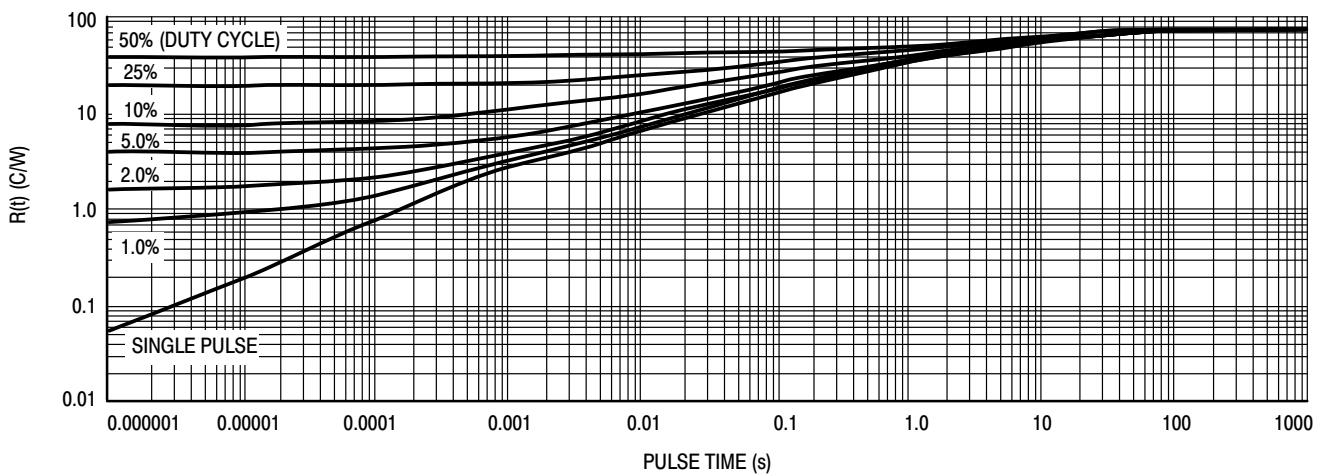
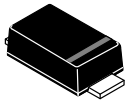


Figure 9. Thermal Response, Junction-to-Ambient ( $1\text{ in}^2$  pad)

### RECOMMENDED SOLDERING FOOTPRINT\*



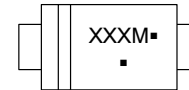
