


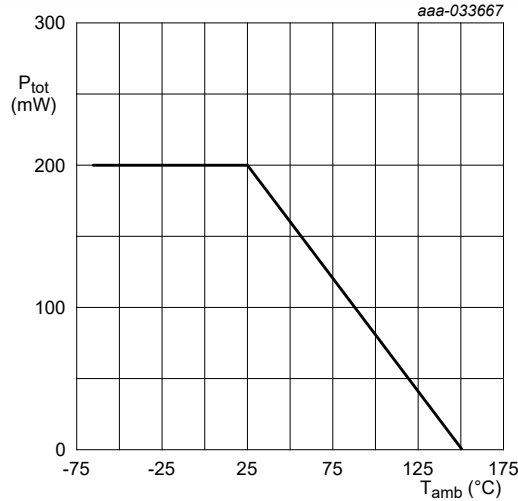

FR4 PCB, single-sided, 35 μm copper, tin-plated and standard footprint

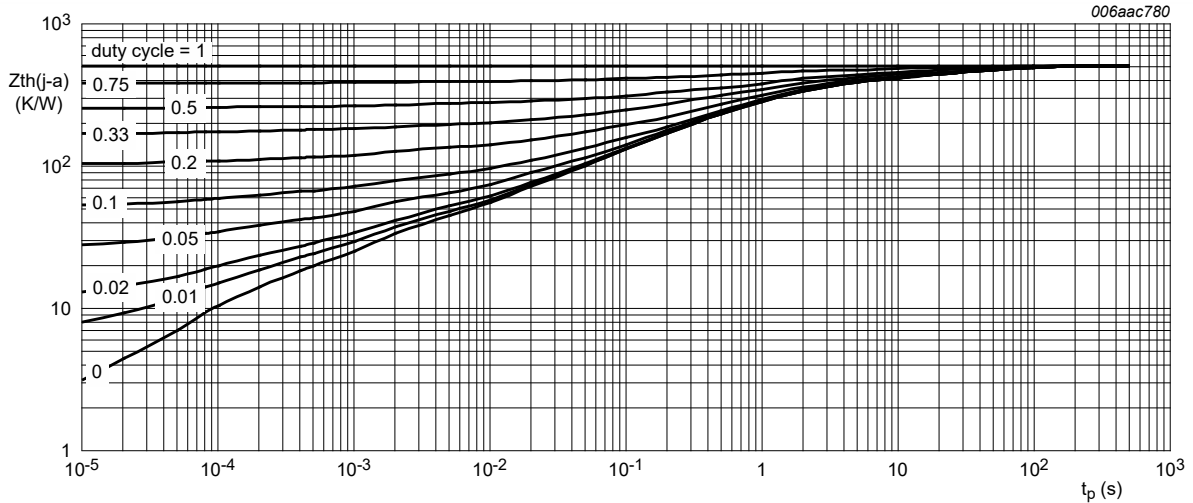
Fig. 1. Power derating curve

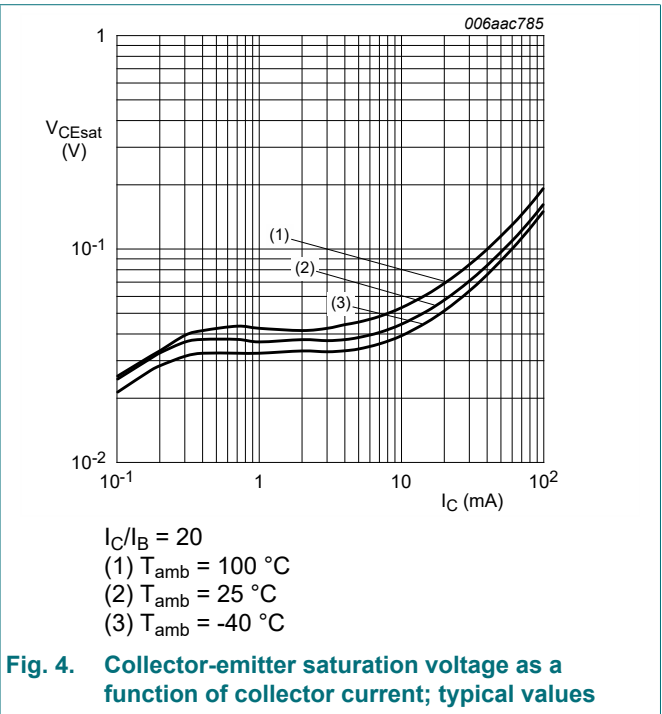
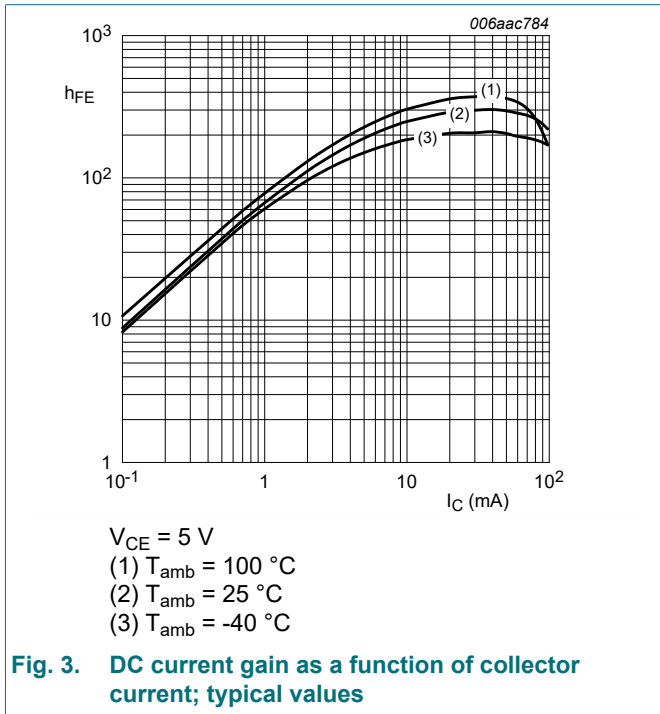
Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

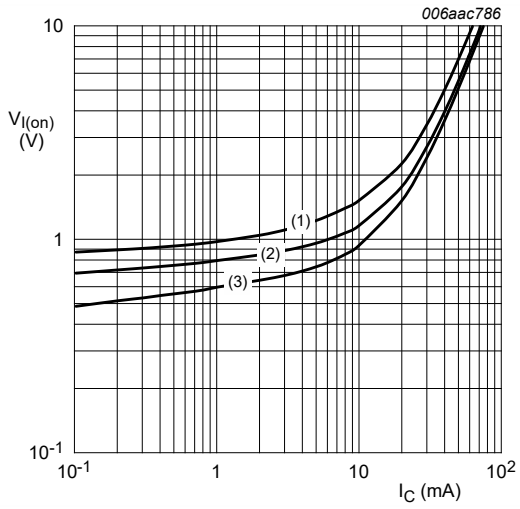

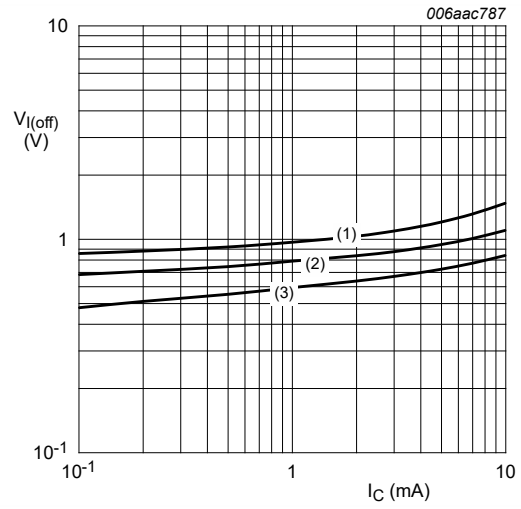

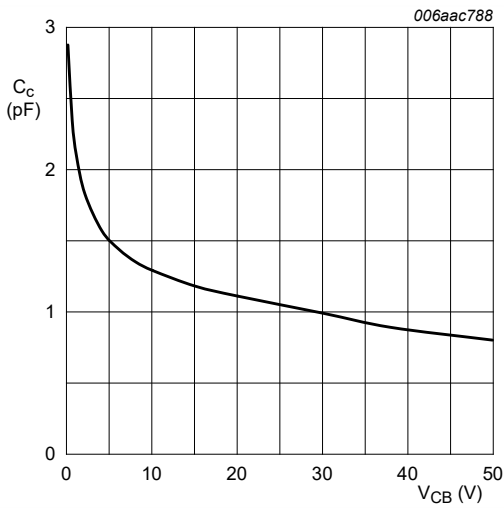

Fig. 5. On-state input voltage as a function of collector current; typical values



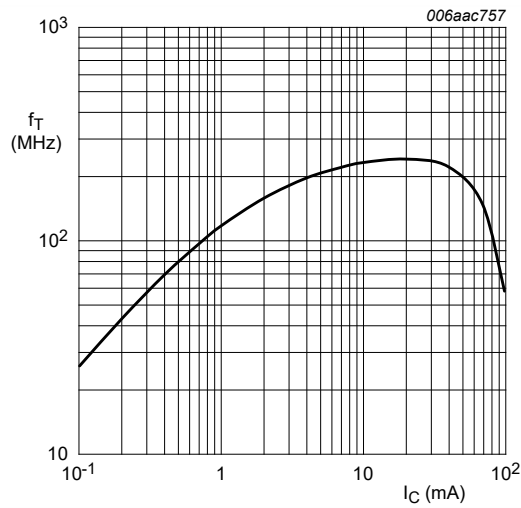

$$\frac{R2}{R1} = \frac{V(I4) - V(I3)}{R1 \cdot (I4 - I3)} - 1$$

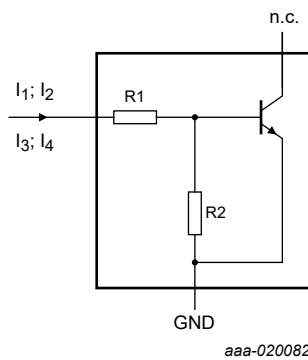


Fig. 9. Resistor test circuit

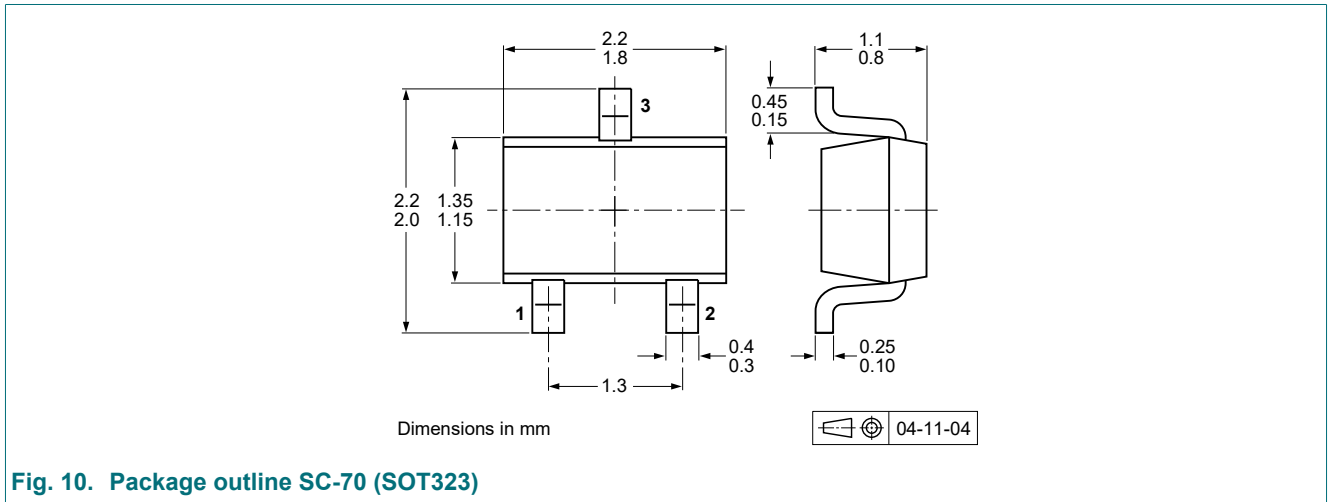


Fig. 10. Package outline SC-70 (SOT323)

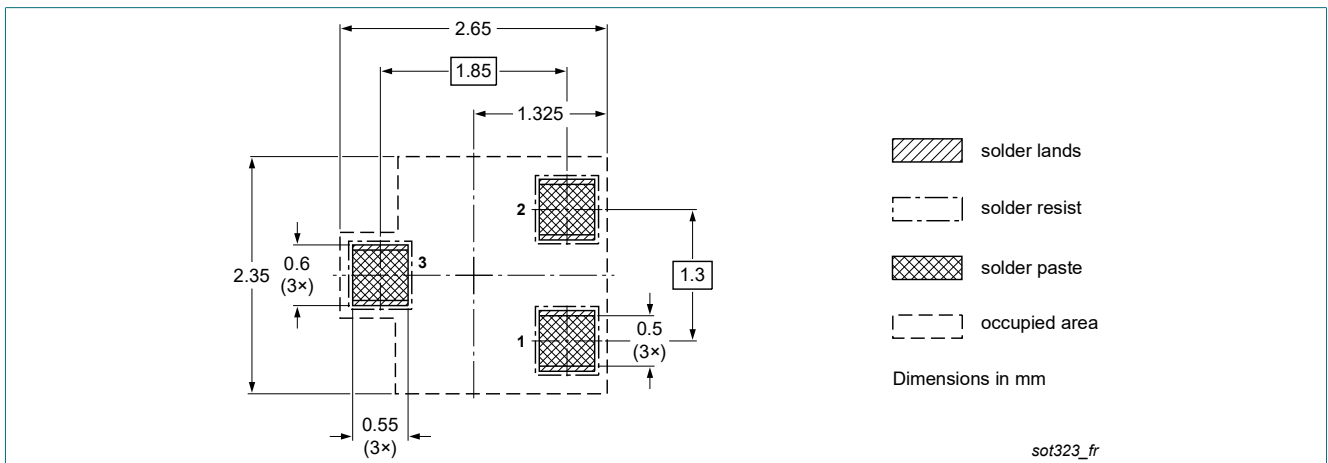


Fig. 11. Reflow soldering footprint for SC-70 (SOT323)

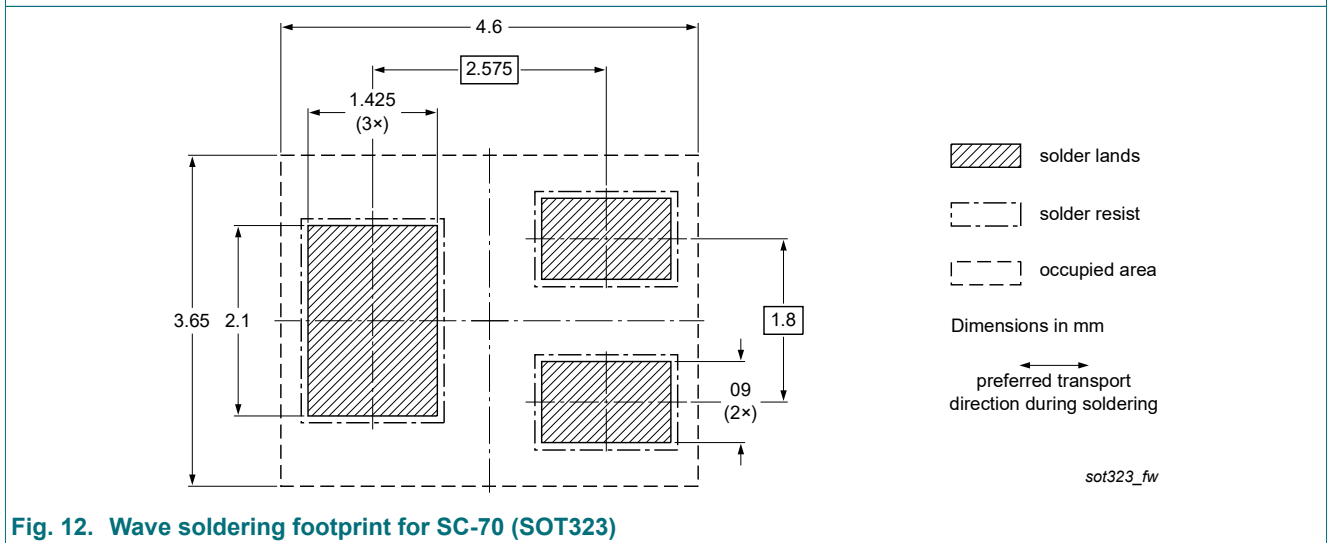


Fig. 12. Wave soldering footprint for SC-70 (SOT323)
