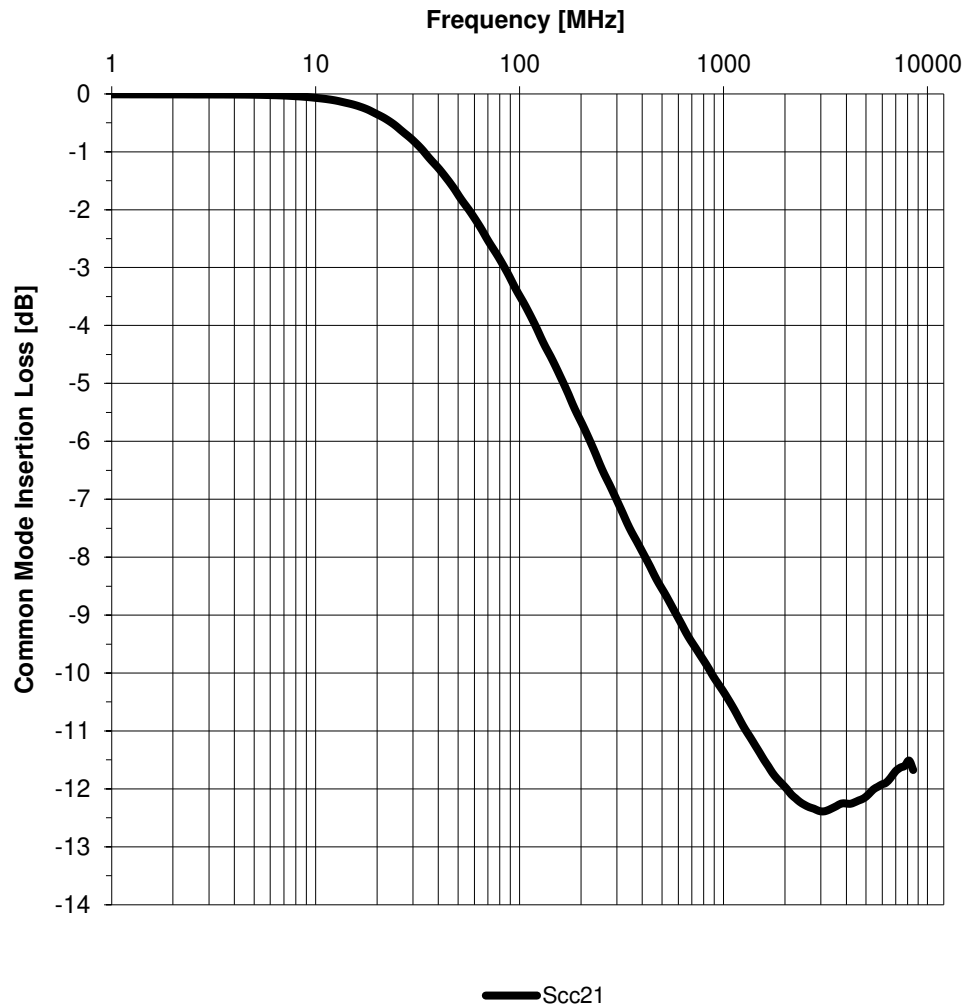
### Typical Differential Mode Insertion Loss Characteristics:



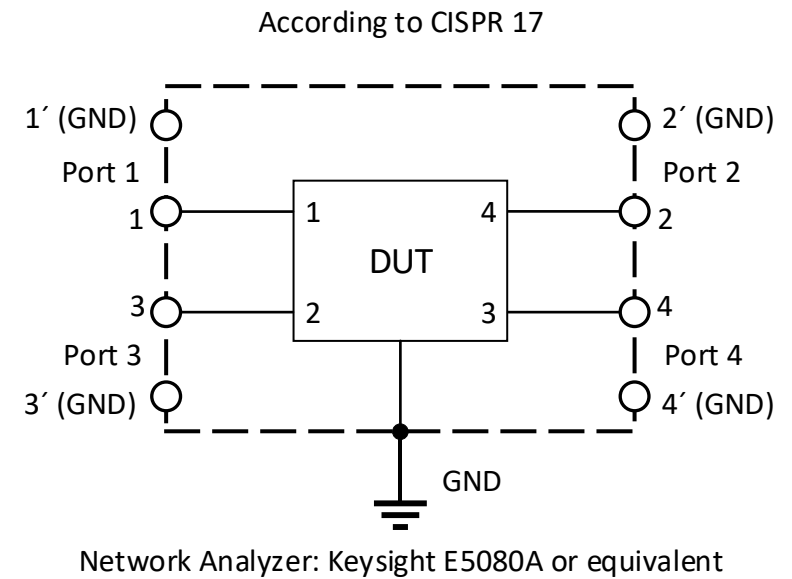

## Typical Common Mode Insertion Loss Characteristics:

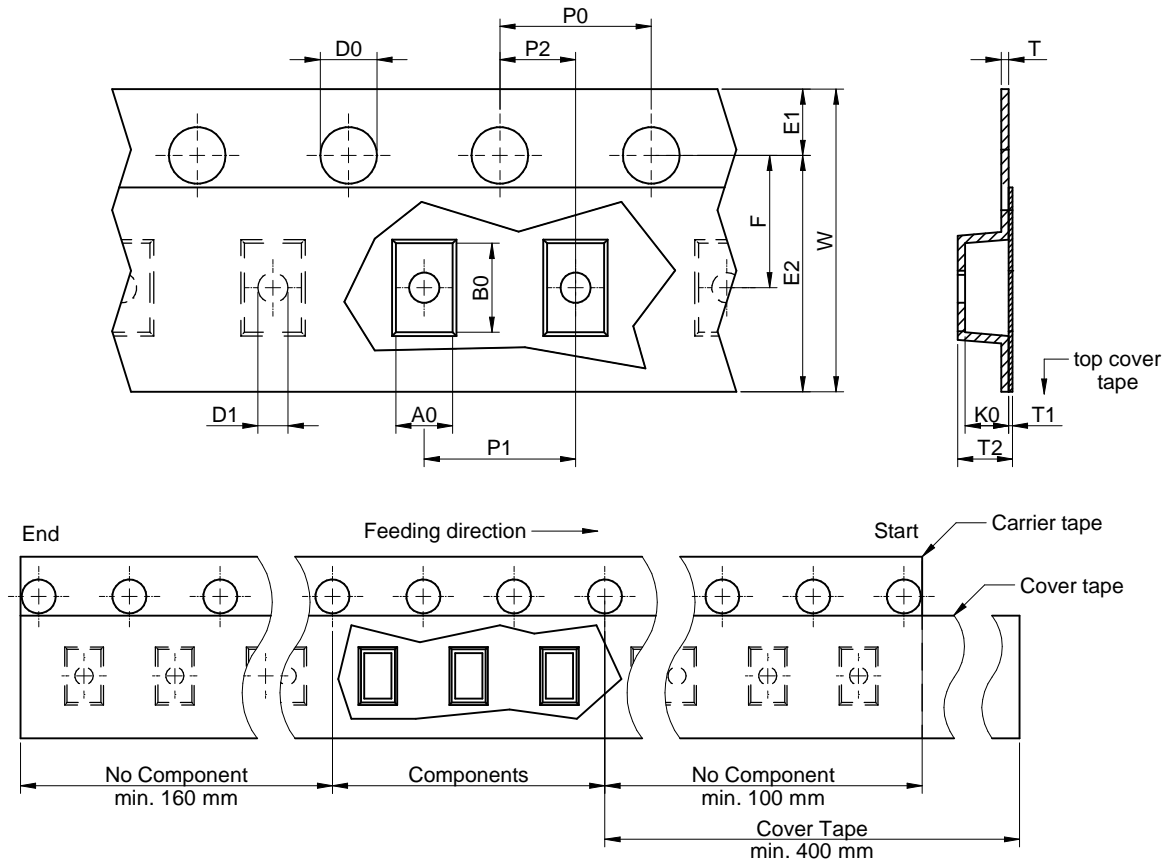



#### Storage Conditions:


