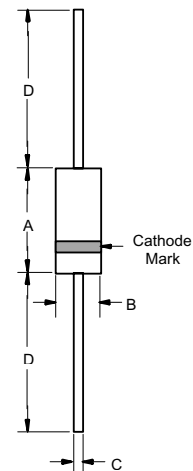

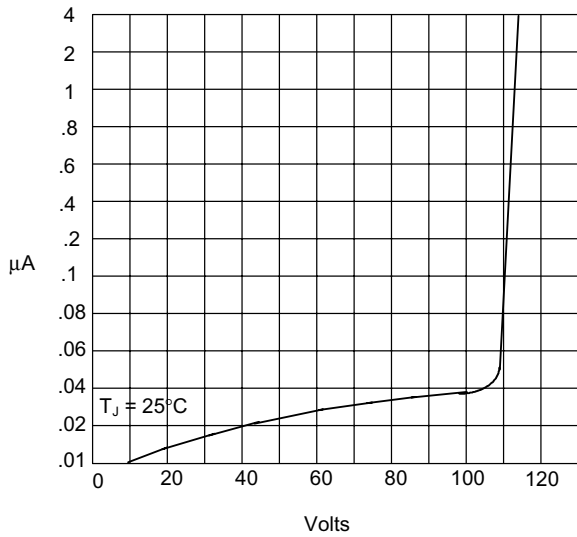

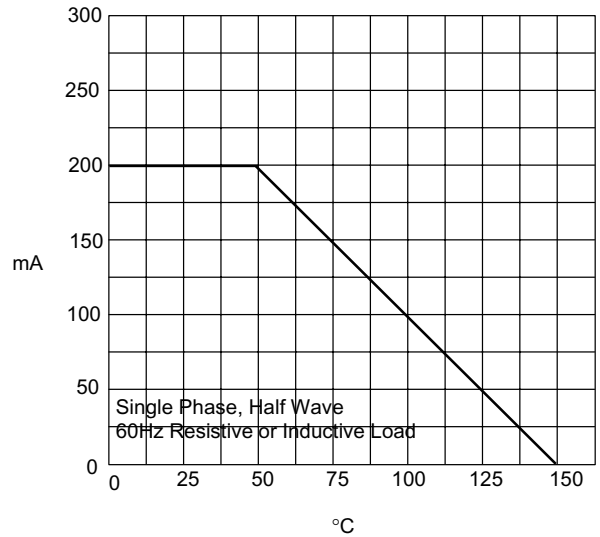

Typical Reverse Characteristics



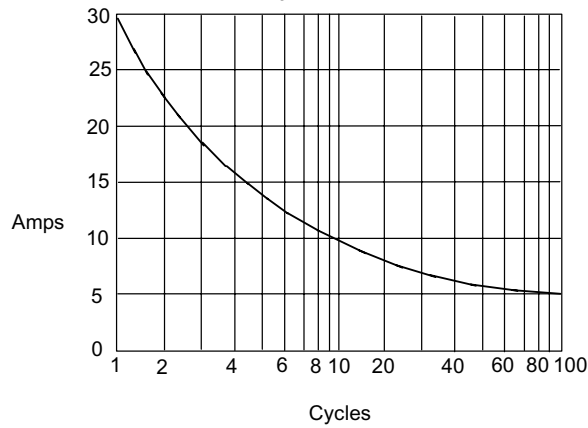
Instantaneous Reverse Current - Micro Amps *versus*
