




Relative Spectral Emission⁴⁾


Radiation Characteristics⁴⁾

Relative Partial Flux⁴⁾










Relative Luminous Flux⁴⁾


Dominant Wavelength ⁴⁾






Max. Permissible Forward Current


Permissible Pulse Handling Capability

 $I_{F} = f(t_{p}); D: Duty cycle$




Permissible Pulse Handling Capability









- ³⁾ **Wavelength:** The wavelength is measured at a current pulse of typically 25 ms, with an internal reproducibility of ±0.5 nm and an expanded uncertainty of ±1 nm (acc. to GUM with a coverage factor of k = 3).
