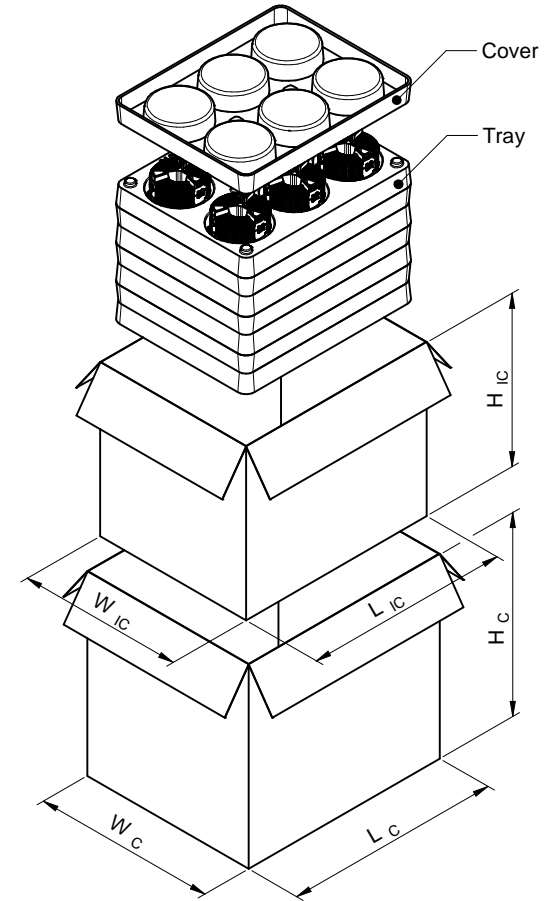
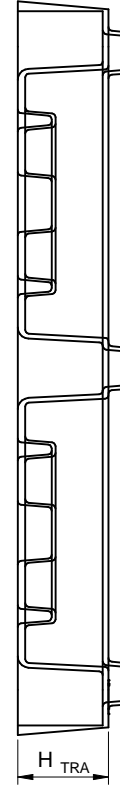
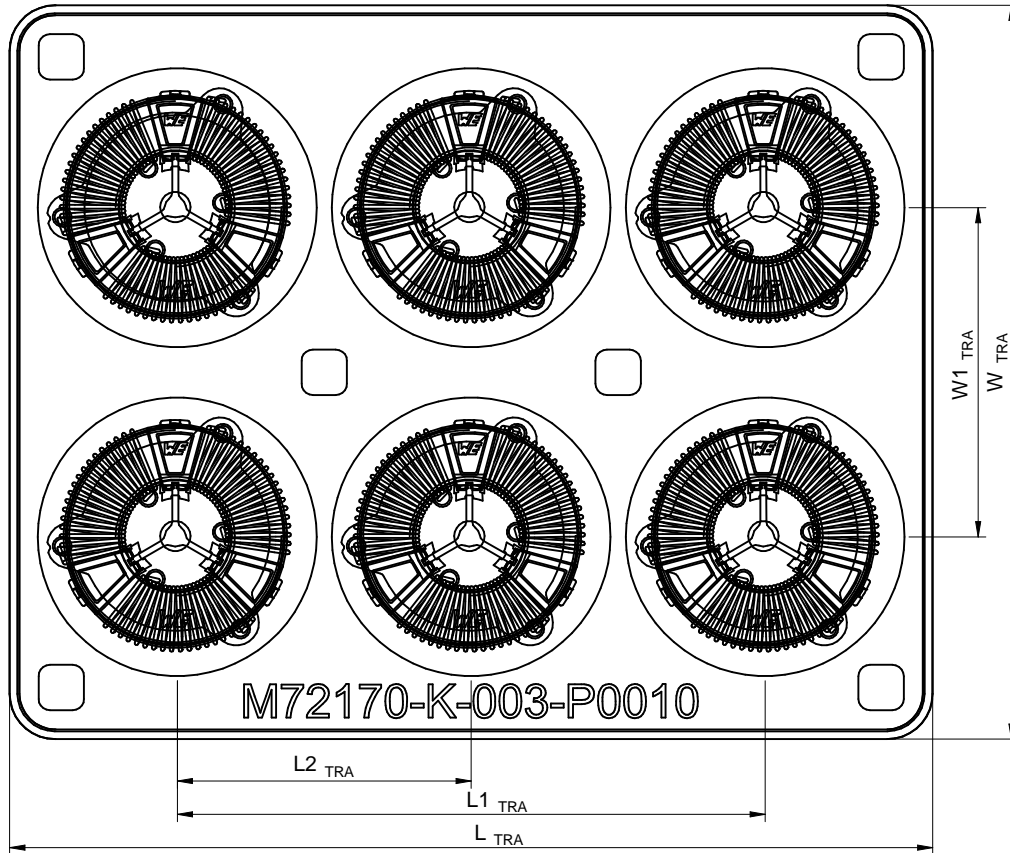


## Typical Insertion Loss:

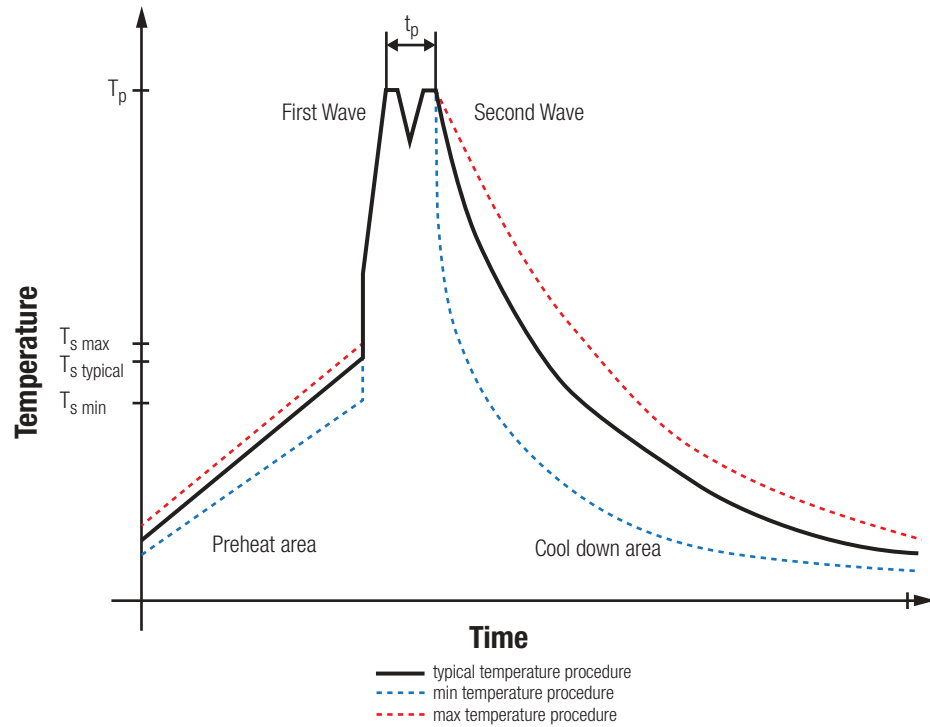



#### Soldering:



#### Packaging:


