Differential Mode

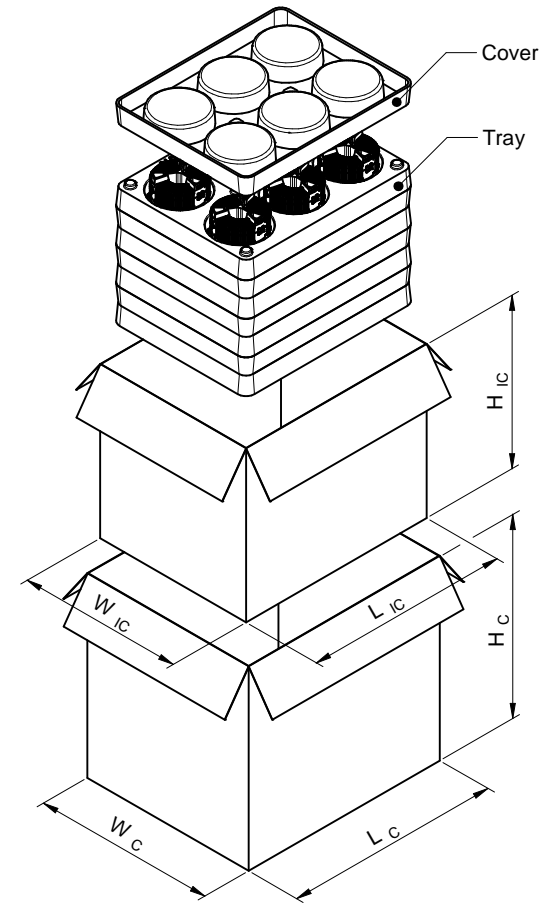
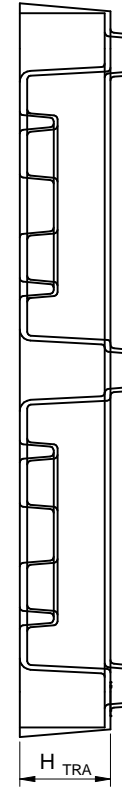
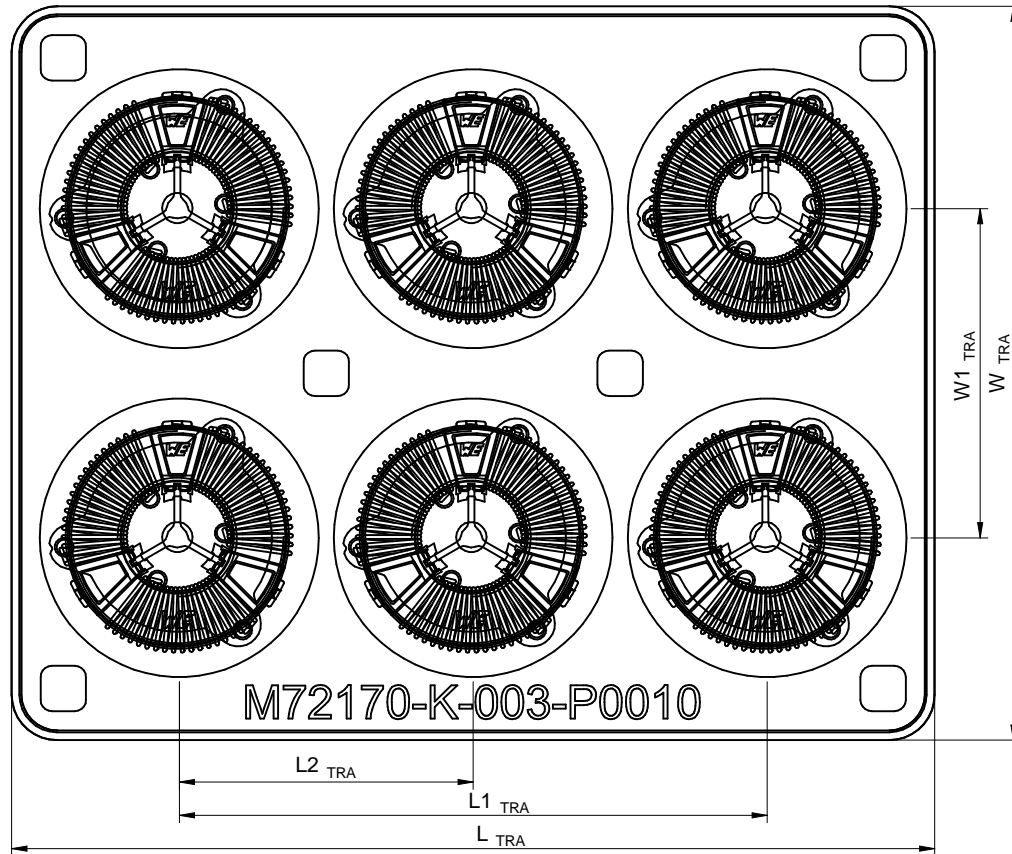


## Typical Insertion Loss:





#### Packaging:


