- General purpose switching and small signal amplification.




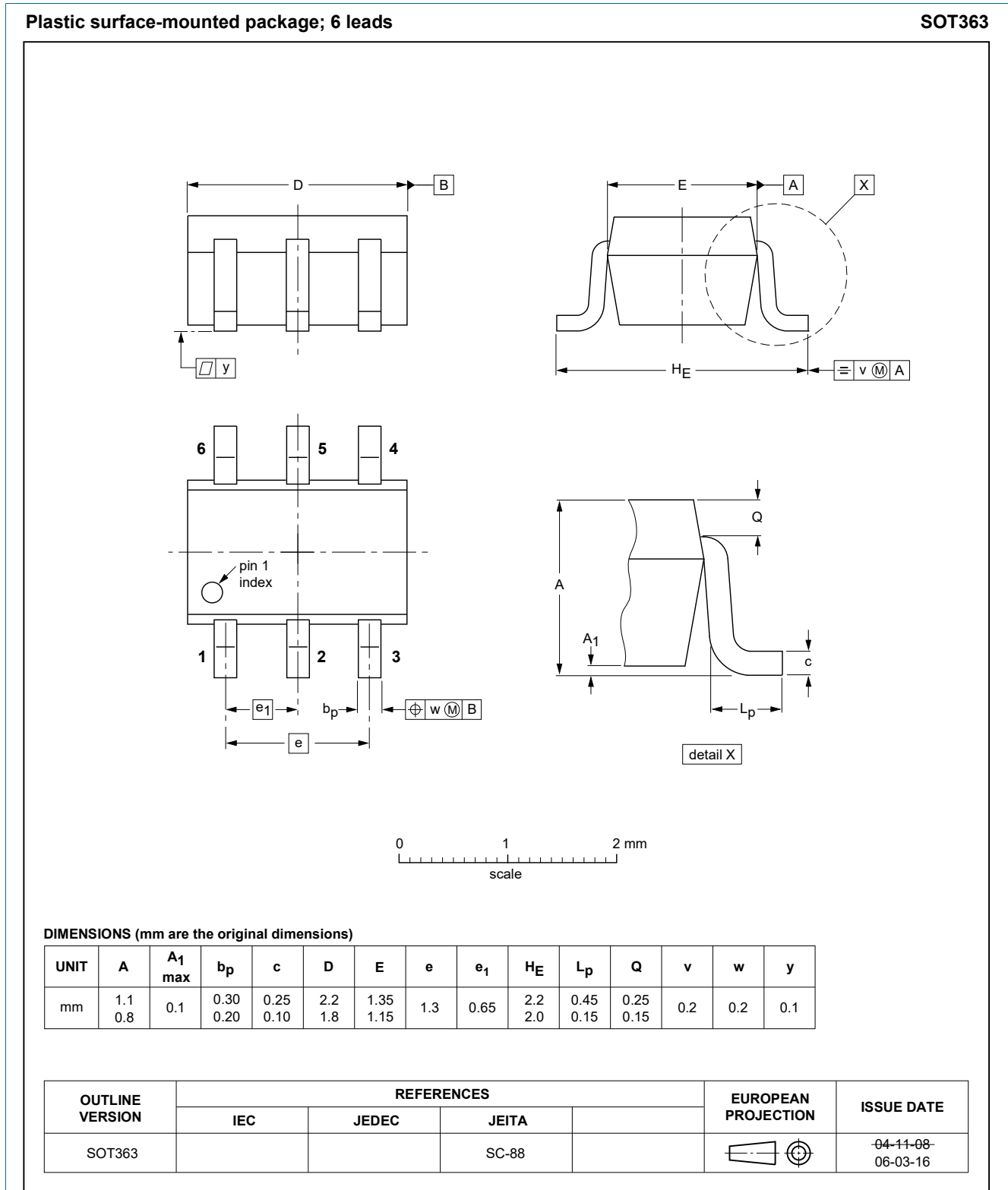


Fig. 7. Package outline TSSOP6 (SOT363)

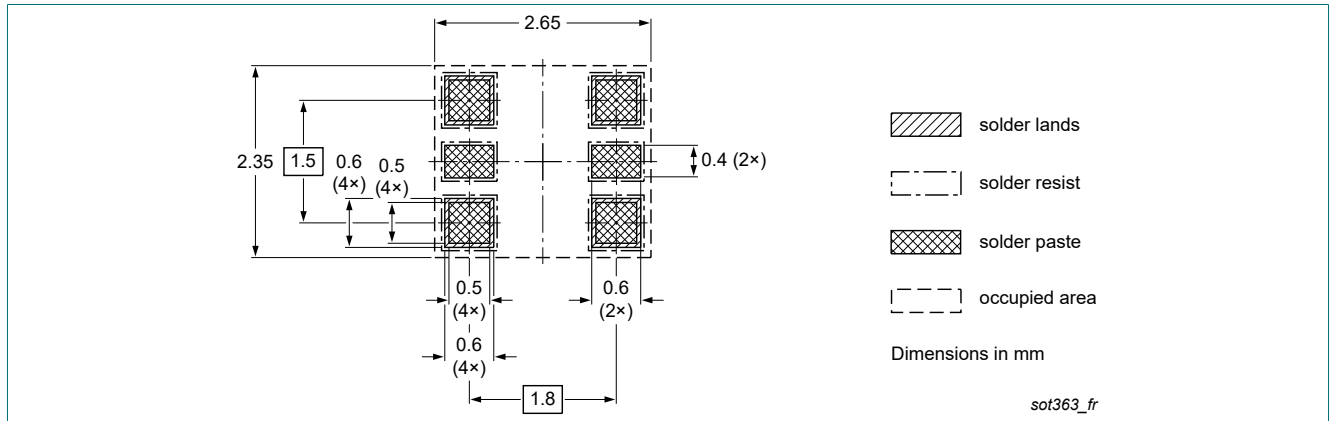


Fig. 8. Reflow soldering footprint for TSSOP6 (SOT363)

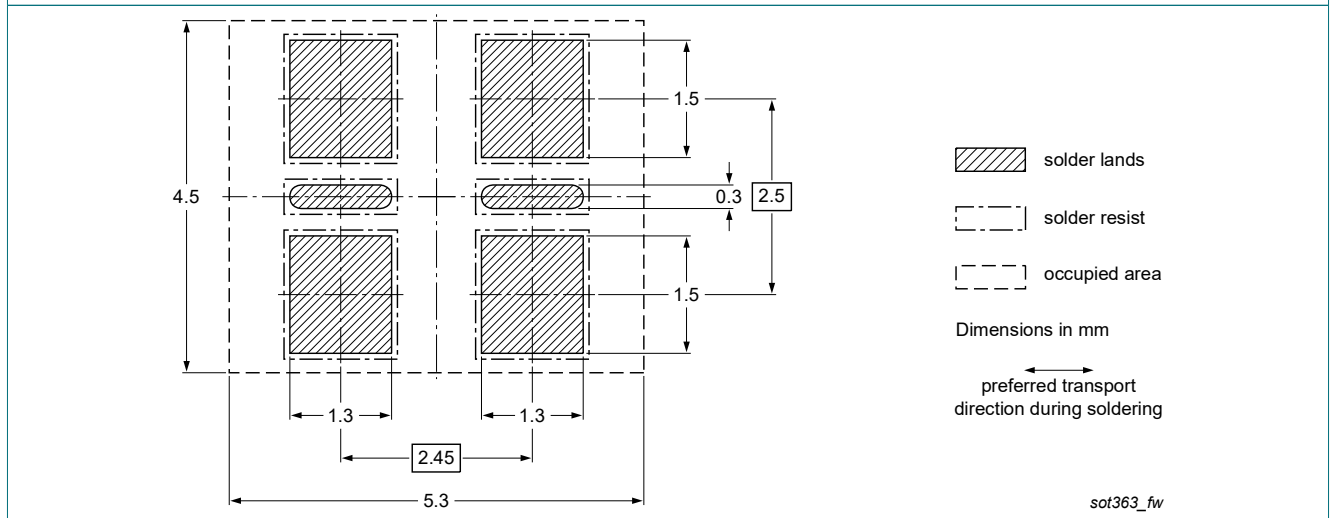


Fig. 9. Wave soldering footprint for TSSOP6 (SOT363)
