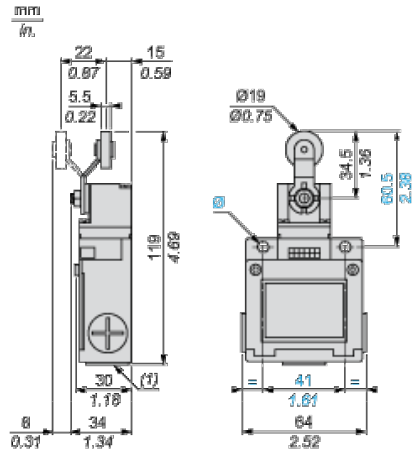

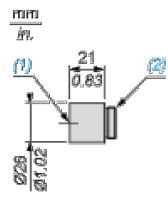

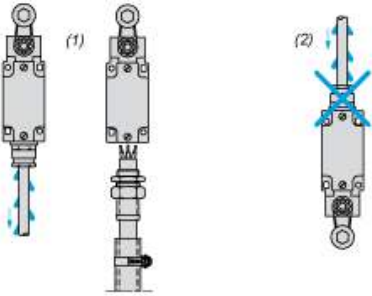
- (1) Tapped entry for $\frac{1}{2}$ " NPT

Mounting with Cable Entry

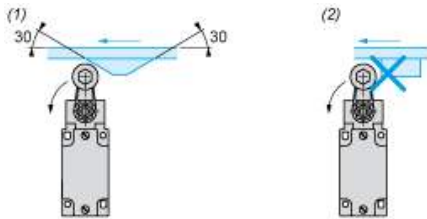
Position of Cable Gland

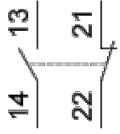
Type of Cam

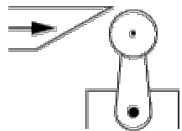
Wiring Diagram

2-pole NC + NO Snap Action

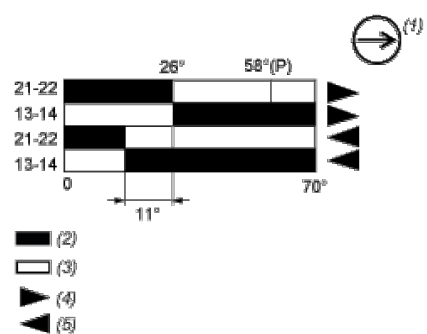


Characteristics of Actuation
