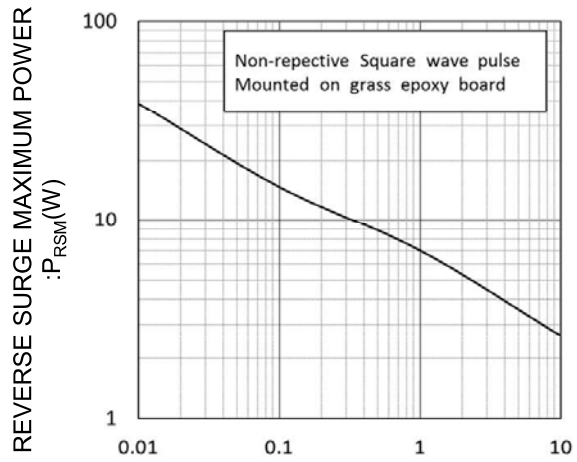

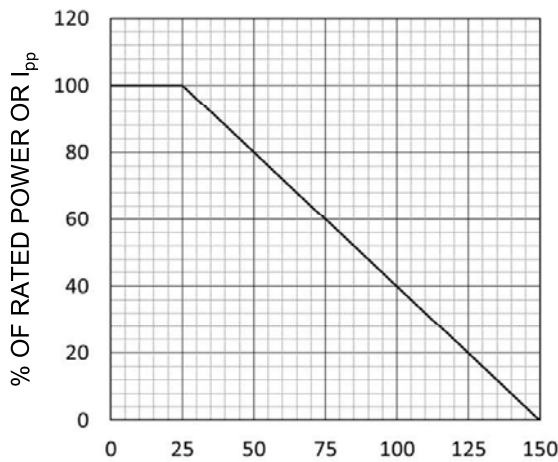

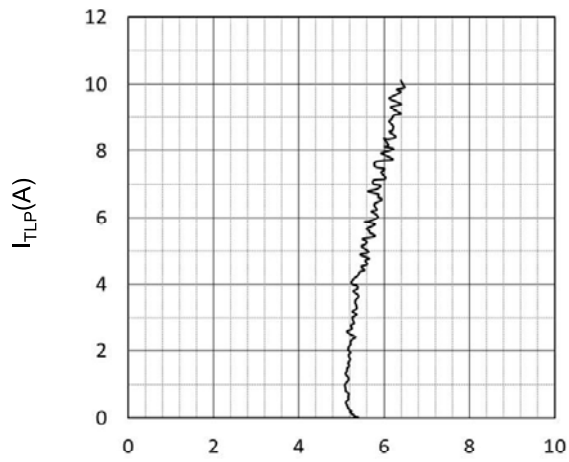
PEAK PULSE CURRENT:  $I_{pp}$  (A)

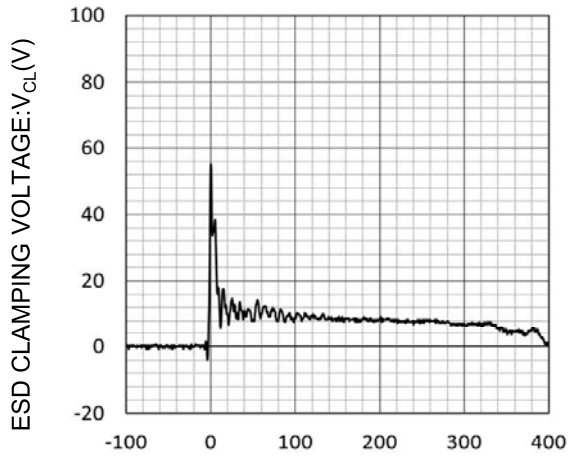


$T_a$  (°C)  
POWER DERATING CURVE

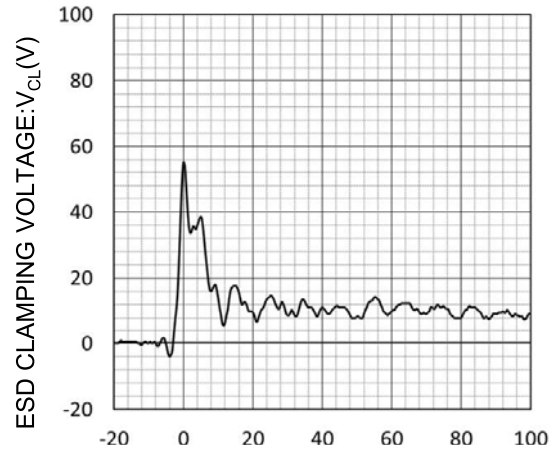

TRANSMISSION LINE PULSE

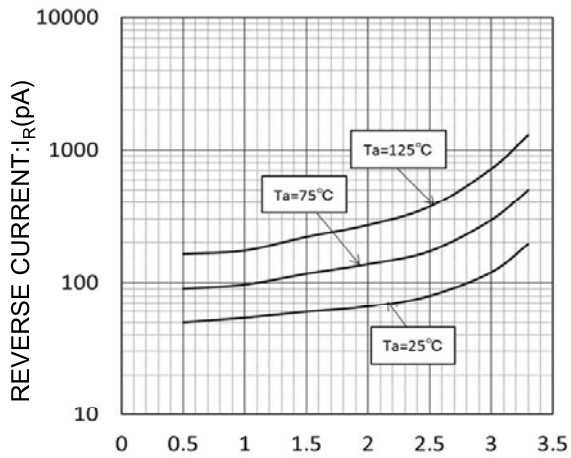

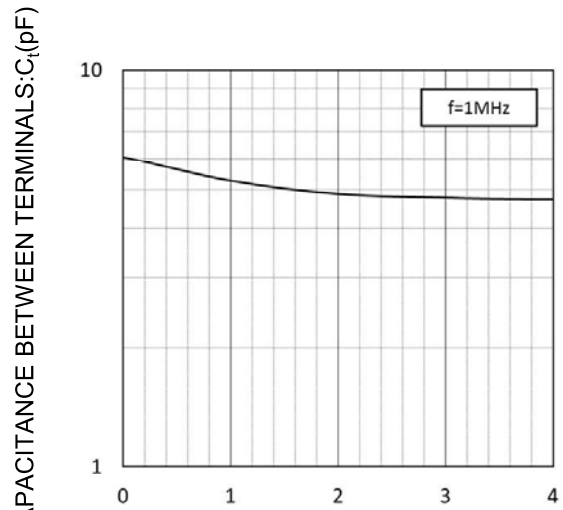
TIME(ns)

(IEC61000-4-2 +8kV CONTACT)

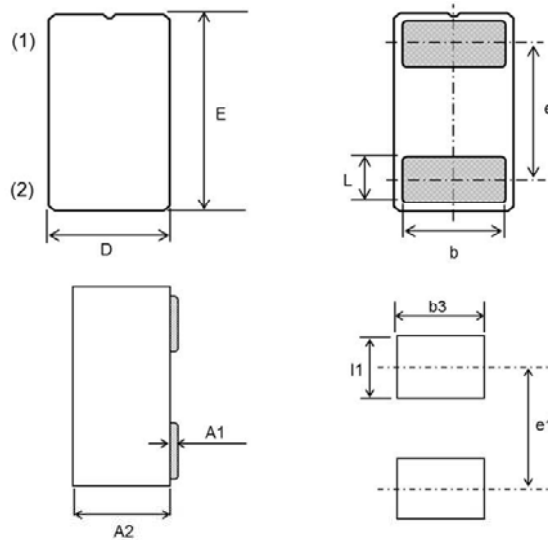


REVERSE VOLTAGE:VR(V)

VR-Ct CHARACTERISTICS

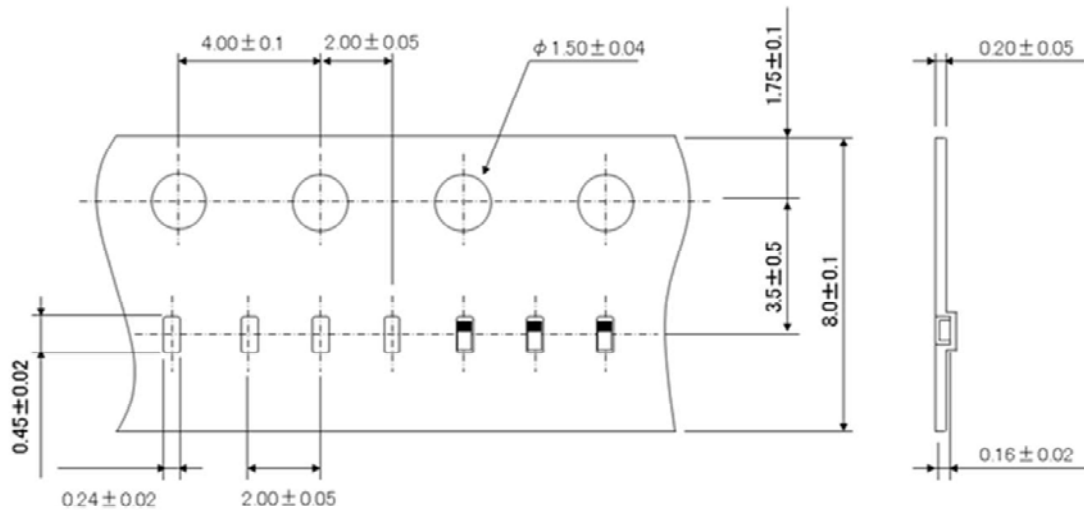
