

Relative CTR vs. Forward Current ( at  $V_{CF}$ =5 V )


Absolute CTR vs. Forward Current ( at  $V_{CE}=0,4$  V )


Relative CTR vs. Forward Current ( at V<sub>CF</sub>=0,4 V )

### Switching time vs. Load Resistance:




