




Note 1. IE, VEC, tr & Qrr represent characteristics of the anti-parallel, emitter-collector free-wheel diode (FWDi).

3. Junction temperature (Tj) should not increase beyond 150°C.











COLLECTOR-EMITTER VOLTAGE VCE (V)




GATE-EMITTER VOLTAGE VGE (V)






COLLECTOR CURRENT Ic (A)

FREE-WHEEL DIODE FORWARD CHARACTERISTICS (TYPICAL)





EMITTER-COLLECTOR VOLTAGE VEC (V)
