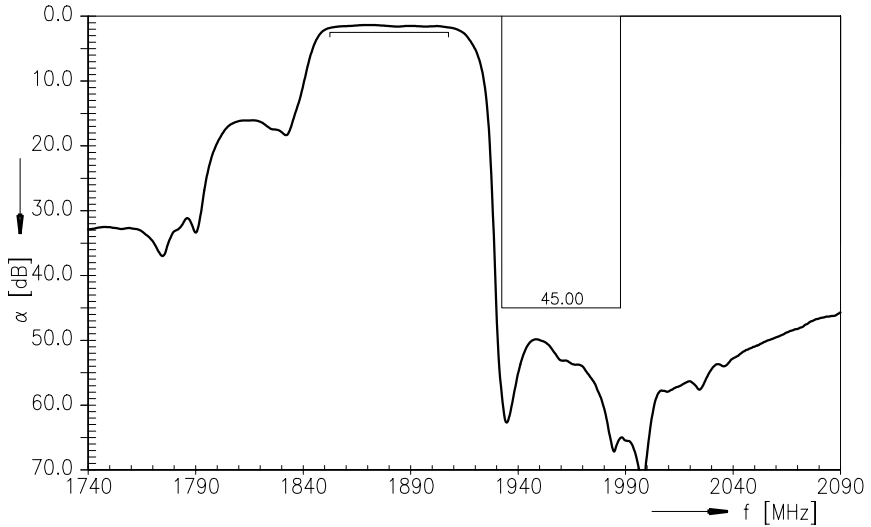

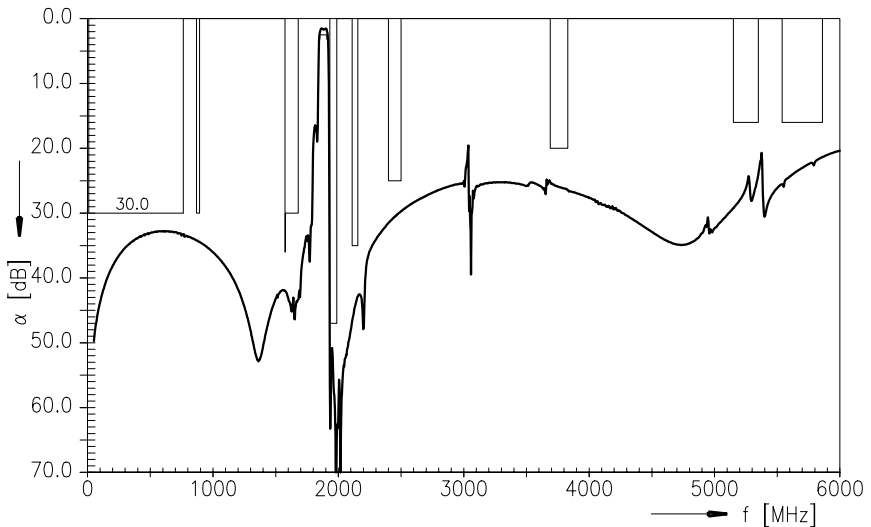

Frequency Response TX-ANT (PTF)



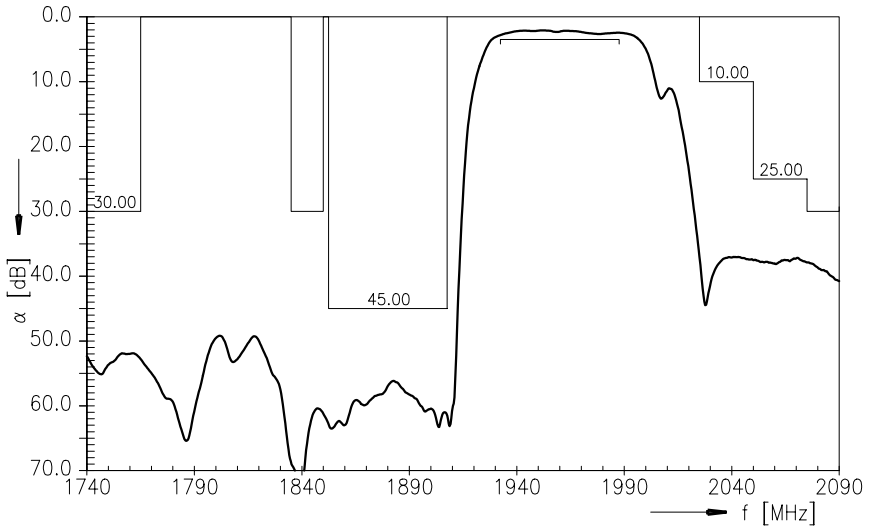
Frequency Response TX-ANT (wideband)



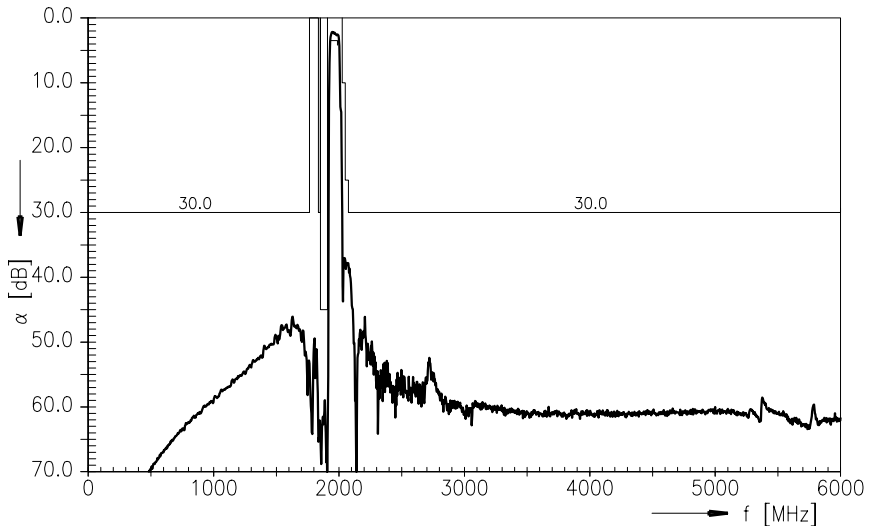

Frequency Response ANT-RX (PTF)

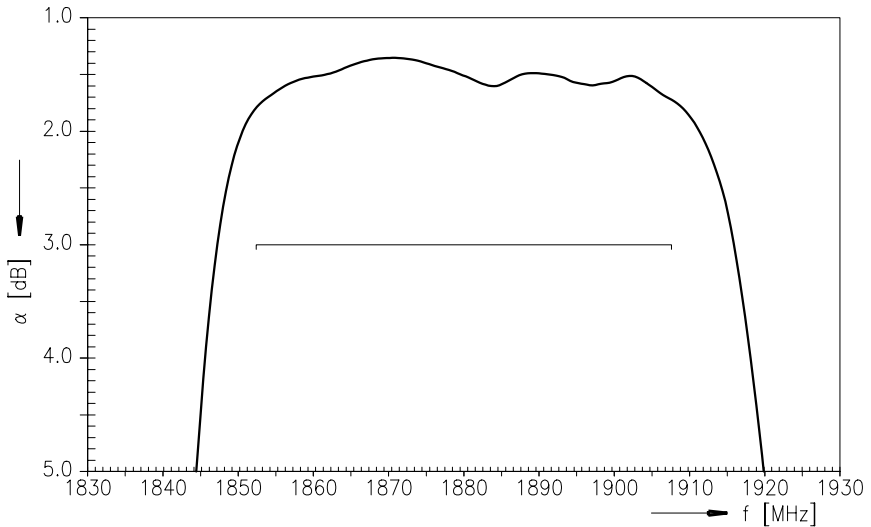


Frequency Response ANT-RX (wideband)

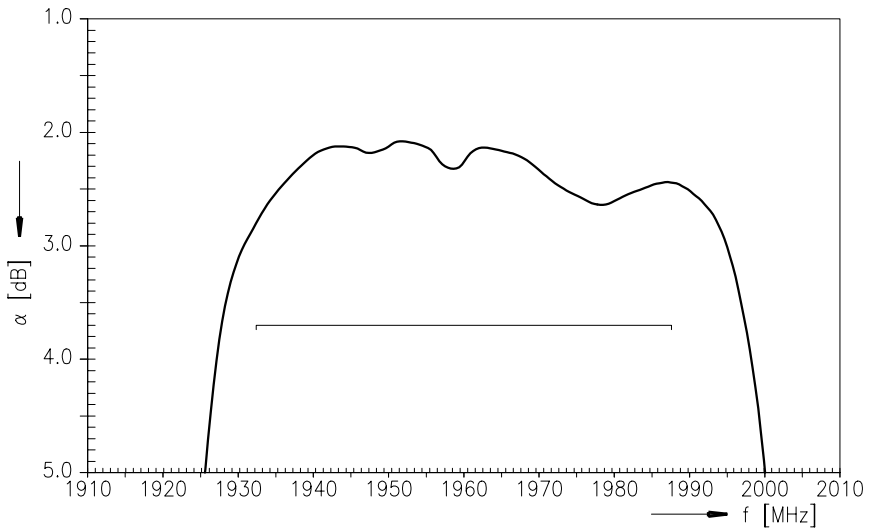




Frequency Response TX-ANT Passband (PTF)



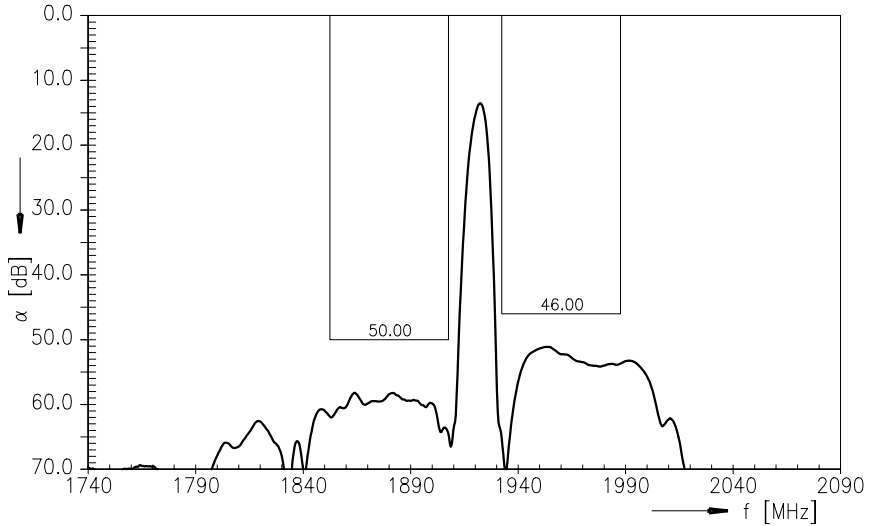
Frequency Response ANT-RX Passband (PTF)



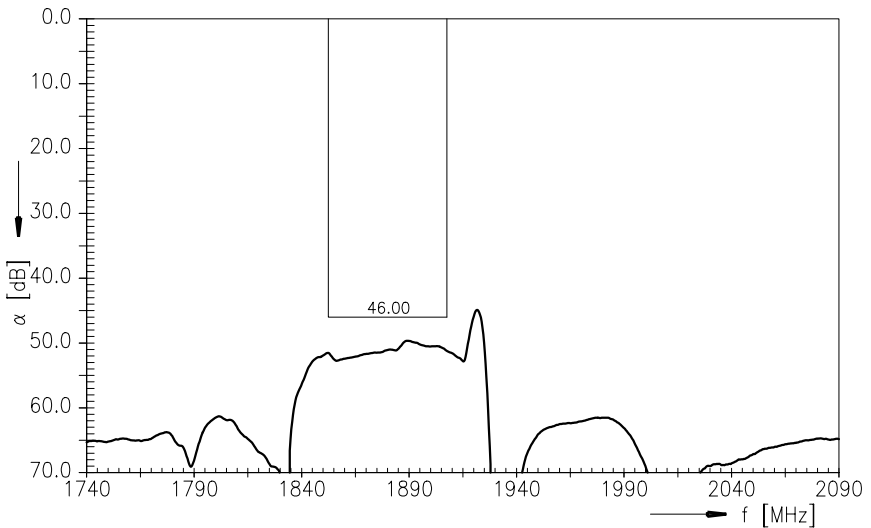

Frequency Response TX-RX (PTF)



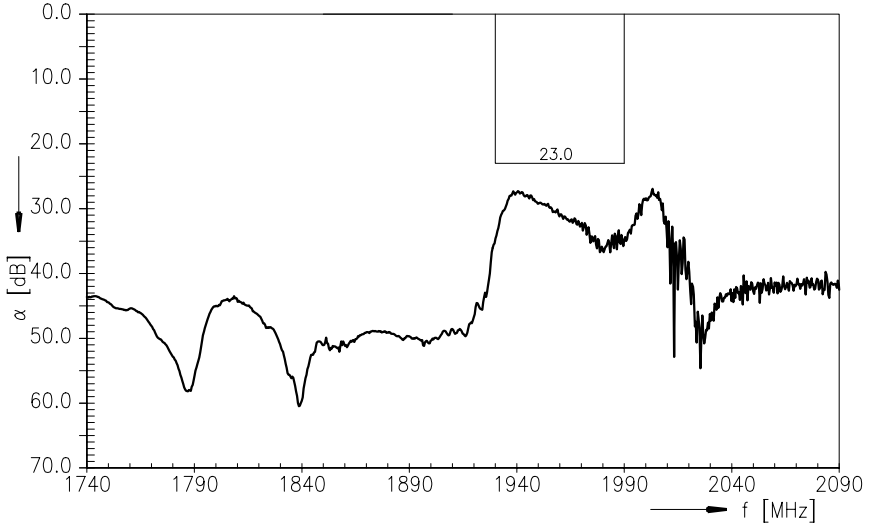
Frequency Response Tx-Rx (PTF) Common Mode Isolation

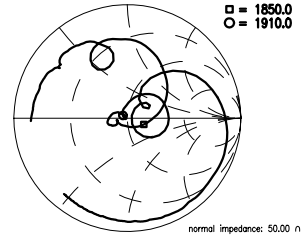
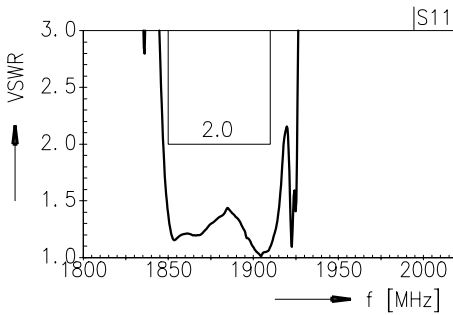


Frequency Response RX-ANT Common Mode Suppression

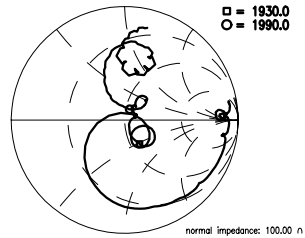
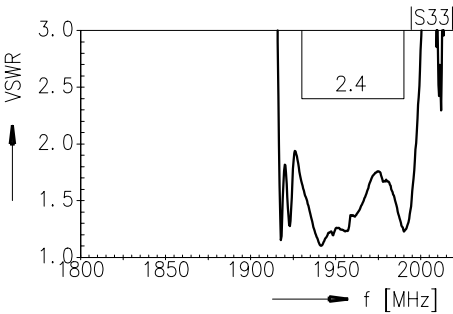




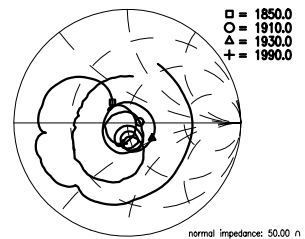
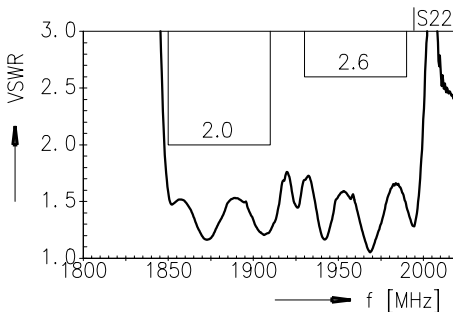
