





# DESCRIPTION

The TPS732xx-Q1 family of low-dropout (LDO) voltage regulators uses a new topology: an NMOS pass element in a voltage-follower configuration. This topology is stable using output capacitors with low ESR, and even allows operation without a capacitor. It also provides high reverse blockage (low reverse current) and ground pin current that is nearly constant over all values of output current.

The TPS732xx-Q1 uses an advanced BiCMOS process to yield high precision while delivering very low dropout voltages and low ground pin current. Current consumption, when not enabled, is under 1  $\mu$ A and ideal for portable applications. The extremely low output noise (30  $\mu$ V<sub>RMS</sub> with 0.1- $\mu$ F C<sub>NR</sub>) is ideal for powering VCOs. These devices are protected by thermal shutdown and foldback current limit.






Figure 1. Fixed Voltage Version

# **APPLICATION INFORMATION**

The TPS732xx-Q1 belongs to a family of new generation LDO regulators that use an NMOS pass transistor to achieve ultra-low-dropout performance, reverse current blockage, and freedom from output capacitor constraints. These features, combined with low noise and an enable input, make the TPS732xx-Q1 ideal for portable applications. This regulator family offers a wide selection of fixed output voltage versions. All versions have thermal and overcurrent protection, including foldback current limit.




Figure 26. Typical Application Circuit for Fixed-Voltage Versions

Figure 26 shows the basic circuit connections for the fixed voltage models.

# INPUT AND OUTPUT CAPACITOR REQUIREMENTS

Although an input capacitor is not required for stability, it is good analog design practice to connect a  $0.1-\mu$ F to  $1-\mu$ F low ESR capacitor across the input supply near the regulator. This counteracts reactive input sources and improves transient response, noise rejection, and ripple rejection. A higher-value capacitor may be necessary if large, fast rise-time load transients are anticipated or the device is located several inches from the power source.

The TPS732xx-Q1 does not require an output capacitor for stability and has maximum phase margin with no capacitor. It is designed to be stable for all available types and values of capacitors. In applications where multiple low ESR capacitors are in parallel, ringing may occur when the product of  $C_{OUT}$  and total ESR drops below 50 n $\Omega$ F. Total ESR includes all parasitic resistances, including capacitor ESR and board, socket, and solder joint resistance. In most applications, the sum of capacitor ESR and trace resistance will meet this requirement.

# **OUTPUT NOISE**

A precision band-gap reference is used to generate the internal reference voltage,  $V_{REF}$ . This reference is the dominant noise source within the TPS732xx-Q1 and it generates approximately 32  $\mu V_{RMS}$  (10 Hz to 100 kHz) at the reference output (NR). The regulator control loop gains up the reference noise with the same gain as the reference voltage, so that the noise voltage of the regulator is approximately given by:

$$V_{\rm N} = 32\mu V_{\rm RMS} \times \frac{(R_1 + R_2)}{R_2} = 32\mu V_{\rm RMS} \times \frac{V_{\rm OUT}}{V_{\rm REF}}$$
(1)

Since the value of  $V_{\text{REF}}$  is 1.2 V, this relationship reduces to:

$$V_{N}(\mu V_{RMS}) = 27 \left(\frac{\mu V_{RMS}}{V}\right) \times V_{OUT}(V)$$
(2)

for the case of no  $C_{NR}$ .

An internal 27-k $\Omega$  resistor in series with the noise reduction pin (NR) forms a low-pass filter for the voltage reference when an external noise reduction capacitor,  $C_{NR}$ , is connected from NR to ground. For  $C_{NR}$  = 10 nF, the total noise in the 10 Hz to 100 kHz bandwidth is reduced by a factor of ~3.2, giving the approximate relationship:

$$V_{N}(\mu V_{RMS}) = 8.5 \left(\frac{\mu V_{RMS}}{V}\right) \times V_{OUT}(V)$$

for  $C_{NR} = 10 \text{ nF}$ .

This noise reduction effect is shown as *RMS Noise Voltage vs C<sub>NR</sub>* (Figure 19) in the Typical Characteristics section.

Connecting a capacitor  $C_{NR}$  from the output to the NR pin reduces output noise and improves load transient performance.

The TPS732xx-Q1 uses an internal charge pump to develop an internal supply voltage sufficient to drive the gate of the NMOS pass element above  $V_{OUT}$ . The charge pump generates ~250 µV of switching noise at ~4 MHz; however, charge-pump noise contribution is negligible at the output of the regulator for most values of  $I_{OUT}$  and  $C_{OUT}$ .

## BOARD LAYOUT RECOMMENDATION TO IMPROVE PSRR AND NOISE PERFORMANCE

To improve AC performance such as PSRR, output noise, and transient response, it is recommended that the PCB be designed with separate ground planes for  $V_{IN}$  and  $V_{OUT}$ , with each ground plane connected only at the GND pin of the device. In addition, the ground connection for the bypass capacitor should connect directly to the GND pin of the device.

# INTERNAL CURRENT LIMIT

The TPS732xx-Q1 internal current limit helps protect the regulator during fault conditions. Foldback current limit helps to protect the regulator from damage during output short-circuit conditions by reducing current limit when  $V_{OUT}$  drops below 0.5 V. See Figure 11 in the Typical Characteristics section for a graph of  $I_{OUT}$  vs  $V_{OUT}$ .

Note from Figure 11 that approximately -0.2 V of V<sub>OUT</sub> results in a current limit of 0 mA. Therefore, if OUT is forced below -0.2 V before EN goes high, the device may not start up. In applications that work with both a positive and negative voltage supply, the TPS732xx-Q1 should be enabled first.

## ENABLE PIN AND SHUTDOWN

The enable pin (EN) is active high and is compatible with standard TTL-CMOS levels. A  $V_{EN}$  below 0.5 V (max) turns the regulator off and drops the GND pin current to approximately 10 nA. When EN is used to shutdown the regulator, all charge is removed from the pass transistor gate, and the output ramps back up to a regulated  $V_{OUT}$  (see Figure 22).

When shutdown capability is not required, EN can be connected to  $V_{IN}$ . However, the pass gate may not be discharged using this configuration, and the pass transistor may be left on (enhanced) for a significant time after  $V_{IN}$  has been removed. This scenario can result in reverse current flow (if the IN pin is low impedance) and faster ramp times upon power-up. In addition, for  $V_{IN}$  ramp times slower than a few milliseconds, the output may overshoot upon power-up.

Note that current limit foldback can prevent device start-up under some conditions. See the *Internal Current Limit* section.

# DROPOUT VOLTAGE

The TPS732xx-Q1 uses an NMOS pass transistor to achieve extremely low dropout. When  $(V_{IN} - V_{OUT})$  is less than the dropout voltage  $(V_{DO})$ , the NMOS pass device is in its linear region of operation and the input-to-output resistance is the R<sub>DS-ON</sub> of the NMOS pass element.

For large step changes in load current, the TPS732xx-Q1 requires a larger voltage drop from  $V_{IN}$  to  $V_{OUT}$  to avoid degraded transient response. The boundary of this transient dropout region is approximately twice the DC dropout. Values of  $V_{IN} - V_{OUT}$  above this line insure normal transient response.

Operating in the transient dropout region can cause an increase in recovery time. The time required to recover from a load transient is a function of the magnitude of the change in load current rate, the rate of change in load current, and the available headroom ( $V_{IN}$  to  $V_{OUT}$  voltage drop). Under worst-case conditions [full-scale instantaneous load change with ( $V_{IN} - V_{OUT}$ ) close to DC dropout levels], the TPS732xx-Q1 can take a couple of hundred microseconds to return to the specified regulation accuracy.

# TRANSIENT RESPONSE

The low open-loop output impedance provided by the NMOS pass element in a voltage follower configuration allows operation without an output capacitor for many applications. As with any regulator, the addition of a capacitor (nominal value 1  $\mu$ F) from the OUT pin to ground reduces undershoot magnitude but increases its duration. The addition of a capacitor (C<sub>NR</sub>) from the OUT pin to the NR pin also improves the transient response.

The TPS732xx-Q1 does not have active pull-down when the output is over-voltage. This allows applications that connect higher voltage sources, such as alternate power supplies, to the output. This also results in an output overshoot of several percent if the load current quickly drops to zero when a capacitor is connected to the output. The duration of overshoot can be reduced by adding a load resistor. The overshoot decays at a rate determined by output capacitor  $C_{OUT}$  and the internal/external load resistance. The rate of decay is given by:

(Fixed voltage version)

$$dV/dt = \frac{V_{OUT}}{C_{OUT} \times 80 k\Omega \parallel R_{LOAD}}$$

# **REVERSE CURRENT**

The NMOS pass element of the TPS732xx-Q1 provides inherent protection against current flow from the output of the regulator to the input when the gate of the pass device is pulled low. To ensure that all charge is removed from the gate of the pass element, the EN pin must be driven low before the input voltage is removed. If this is not done, the pass element may be left on due to stored charge on the gate.

After the EN pin is driven low, no bias voltage is needed on any pin for reverse current blocking. Note that reverse current is specified as the current flowing out of the IN pin due to voltage applied on the OUT pin. There will be additional current flowing into the OUT pin due to the  $80-k\Omega$  internal resistor divider to ground (see Figure 1).

# THERMAL PROTECTION

Thermal protection disables the output when the junction temperature rises to approximately 160°C, allowing the device to cool. When the junction temperature cools to approximately 140°C, the output circuitry is again enabled. Depending on power dissipation, thermal resistance, and ambient temperature, the thermal protection circuit may cycle on and off. This limits the dissipation of the regulator, protecting it from damage due to overheating.

Any tendency to activate the thermal protection circuit indicates excessive power dissipation or an inadequate heatsink. For reliable operation, junction temperature should be limited to 125°C maximum. To estimate the margin of safety in a complete design (including heatsink), increase the ambient temperature until the thermal protection is triggered; use worst-case loads and signal conditions. For good reliability, thermal protection should trigger at least 35°C above the maximum expected ambient condition of your application. This produces a worst-case junction temperature of 125°C at the highest expected ambient temperature and worst-case load.

The internal protection circuitry of the TPS732xx-Q1 has been designed to protect against overload conditions. It was not intended to replace proper heatsinking. Continuously running the TPS732xx-Q1 into thermal shutdown will degrade device reliability.

# POWER DISSIPATION

The ability to remove heat from the die is different for each package type, presenting different considerations in the PCB layout. The PCB area around the device that is free of other components moves the heat from the device to the ambient air. Performance data for JEDEC low- and high-K boards are shown in the Power Dissipation Ratings table. Using heavier copper will increase the effectiveness in removing heat from the device. The addition of plated through-holes to heat-dissipating layers will also improve the heat-sink effectiveness.

Power dissipation depends on input voltage and load conditions. Power dissipation ( $P_D$ ) is equal to the product of the output current times the voltage drop across the output pass element ( $V_{IN}$  to  $V_{OUT}$ ):

$$\mathsf{P}_{\mathsf{D}} = (\mathsf{V}_{\mathsf{IN}} - \mathsf{V}_{\mathsf{OUT}}) \times \mathsf{I}_{\mathsf{OUT}}$$

Power dissipation can be minimized by using the lowest possible input voltage necessary to assure the required output voltage.
