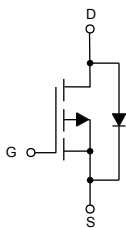

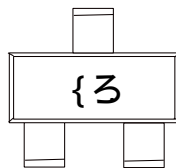

Internal Structure and Marking Code

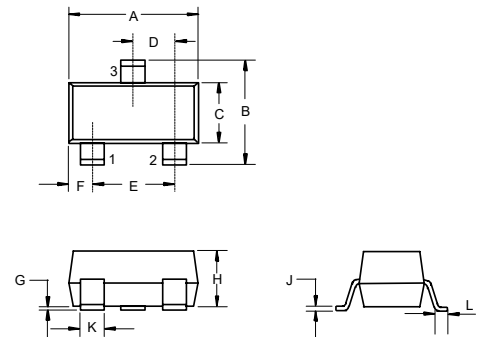


1. GATE

3. DRAIN



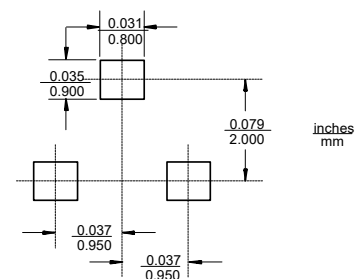

Fig. 1 - Output Characteristics

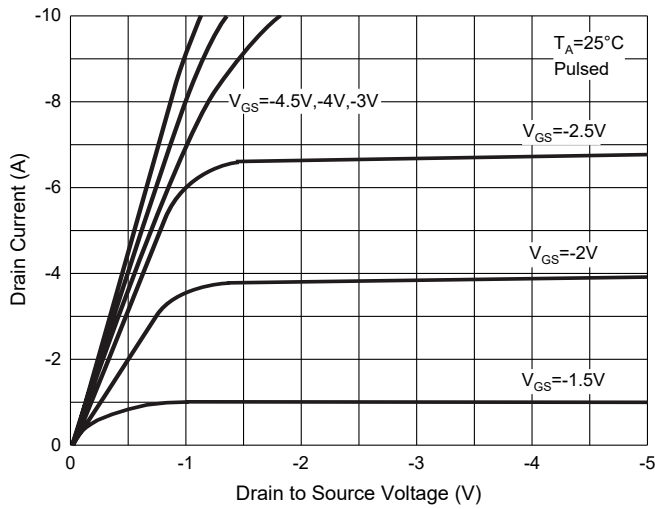


Fig. 2 - Transfer Characteristics

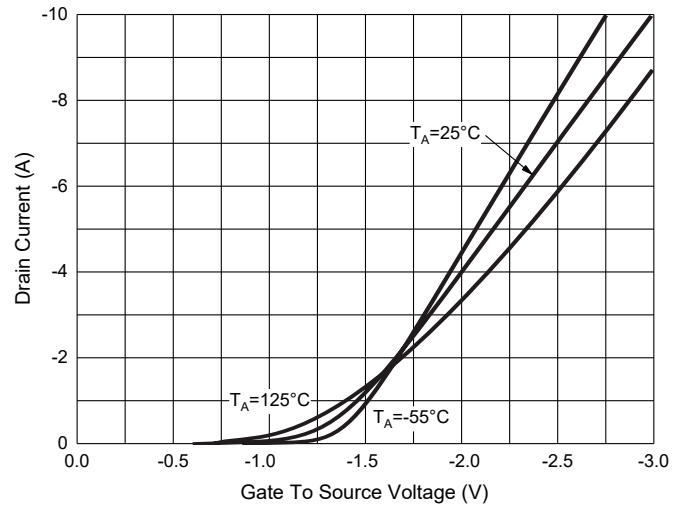


Fig. 3 - Capacitance Characteristics

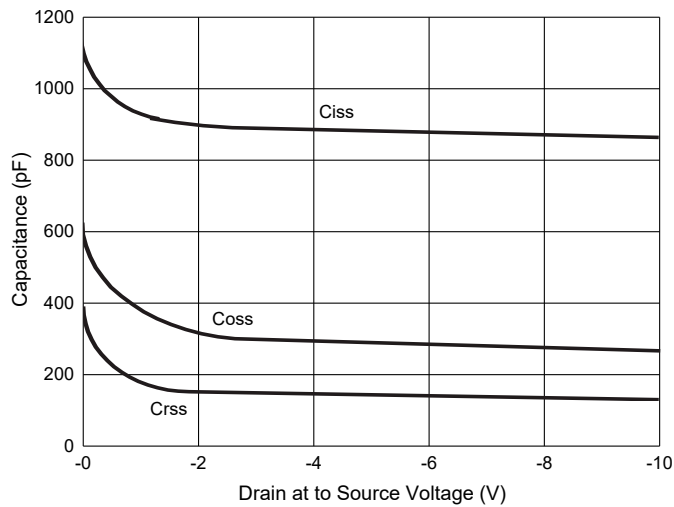


Fig. 4 - $R_{DS(ON)}$ —Temperature

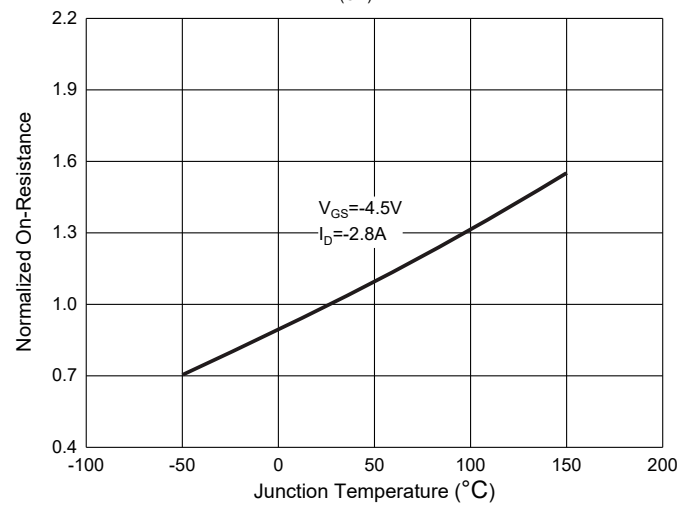


Fig. 5 - Threshold Voltage

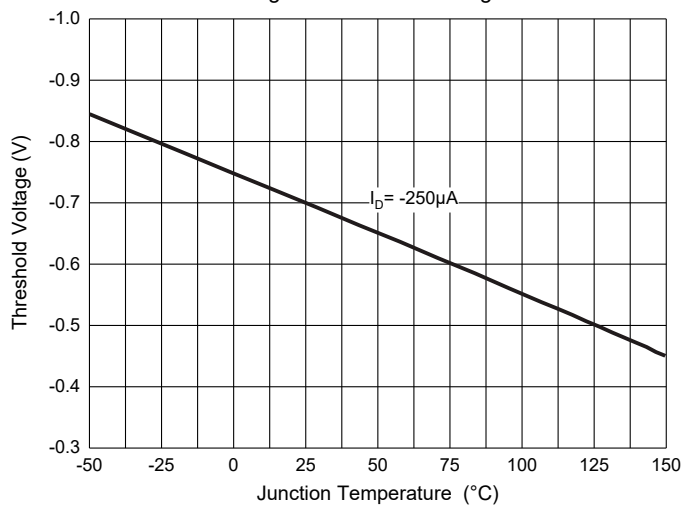
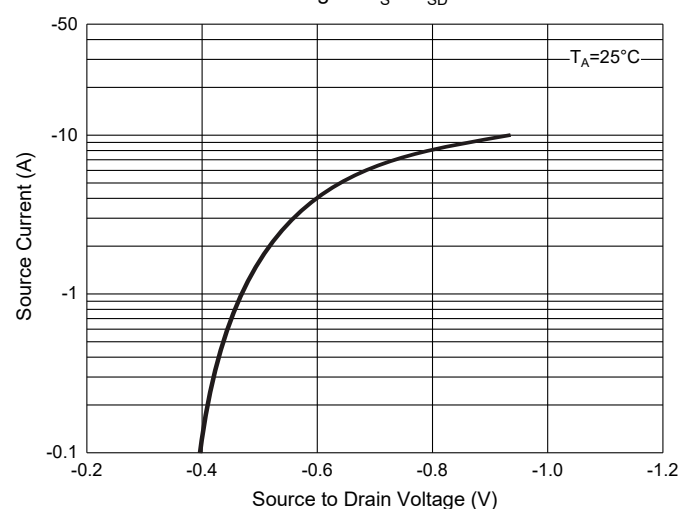


Fig. 6 - I_S — V_{SD}
