VIEWED FROM MATING SIDE



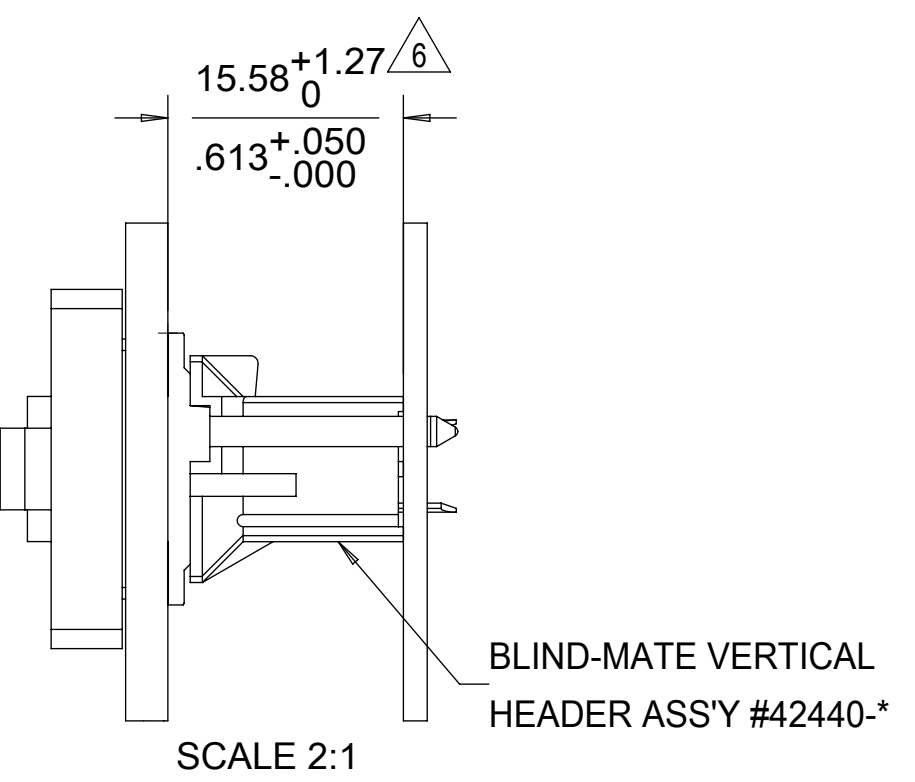
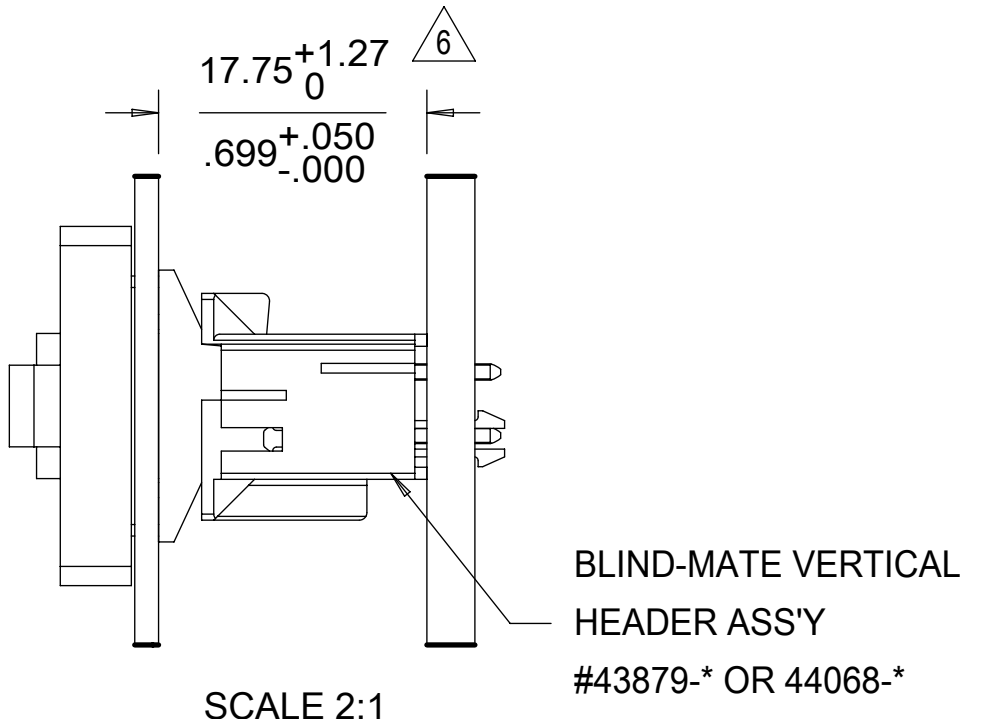
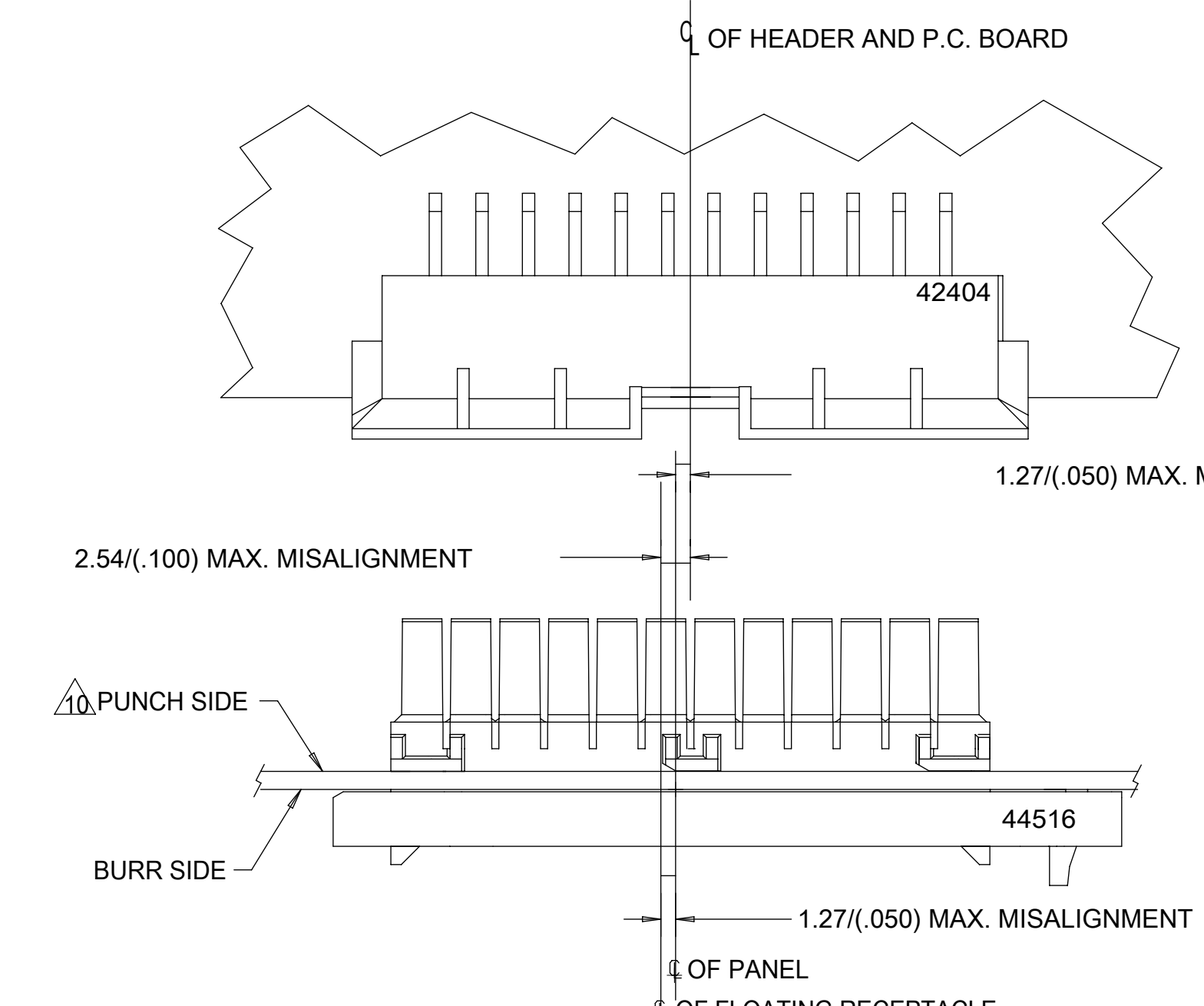
CIRCUIT #1 LOCATION
