## **SECTION 4: FIRST AID MEASURES**

Should be treated normally after cyanoacrylate is released from the tissue.

Eye Contact: Immediately flush with warm water for at least 15 minutes, and seek medical attention. Cyanoacrylate will bond to eye proteins and

cause weeping which will help debond the adhesive. Keep eye covered until debonding is complete, usually

within 5 days.

**Ingestion:** Ingestion not likely. Material will rapidly polymerize in the mouth prior to ingestion. Ensure breathing passages are not obstructed

and seek medical attention.
