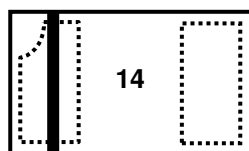

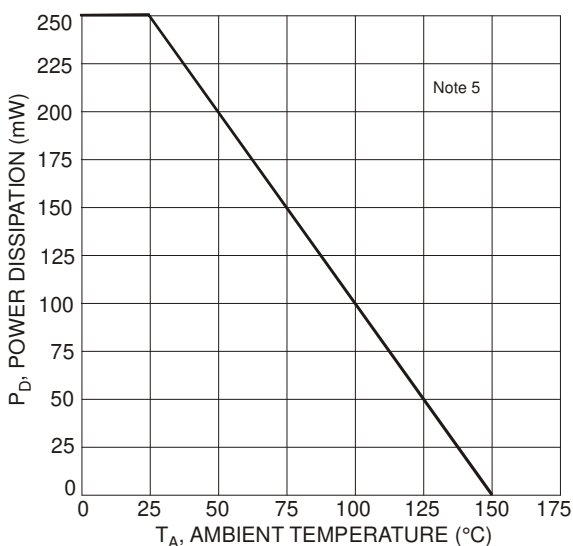


Figure 1 Power Derating Curve

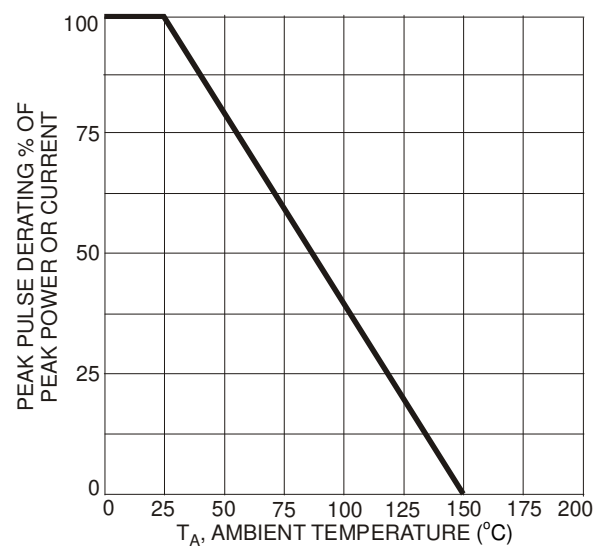


Figure 2 Pulse Derating Curve

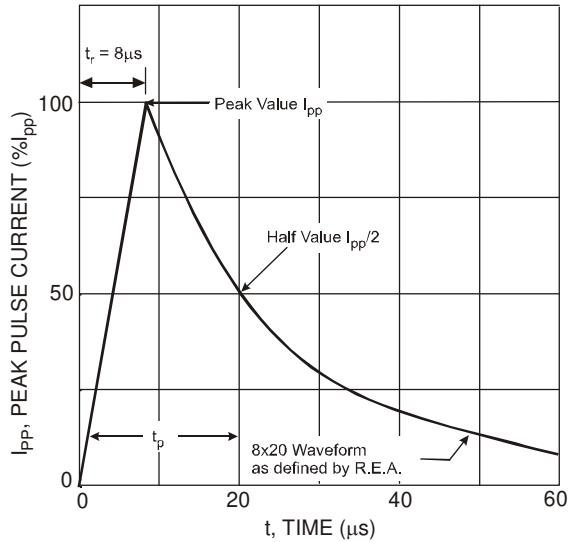


Figure 3 Typical $8 \times 20\mu$ s Pulse Waveform

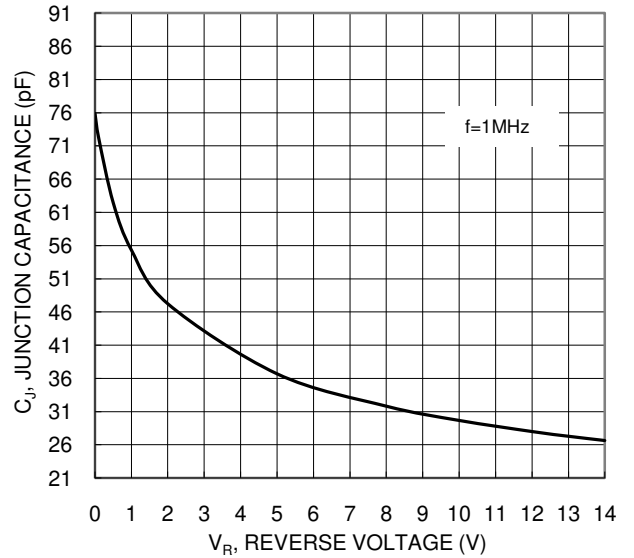


Figure 4 Typical Junction Capacitance

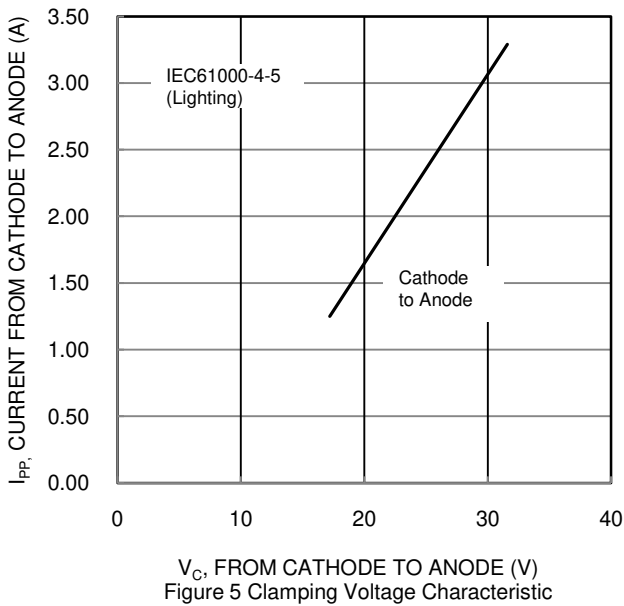
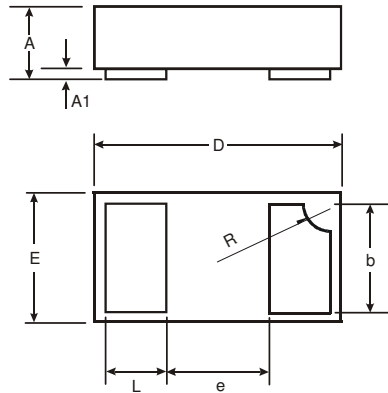


Figure 5 Clamping Voltage Characteristic

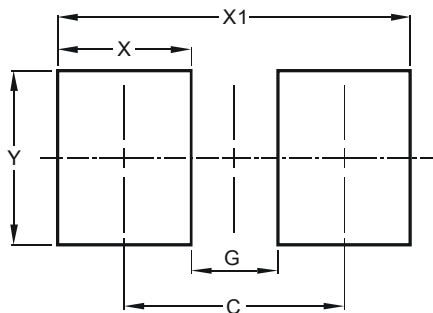
