## SP1 Package outline (dimensions in mm)












# Q1 to Q4 Typical performance curve




























# CR1 to CR4 Typical performance curve




#### **Switching Energy Losses vs Gate Resistance**



#### **Energy losses vs Collector Current**




### maximum Effective Transient Thermal Impedance, Junction to Case vs Pulse Duration









#### Switching Energy Losses vs Gate Resistance
