### Typical Insertion Loss:



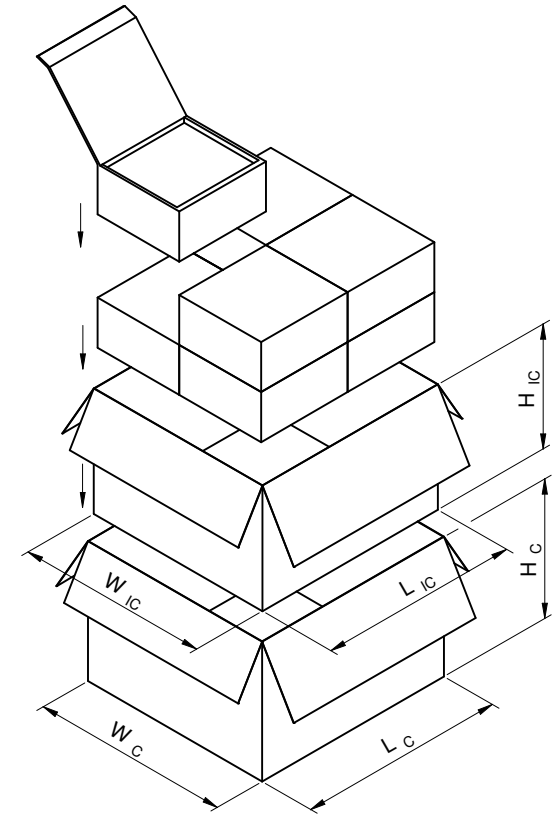
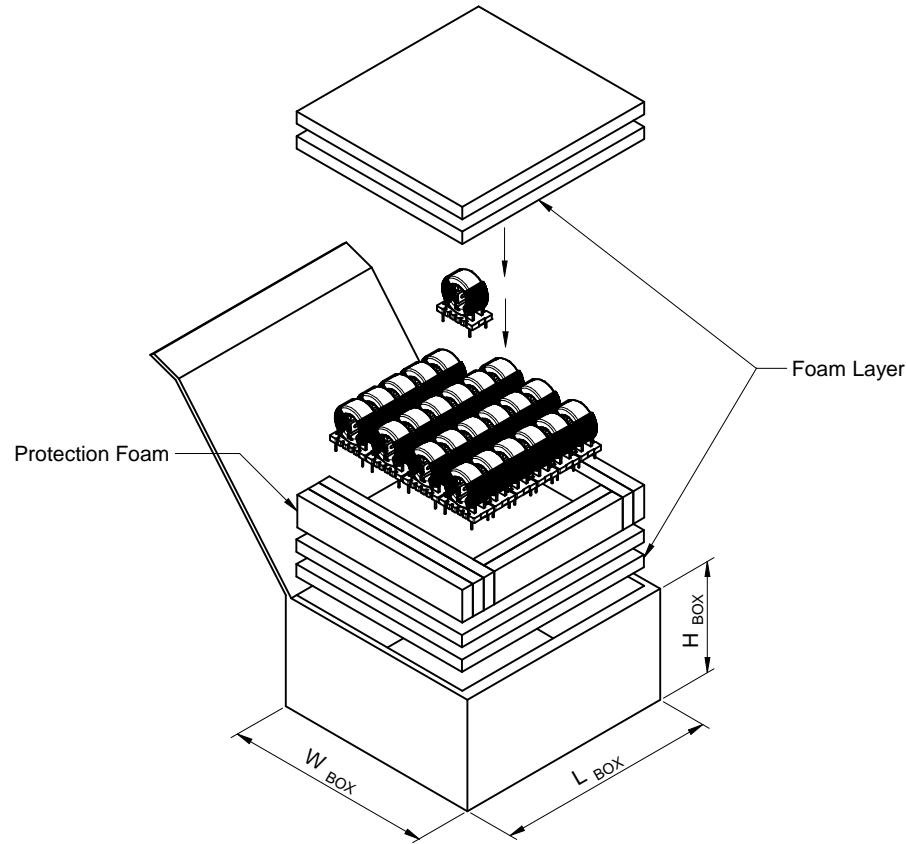

#### Soldering




