#### **Product specific:**

- Cleaning and Washing:

#### **Storage Conditions:**

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad mounting. Therefore, all products shall be used within the period of 12 months based on the day of shipment.
- Do not expose the components to direct sunlight.
- The storage conditions in the original packaging are defined according to DIN EN 61760-2.
- The storage conditions stated in the original packaging apply to the storage time and not to the transportation time of the components.

#### Packaging:

 The packaging specifications apply only to purchase orders comprising whole packaging units. If the ordered quantity exceeds or is lower than the specified packaging unit, packaging in accordance with the packaging specifications cannot be ensured.

#### Handling:

- Use a M4 screw to mount the Earthing Metal Clip to the PCB.
- The Earthing Metal Clip shall not exceed the recommended clamping torque. If the recommended clamping torque is exceeded, there is
  a risk that the Clip will not be able to push back into the initial state.
- Do not bend the Metal Clip to the opposite position, as the material will overstretch and possibly break.
- Avoid connecting, touching, or overlapping the contact between the cable and PCB with any non-conductive coating.
- Please be aware that products provided in bulk packaging may get bent and might lead to derivations from the mechanical
  manufacturing tolerances mentioned in our datasheet, which is not considered to be a material defect.
- The temperature rise of the component must be taken into consideration. The operating temperature is comprised of ambient temperature and temperature rise of the component. The operating temperature of the component shall not exceed the maximum temperature specified.
