#### **Notice on Usage**


Let Vth be the voltage applied between gate and source that causes the drain current (ID) to be low (-100 $\mu$ A for the SSM3J334R). Then, for normal switching operation, VGS(on) must be higher than Vth, and VGS(off) must be lower than Vth. This relationship can be expressed as: VGS(off) < Vth < VGS(on).


