






#### TYPICAL CHARACTERISTICS (T<sub>a</sub> = 25 °C)



REVERSE BIAS SAFE OPERATING AREA




FORWARD BIAS SAFE OPERATING AREA





VcE – Collector to Emitter Voltage – V
